Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about G4S Compliance & Investigations, Inc. Profit Sharing/401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A--PLAN DESCRIPTION

The following brief description of the G4S Compliance & Investigations, Inc. Profit Sharing/401(k) Plan (“the Plan” formerly known as MJM Investigations, Inc. Profit Sharing 401(k) Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a profit sharing 401(k) plan covering substantially all employees of G4S Compliance & Investigations, Inc (formerly known as MJM Investigations, Inc.). The Plan was established effective January 23, 1992 and restated effective January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective June 5, 2019, certain employees were transferred from G4S Secure Solutions (USA), Inc. As a result, the accounts of all affected employees were transferred out of G4S Secure Solutions (USA), Inc. 401(k) Plan to the Plan. The Plan was frozen prior to the merger into the Allied Universal, Inc. 401(k) Plan.

Merger: In April 2021, Atlas UK Bidco Limited acquired G4S plc. G4s plc was the parent company of G4S Holding One Inc., who was the 100% owner of G4S Compliance & Investigations, Inc. In December 2021, all active employees of G4S Compliance & Investigations, Inc. transferred to Allied Universal Compliance & Investigations, Inc. and became eligible participants under the Allied Universal 401(k) Plan (“AUS 401(k) Plan”) effective January 1, 2022. The Plan was frozen as of January 1, 2022. The Allied Universal Committee approved the merger of the Plan into the AUS 401(k) Plan in March 2022. All investments were transferred from the Plan into the AUS 401(k) Plan on June 27, 2022, with residual assets being cleared from the Trust in July 2022.

Eligibility Requirements: Effective January 1, 2021, employees are eligible to participate in the Plan upon the completion of six months of service and attaining age 21.

Contributions: Each year, participants may elect to defer a percentage of their compensation into the Plan, subject to certain limitations set forth in the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. No participant contributions were made to the Plan during the seven-month period ended July 31, 2022.

The Company elected to make discretionary matching contributions for all participants of 50% up to 6% of eligible compensation that a participant contributed to the Plan. For 2022, the Company did not make any discretionary matching contributions to the Plan.

Effective January 1, 2021, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation.

Rollover Contributions: The Plan provides for rollover contributions from other qualified retirement plans.

Participant Accounts: Plan contributions are made at specified rates and are credited to an individual account in the name of each participant. Each participant’s account is credited with the participant’s contributions and an allocation of the Company’s matching contributions, Plan earnings, and administrative expenses, and, at the discretion of the Plan administrator, forfeitures of terminated participants’ nonvested accounts. Under such a plan, the participant is not provided with any fixed benefit. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Directed Investment Accounts: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

Forfeited Accounts: At July 31, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$34,724, respectively. These accounts, at the discretion of the plan sponsor, may be used to pay administrative expenses or reduce future contributions by the Company. No forfeitures were allocated during the period ended July 31, 2022.

Vesting: Participants are 100% vested in the salary reduction amount contributed to the Plan. Vesting in the Company's matching portion of their accounts is based on the years of continuous service. The Company elects the following vesting schedule:

Funding Policy: The employer is generally required to pay the trustee its contribution to the Plan for each plan year within the time prescribed by law, including extensions of time for the filing of the employer's federal income tax return for the fiscal year. However, employee elective contributions accumulated through payroll deductions shall be paid to the trustee as of the earliest date on which contributions can be reasonably segregated from the employer's general assets, but in any event, fifteen days immediately following the month to which such contributions relate. Furthermore, any additional employer contributions which are allocable to participants' accounts for a plan year shall be paid to the plan no later than the twelve-month period immediately following the close of such plan year.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of the participant's vested account balance. Transactions are treated as a transfer between the investment options and the participant's note fund. All loans must be adequately secured, bear a reasonable rate of interest, and have a definite repayment period not to exceed five years unless the loan is for the purchase of primary residence when the repayment period may be more. At July 31, 2022, there were no notes receivable from participants. At December 31, 2021, interest rates ranged from 4.25% to 6.50% and mature at various dates through 2029. Principal and interest are paid ratably through payroll deductions. Interest income from notes receivable from participants approximated \$0 in 2022.

Payment of Benefits: A participant's vested interest in the Plan's assets is distributed to the participant, his spouse, or other beneficiary generally upon termination, disability, retirement, death, or proven financial hardship. A participant will receive a lump-sum amount equal to the value of his or her account as defined in the Plan.

Hardship Withdrawals: Withdrawals due to financial hardship are permitted for the following reasons: medical expenses, funeral expenses, purchase of primary residence, post-secondary tuition payment, eviction from or foreclosure on principal residence or as otherwise provided by the Plan. Withdrawals may only reduce employee deferrals and are not permitted after a participant has separated from service.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, and trustee. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

Investment and Securities Transactions: The Plan's investments are stated at fair value. All Plan assets were transferred to the 401(k) Plan before close of business on June 27, 2022 with residual assets being cleared from the Trust in July 2022.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of July 31, 2022 and December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions: Employer and employee contributions are accrued in the Plan year to which they relate.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Date of Management's Review of Subsequent Events: The Plan has evaluated subsequent events through May 10, 2023, the date which the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the seven-month period ended July 31, 2022, there were no transfers of investments into or out of Level 3.

NOTE D--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE E--RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Great-West Trust Company, LLC ("Great-West"). Great-West is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid to Great-West by the Plan approximated \$48,000 for the seven-month period ended July 31, 2022.

**NOTE F--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

The Company merged the Plan with the 401(k) Plan on July 31, 2022.

**NOTE G--TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2014, that the pre-approved prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.
