### **Independent Auditors' Report**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter**

As described in Note 1 to the financial statements, plan management of Stafford Health Services, Inc. Retirement Plan approved a plan of liquidation effective July 31, 2023. As a result, the plan has changed its basis of accounting from the going concern basis used in presenting the December 31, 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1 - DESCRIPTION OF PLAN**

The following description of the Stafford Health Services, Inc. Retirement Plan provides only general information. Participants should refer to the plan agreement or summary plan description for a more complete description of the plan's provisions, which are available from the plan administrator.

The plan sponsor has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions set forth in ERISA. Effective July 31, 2023 the company resolved to terminate the plan as a result of a sale of the plan sponsor's business. The resolution specified that all participants under the plan shall become 100% vested in all accounts and all accounts should be distributed to participants as soon as administratively feasible. Liquidation of assets occurred through distributions to participants. Full liquidation of the plan was completed as of December 15, 2023.

**GENERAL**

The plan is a defined contribution plan covering all employees of the plan sponsor, Stafford Health Services, Inc. and its affiliated companies (collectively referred to as "the company"), who are age twenty-one or older, have completed one year of service, and have worked at least 1,000 hours. Affiliated companies include Stafford Suites LLC, Ridgemont Terrace Inc., Belmont Terrace Inc., and Stafford Healthcare SeaTac LLC. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Participants may contribute a percentage of eligible annual compensation, as defined in the plan agreement. Additionally, participants age 50 or older, who are making contributions to the plan, are allowed to make catch-up contributions as defined in the plan. Participants may also contribute amounts representing rollover distributions from other qualified plans.

The company will make a matching contribution annually. This matching contribution is based upon each participant's eligible contributions limited to 2% of the participant's compensation. The company may also make a discretionary profit sharing contribution. The company made matching contributions of \$80,725 and \$143,056 for the period ended December 15, 2023 and year ended December 31, 2022, respectively. There were no discretionary profit sharing contributions.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and allocations of (a) the company matching contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Vesting in employer matching contributions and profit sharing contributions plus actual earnings thereon are based on years of continuous service as follows:

#### **PARTICIPANT INVESTMENT ACCOUNT OPTIONS**

Upon enrollment in the plan, participants are able to direct their contributions, including matching and discretionary profit sharing contributions among any or all of the multiple investment account options. Investment options are pooled separate accounts held by John Hancock Life Insurance Company (U.S.A.). Participants may change their investment options daily. There are no nonparticipant directed investments.

Contributions may be temporarily held as cash balances prior to the execution of the investment according to the participant's direction.

#### **PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, a participant with a balance in excess of \$1,000 may receive a single lump-sum distribution equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant with a balance in excess of \$1,000 may elect whether to receive a lump-sum distribution or roll over the vested interest in his or her account into another qualified plan. A participant will receive an automatic benefit payment for the value of the vested interest in his or her account as a cash lump-sum for balances under \$1,000.

#### **HARDSHIP WITHDRAWALS**

Participants are permitted to withdraw, in a single sum, up to the vested portion of their account balance under certain conditions. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of funeral expenses or casualty losses (as defined by the Internal Revenue Code) or to prevent eviction or foreclosure from the participant's principal residence.

#### **FORFEITURES**

Forfeitures of non-vested company contributions can be used to first pay any plan administrative expenses or offset future employer contributions. Forfeitures in the amount of \$0 and \$18,131 were available at December 15, 2023 and December 31, 2022, respectively. For the period ended December 15, 2023 and year ended December 31, 2022, the plan used forfeitures of approximately \$21,000 and \$7,000, respectively, to offset employer contributions and administrative expenses.

**Note 2 - SUMMARY OF ACCOUNTING POLICIES****BASIS OF ACCOUNTING**

The financial statements of the plan are prepared using the accrual method of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's trustee and plan administrator determine the plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

**EXCESS CONTRIBUTIONS PAYABLE**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code are recorded as a liability with a corresponding increase to corrective distributions. The plan distributed the excess contributions to the applicable participants prior to March 15 of the following year.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATION OF PLAN ASSETS**

Administrative expenses for the plan are paid by the plan and totaled \$58,361 and \$58,101 for the period ended December 15, 2023 and year ended December 31, 2022, respectively. Additionally, fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses.

**Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A), the custodian of the plan, has certified that the following data included in the accompanying financial statements is complete and accurate with respect to investments:

- Cash
- Fair value of investments
- Net appreciation (depreciation) in fair value of investments
- Interest income

The plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

#### Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Pooled separate accounts are valued at the net asset value (NAV) of units of the separate account. Participant transactions (purchases and sales) may occur daily. Were the plan to initiate a full redemption of the separate account, the custodian reserves the right to temporarily delay the withdrawal from the account to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 6 - TAX STATUS

The plan sponsor adopted a Prototype Non-Standardized Profit Sharing Plan with a deferral arrangement that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, the plan was restated effective January 1, 2022, which stated the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (the code). Once qualified, the plan is required to operate in conformity with the code to maintain its qualification. The plan administrator believes that the plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7 - PARTY-IN-INTEREST TRANSACTIONS

The pooled separate accounts are managed by John Hancock Life Insurance Company (U.S.A.), the custodian of the plan. Investment management fees, custodian fees and third party administration fees are included in administrative expenses in the accompanying financial statement.

The plan used the services of the independent public accounting firm to audit the plan. Administrative expenses for the period ended December 15, 2023 and year ended December 31, 2022 includes approximately \$9,000 and \$6,000, respectively, paid to the independent public accounting firm.

These transactions qualify as party-in-interest transactions.

#### Note 8 - RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
