Independent Auditors' Report

To the Board of Trustees
Catania Hospitality Group, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Catania Hospitality Group, Inc. 401(k) Plan ("the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (*in Liquidation*) and 2022 (*Ongoing*), and the related statements of changes in net assets available for benefits for the years ended December 31, 2023 (*in Liquidation*) and 2022 (*Ongoing*), and the related notes to the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Notes to Financial Statements

Note 1 – Description of plan

The following description of the Catania Hospitality Group, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by the Catania Hospitality Group, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company is the Plan Administrator. In general, the Plan Administrator manages the operation of the Plan, subject to the terms and provisions of the Plan.

Plan assets are held by Fidelity Management Trust Company (the “Trustee”).

On November 28, 2023, the Company directed the Trustee to terminate the Plan and to distribute Plan assets as soon as administratively feasible (Note 5).

Eligibility

Employees of the Company are eligible to participate if they have attained age 18, and have completed six months of service.

Contributions

Participants may elect to make a pre-tax savings contribution to the Plan up to the maximum amount allowed by law. The deferred percentage is subject to certain limitations specified by Internal Revenue Service (“IRS”) regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company made matching contributions of 25% of the first 5% of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company’s Board of Directors. Contributions are subject to certain limitations. Participants aged 50 and above are also permitted by IRS regulations to make catch-up contributions.

Participant accounts

Each participant’s account is credited with the participant’s contribution, and an allocation of the Company’s contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service. Upon termination of the Plan, all participants become 100% vested in the Company’s matching contribution and related earnings.

Distribution of benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the vested value of his or her account or a rollover to an IRA or Qualified Plan. If the account balance is in excess of \$5,000, the participant may elect to leave funds invested in the Plan.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 limited to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and, as of December 31, 2023, bear interest at a rate of 3.25%, which is commensurate with local prevailing rates as determined by the Plan Administrator. The term of the loan may not exceed five years. Principal and interest is paid ratably through payroll deductions. When a participant defaults on their note and is not eligible for a plan distribution, the unpaid balance is treated as a deemed distribution to the participant for purposes of the Form 5500 (see Note 8). Upon resolution to terminate the Plan, any future new notes receivable were disallowed from the Plan.

Forfeited accounts

These accounts are used to first reduce administrative expenses of the Plan, then to supplement Company matching contributions.

Note 2 – Summary of significant accounting policies

Method of accounting

For 2022, the Plan's transactions are reported on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). For 2023, the Plan's transactions are reported on the liquidation basis of accounting in accordance with U.S. GAAP.

Accounting estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. In connection with the Plan termination, actual interest and dividend income and administrative expenses through April 30, 2024 have been accrued for and are included in the Statements of Net Assets Available for Benefits (*In Liquidation*) and Statements of Changes in Net Assets Available for Benefits (*In Liquidation*) for the year ended December 31, 2023.

Administrative expenses

Certain costs of plan administration are absorbed by the Company. Investment related expenses are included in net appreciation in fair value of investments.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See discussion under *Fair Value Measurements* for a description of valuation methodologies used for assets measured at fair value.

Purchases and sales of securities are reflected on a trade-date basis. The Plan presents the net appreciation or depreciation in the fair value of its investments in the Statements of Changes in Net Assets Available for Benefits which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. Interest income is recorded, as earned, on an accrual basis. Dividend income is recorded on the ex-dividend date.

Payment of benefits

Benefits are recorded when paid.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Note 4 – Fair value measurements

Fair value measurements

The Fair Value Measurements topic of the FASB Accounting Standards Codification (FASB ASC) establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are: Level 1, defined as observable inputs such as quoted prices in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the Net Asset Value (“NAV”) of shares held by the Plan at year end.

Cash equivalent: Represents an investment in a money market fund and is valued at the Net Asset Value (“NAV”) of shares held by the Plan at year end.

The methods described on the previous page may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2023 and 2022, all of the Plan's investments are classified as Level 1 within the fair value hierarchy.

Note 5 – Plan termination

On November 28, 2023, the Company directed the Trustee to terminate the Plan and to distribute Plan assets as soon as administratively feasible. All balances were distributed as of April 30, 2024.

Note 6 – Tax status

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by Federal or State tax authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 7 – Related parties

Affiliates of the Trustee sponsor investments and provide recordkeeping services to the Plan. These investments and the administrative expenses associated with the recordkeeping services qualify as party-in-interest transactions. Participant notes receivable are also considered party-in-interest transactions.

We have audited the financial statements of Catania Hospitality Group, Inc. 401(k) Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit") for the year ended December 31, 2023 (*In Liquidation*), and we will issue our report thereon dated July 23 2024. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated April 18, 2024. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was changed as a result of the Plan's termination. The Plan changed its basis of accounting from the going concern used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements in accordance with accounting principles generally accepted in the United States of America. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The most sensitive estimate affecting the financial statements was management's estimate of the fair value of Plan investments, based on information certified by the trustee, as follows:

Mutual Funds: Valued at net asset value ("NAV") per share (or its equivalent).

We evaluated the methods, assumptions, and data used to develop the estimate in determining that it is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. We are pleased to report that there were no corrected or uncorrected misstatements.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated July 23, 2024.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to our retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of the Trustees and management of Catania Hospitality Group, Inc. 401(k) Plan, and is not intended to be, and should not be, used by anyone other than these specified parties.
