To the Trustees of

Scope and Nature of ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

NOTE A – DESCRIPTION OF PLAN

The following description of the Underwood Brothers, Inc dba AAA Landscape 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Underwood Brothers, Inc dba AAA Landscape (Plan Sponsor or Company) and an affiliate who has adopted the Plan. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility – Employees who are age 21, with the exception of union employees and nonresident aliens, become eligible to participate in the Plan on the first day of the calendar quarter coinciding with or next following the date they have completed three months of service. Effective December 1, 2019, the Plan was amended to lower the minimum age to 18. Participants are eligible to receive employer discretionary matching contributions once they have completed three months of service. Participants are eligible to receive employer discretionary profit-sharing contributions upon completing 1,000 hours of service as long as they are employed on the last day of the Plan year.

Contributions – Each year, participants may elect to defer up to the maximum amount allowed by law of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution as a percentage of the participant's eligible deferral contributions and a discretionary profit-sharing contribution at the option of the Company's management. For the years ended December 31, 2020 and 2019, the Company elected to make discretionary matching contributions of 20 percent of the first 5 percent of base compensation that a participant contributes to the Plan totaling \$24,633 and \$22,016, respectively. The Company did not make discretionary profit sharing contributions for the years ended December 31, 2020 and 2019. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions, if any, and Plan earnings (loss). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (loss), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their elective deferrals and any rollover contributions made to the Plan plus actual earnings thereon. Participants are vested in the Company’s discretionary matching and profit-sharing contributions based upon years of credited service, as defined. A participant’s vests 20% for each year of service after two years and is 100% vested after six years of service. Additionally, participants become fully vested upon normal retirement age, death, or total disability prior to retirement.

Notes receivable from participants – Notes receivable from participants represent loans which allow participants to borrow from their accounts, subject to approval by the Plan Administrator. The minimum amount that may be borrowed is \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant’s vested account balance. The loans are secured by the remaining balance in the participant’s account and bear interest, which is fixed at prime plus 2% at the time the loan is made and is commensurate with local prevailing Principal and interest are paid ratably through periodic payroll deductions over a term not to exceed five years, unless the loan qualifies as a home loan, as defined.

Payment of benefits – On termination of employment including disability and retirement, a participant may to receive the value of the vested interest in his or her account as a lump sum distribution. Participants may take hardship withdrawals from their account as set forth in the provisions of the Plan document.

Forfeited accounts – At December 31, 2020 and 2019, forfeited nonvested accounts totaled \$4,512 and \$2,615, respectively. These accounts shall be used to reduce employer contributions or offset Plan expenses at the discretion of the Plan Administrator. During the years ended December 31, 2020 and 2019, forfeited accounts of \$0 and \$2,943, respectively, were used to reduce employer contributions. In addition, plan administrative expenses were reduced by \$200 and \$1,695, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

The Plan maintains its financial records using the cash basis of accounting, under which additions and deductions to net assets available for benefits are recognized when they occur. Adjustments are prepared at each year-end to adjust the financial records to the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2020 and 2019. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess contributions payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2020 excess contributions to the applicable participants after March 15, 2021 and filed Form 5330 in 2022. The Plan distributed the 2019 excess contributions to the applicable participants after March 15, 2020 and filed Form 5330 in 2020.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events – The Plan Administrator has evaluated subsequent events through July 12, 2024, the date the financial statements were available to be issued.

NOTE C – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2020 and 2019, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2020 and 2019, was obtained by the Plan Administrator and agreed to or derived from information certified as complete and accurate by Massachusetts Mutual Life Insurance Company (trustee of the Plan through August 31, 2020) and John Hancock Life Insurance Company (the trustee of the Plan effective September 1, 2020).

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2020 and 2019.

- *Pooled separate accounts* – Investments in pooled separate accounts are valued at their participation unit share of the total pooled fund as determined by the trustee.
- *Cash and equivalents* – Valued at the closing price reported in the active market in which the individual security is traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

NOTE E – PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the trustee and recordkeeper for the Plan effective September 1, 2020, therefore, these transactions qualify as party in interest transactions. Massachusetts Mutual Life Insurance Company was the trustee and recordkeeper of the Plan through August 31, 2020, and, therefore, fees paid for services qualify as party in interest transactions.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE G – TAX STATUS

The Company has adopted a prototype volume submitter profit sharing plan sponsored by Pension Benefit Solutions Inc dba Sunwest Pensions. The IRS has determined and informed the sponsor of the prototype plan by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE G – TAX STATUS – continued

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
