Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BCRA, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of BCRA, Inc. 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTE A.--DESCRIPTION OF PLAN

The following description of BCRA, Inc. (Company or Sponsor) 401(k) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) profit sharing plan originally effective September 1, 1998. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by the Company or the related employer BCRA Construction, LLC excluding employees covered by a collective bargaining agreement, leased employees, employees incorrectly determined to be an employee, non-resident aliens, and interns. Employees are eligible to participate in deferring a portion of their pay to the Plan, in discretionary employer match contributions and in discretionary profit sharing contributions upon reaching age 21 and after completing one consecutive month of service. The entry date is the first day of each quarter following completion of eligibility requirements. Effective June 15, 2021, the plan was restated as part of a cycle 3 restatement period.

Contributions: The Plan is funded by eligible participant elective deferrals which may be up to 90% of pre-tax annual compensation, discretionary matching contributions and discretionary profit-sharing contributions. Eligible participants are automatically enrolled in the Plan with a deferral amount of 5% of their eligible compensation with an automatic increase of 1% up to 10% on the first day of each Plan year, thereafter.

The discretionary match contributions were calculated at 50% of deferrals, up to 5% of wages for the year ended December 31, 2023.

Discretionary profit-sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Participants must be employed on the last day of the Plan year and complete 1,000 hours of service during the Plan year to be eligible to receive any profit-sharing contributions, unless the participant dies, becomes disabled or reaches the normal retirement age. There were no discretionary profit sharing contributions in 2023.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Also, all participants who are eligible to make elective deferral contributions may designate all or any portion of their deferrals as Roth elective deferral contributions. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions, an allocation of plan earnings (losses), and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

NOTE A.--DESCRIPTION OF PLAN (Continued)

Vesting: Participants are immediately vested in their rollover contributions and elective deferrals plus actual earnings thereon. Vesting in any Company discretionary matching or profit sharing contributions is based on years of continuous service. A participant is 33% vested after two years of credited service, 67% vested after three years, with full vesting at four years, or upon death or disability.

Retirement: The normal retirement date is the first day of the month on or after the date the participant turns 60. There is no early retirement.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or a partial payments. For terminated service due to other reasons, a participant may receive the value of their vested account in a lump sum, partial payment or may continue to participate in the plan investments and benefits will be provided upon retirement or death. If the balance of the vested accounts is \$1,000 or less, payment may be made in a lump-sum without the participant's consent. If such balance is less than or equal to \$5,000 but greater than \$1,000, without other election, it will automatically be rolled over into an IRA established by the Company. Hardship distributions are allowed in accordance with the provisions of the Plan. In-Service distributions are allowed at age 59½. Qualified reservist distributions are also allowed.

Notes Receivable from Participants: Participants may borrow from their accounts, except for Roth amounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. A participant may have up to two loans outstanding at a time. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed thirty years. Under the terms of the Plan agreement, plan loans will bear a reasonable rate of interest, further defined as prime plus 1%. Principal and interest are paid through payroll deductions.

Investment Options: Participants direct their contributions and account balances in a variety of investment options among the investments offered under the Plan. The Plan Sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

Forfeitures: Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and at the discretion of the Company, may be used pay the Plan's administrative expenses with any remaining amount used to reduce future Company contributions. As of December 31, 2023 and 2022, forfeited non-vested account totaled \$8,227 and \$0, respectively. During 2023, \$12,165 of plan fees were paid from forfeited non-vested accounts.

Plan Expenses: Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid for directly by the Company and are not included in these financial statements. Fees relating to administration of notes receivable from participants and for certain withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses including 12b-1 fees and revenue sharing fees are deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines valuation utilizing information provided by investment advisors and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefit payments based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the record keeper of the Plan as agent for Ascensus Trust Company, the custodian of the Plan.

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

Collective trust: Value at NAV of units held by the Plan at year end. The NAV, as provided by the trustee and custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a collective investment is calculated based on a compilation of primarily observable market information. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemption activity in the trust. If the Plan initiates a full redemption of the collective trust, the issue reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in orderly business manner.

Self-directed brokerage accounts: The Plan allows participants to invest up to 75% of their Plan balance in self-directed brokerage accounts. Available funds under this feature are subject to certain limitations but generally include: Interest-bearing cash, stocks, fixed income securities (including corporate and government bonds), and mutual funds. Holdings as of December 31, 2023 and 2022, included interest-bearing cash and corporate stocks.

Interest-bearing cash: Valued at carrying value which approximates fair value.

Corporate stocks: Valued at the closing price reported on the active market on which individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

No such officer or employee receives compensation from the Plan.

NOTE F.--TAX STATUS

The plan was amended and restated effective June 15, 2021 and adopted a non-standardized pre-approved profit sharing plan with CODA, which received a favorable opinion letter from the Internal Revenue on June 30, 2020, which stated that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan, including employer contributions, shall become fully vested and non-forfeitable.

NOTE H.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE I.--SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 8, 2024 which is the date the financial statements were available to be issued.
