I received a notice dated January 25, 2024 informing me of penalties for the 2022 Form 5500-SF for the Girl Boy Girl 401(k) Plan (Plan #001).

I hired ADP Retirement Services as our Third Party Administrator for the Plan. The Plan was terminated on February 28, 2022 and liquidated in March 2022.
