## **TTG EQUIPMENT LLC 401(k) PLAN NOTES TO FINANCIAL STATEMENTS**

### **DESCRIPTION OF PLAN**

The following brief description of the TTG Equipment LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan with salary reduction features which is commonly referred to as a 401(k) plan. It covers all eligible employees of TTG Equipment LLC (the Company). Employees become eligible when they complete one year of service and attain age 21. They may participate once they reach their entry date, which is either the first day of the Plan year or the first day of each quarter in the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was established on September 5, 2019 through a merger of Troxel Equipment Co., Inc. 401(k) Plan, Harper Implement Company Inc Retirement Savings Plan, and Jackson-Lee-Pearson 401(k) & Profit Sharing Plan.

#### **Merger**

Effective October 31, 2023, the Plan, including all assets and liabilities, were merged into and with the Truland Equipment, LLC 401(k) Plan with participants of the Plan becoming participants in the Truland Equipment, LLC 401(k) Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, including rollovers, allocations of the Company's safe harbor contribution and an allocation of plan earnings, and debited with an allocation of expenses that are paid by the Plan. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Contributions**

Participants may contribute the maximum amount allowed by the Internal Revenue Code to the Plan, as defined, on a pre-tax basis and/or on a post-tax basis. Participants 50 years of age or older are allowed an additional catch-up contribution as defined by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan is a "safe harbor 401(k) plan". In order to maintain "safe harbor" status, the Company will make a contribution equal to 3% of compensation annually. The Company may also make a discretionary matching contribution or a discretionary nonelective contribution. For the period January 1, 2023 to October 31, 2023 and for the year ended December 31, 2022, the Company did not make any such additional discretionary contributions.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates. The interest rate remains fixed throughout the duration of the loan. Participants may only have one loan outstanding at any given time. Principal and interest is paid ratably through payroll deductions.

**DESCRIPTION OF PLAN, continued**

**Vesting**

Participants are immediately vested in their voluntary contributions, rollover contributions and safe harbor contributions plus actual earnings thereon. A participant becomes vested with respect to the Company's discretionary contributions based upon the number of years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 3	0%
3	100%

Nonvested amounts are forfeited upon termination of service and may be used to pay Plan expenses or to reduce the Company's contribution in the year following forfeiture. Forfeitures attributable to matching contributions may be used to reduce any matching contribution. Forfeitures attributable to nonelective contributions may be used to reduce any nonelective contribution.

**Investment Options**

The trustee of the Plan determines and approves investment options set up for the Plan. Upon enrollment in the Plan, a participant can direct contributions into various investment options offered by the Plan. The Plan's assets are held in trust. The custodian invests in monies according to participant directions.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts may be used to reduce administrative expenses and/or offset employer contributions.

**SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management and trustees to make estimates and assumptions that affect certain reported amounts of plan assets and liabilities and the disclosure of contingencies, if any, at the date of the financial statements, and additions to and reductions from net assets available for plan benefits during the reporting periods. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See also FAIR VALUE MEASUREMENTS footnote.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2023 or December 31, 2022. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value investments.

**Date of Management's Review**

Management has evaluated subsequent events through August 13, 2024, the date which the financial statements were available to be issued.

**FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value. Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of fair value hierarchy are described below:

Level 1 – Quoted prices in active markets for identical, unrestricted assets or liabilities.

Level 2 – Quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at October 31, 2023 and December 31, 2022.

**Mutual Funds**

Mutual funds are valued at the daily closing price as reported by the fund. All the mutual funds are funds with quoted daily prices that are directly observable in the marketplace by market participants.

**Collective Investment Trust**

The Plan participates in the PIMCO Stable Inc Fund which is held in a collective investment trust fund held by SEI Trust Company. Collective trust funds are valued at net asset value (NAV) of the units of the collective trust. NAV is used as a practical expedient to estimate fair value.

**PLAN AMENDMENTS**

Effective April 1, 2022, the Plan was amended to adopt a pre-approved Fidelity sponsored 401(k)/profit sharing plan document which named Fidelity Management Trust Company as Trustee, named Fidelity Workplace Services, LLC as recordkeeping services provider, and allowed for participant loans.

**INCOME TAX STATUS**

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the non-standardized prototype document has a favorable determination letter from the IRS dated June 30, 2020. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date

**PLAN TERMINATION AND MERGER**

Effective September 1, 2023, the TTG Equipment LLC 401(k) Plan merged into the KennFeld Group LLC 401(k) Profit Sharing Plan. The KennFeld Group LLC 401(k) Profit Sharing Plan has been restated and renamed as Truland Equipment, LLC 401(k) Plan under a pre-approved plan provided by Lincoln Retirement Services Company LLC. Lincoln Financial Group Trust Company was named Trustee of this new plan. On October 31, 2023, the Plan, including all assets and liabilities, were merged into and with the Truland Equipment, LLC 401(k) Plan.

**RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity. Fidelity serves as the trustee, recordkeeper, and custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Trustee collects management fees by offsetting the investment return. The Plan is not directly billed for these fees.

Participants pay fees to the recordkeeper for loan and withdrawal transaction processing. These transactions qualify as permitted party-in-interest transactions.

The Plan allows participants to borrow from their vested account balance and notes receivable from participants also qualify as party-in-interest transactions.

**RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
