INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Bamberger Polymers 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Basis for Opinion

Note 1 - Description of plan:

The following description of the Bamberger Polymers 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all employees of Bamberger Polymers, Inc. (the Company, Plan Sponsor or Plan Administrator) who had completed at least one month of service and had attained age 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management was responsible for oversight of the Plan. The Investment Committee determined appropriateness of the Plan's investment offerings, monitored investment performance, and reported to Management.

In 2023, the board of directors of the Company elected to merge the Plan into the Ravago Americas 401(k) Savings and Profit Sharing Plan (Ravago Plan), the plan sponsored by Ravago Americas, Inc. (Ravago), the sister company of the Company. The Plan was frozen in December 2023 and subsequently all of the Plan's assets were transferred including unpaid employer contributions receivable of \$1,022,302 and unpaid participant contributions receivable of \$42,389 to the Ravago Plan on December 31, 2023.

The Plan is part of a controlled group with the Ravago Plan. As a result of the compliance testing, a retroactive amendment was required and executed for the 2023 Plan year. The amendment needed was for the Plan to pass the Internal Revenue Code Section 410(b) coverage requirements and resulted in an immaterial QNEC.

Contributions

Prior to the Plan termination by merger, each year, participants could contribute up to 100% of annual compensation, as defined in the Plan, not to exceed the limits of the Internal Revenue Code (IRC). The Plan allowed for pre-tax and after-tax (Roth) contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Prior to the Plan termination by merger, the Company could make matching and/or profit sharing contributions. Participants were eligible for matching and profit sharing contributions after completing 6 months of service. For 2023, the Company made matching contributions in an amount equal to 20% of the matched employee contributions that were not in excess of 5% of the participant's compensation, as defined. Additional profit sharing amounts could be contributed at the option of the Company's board of directors. In order to receive a match or

profit sharing contribution, the participant must have worked 1,000 hours in the Plan year and been an employee on the last day of the Plan year. For the year ended December 31, 2023, the Company made a matching contribution of \$148,847 and a profit sharing contribution of \$873,455 to the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations. Participants directed the investment of their contributions into various investment options offered by the Plan.

Effective October 1, 2023, the Plan was amended to allow for participants who had completed 1 month of service to be eligible to receive matching and profit sharing contributions. Effective January 1, 2023, the Plan was amended to remove the requirement that participants work at least 1,000 hours in the Plan year and be an employee on the last day of the Plan year to be eligible to receive a match and/or profit sharing contribution.

Participant accounts

Prior to the Plan termination by merger, each participant's account was credited with the participant's contributions, rollover contributions, and Company matching contributions, as well as allocations of Company profit sharing contributions, Plan earnings and Plan losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions and earnings thereon were based on years of continuous service, as defined by the Plan document. The participants began vesting in Company's matching and profit sharing contributions at a rate of 20% per year upon completion of their second year of service. A participant was 100% vested after six years of service.

Participants were also immediately vested upon termination of the Plan, upon reaching the early retirement age of 59½, normal retirement age of 65, or upon disability or death while an employee of the Plan Sponsor. Forfeitures of terminated participants' non-vested accounts were used by the Plan to restore forfeitures, reduce company contributions, be reallocated to participant accounts, or to pay reasonable plan expenses.

Forfeitures

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$8,420, respectively. As stated above, these accounts could be used to restore forfeitures, reduce Company contributions, be reallocated to participant accounts, or to pay reasonable plan expenses. For the year ended December 31, 2023, Company contributions were reduced by \$9,190 from forfeited non-vested accounts. The Plan's assets transferred to the Ravago Plan on December 31, 2023. Included in the transfer was a forfeiture balance of \$59,376.

Payment of benefits

A participant was entitled to receive a lump-sum amount, substantially equal annual installment payments or payments in the form of an annuity upon attainment of age 50 (with certain limitations), termination of service, retirement, or death. A participant could have requested a withdrawal from the Plan while still under the employment of the Company for reasons of financial hardship from all accounts.

For termination of service due to other reasons, and if the vested account balance, excluding rollover contributions, if any, exceeded \$1,000, a participant may have elected to receive a lump sum distribution or to remain in the Plan. If the vested account balance was less than \$1,000 the plan administrator would distribute the participants entire vested account balance as a lump-sum distribution as soon as administratively feasible.

Notes receivable from participants

Participants could borrow from the Plan any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms were for a period not exceeding five years unless for the purchase of a principal residence, in which case the note repayment period could not extend beyond 30 years. Notes were secured by the balance in the participant's account and bore interest at an agreed-upon percentage based on prevailing market rates as reflected in the Wall Street Journal on the date of the note, plus one percent. Principal and interest were paid ratably through payroll deductions. Participants were allowed up to five notes outstanding at any one time.

Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. The Company reserved the right to elect to pay, or have the Plan pay, administrative costs in the future. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were

included in administrative expenses. Investment related expenses were included in net appreciation of fair value of investments.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Collective investment trust fund

Investments in the collective investment trust fund (the Principle Stable Value 2 Fund) were required to be reported at fair value. The collective investment trust fund, at the fund level, was composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts were not considered fully benefit-responsive to the Plan as the underlying contracts were not direct investments between the Plan and the issuer. The Plan had elected to value the collective investment trust fund using net asset value (NAV) as the practical expedient to determine fair value.

Investment valuation and income recognition

Investments were reported at fair value. Fair value was the price that would have been received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

Payment of benefits

Benefits were recorded when paid.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP required management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceased to make note repayments and the Plan Administrator deemed the participant note to be in default, the participant note balance was reduced and a benefit payment was recorded.

Risks and uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it was at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Recent legislative developments

In December 2019 and December 2022, Congress passed the SECURE Act and SECURE 2.0 Act, respectively, which included numerous reforms to existing retirement law and allows plan sponsors to make certain immediate plan operational changes without formal amendment of the plan document. The Plan Administrator timely amended the Plan for any applicable changes.

Subsequent events

The Plan has evaluated subsequent events through August 8, 2024, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2023, have been incorporated into these financial statements.

Note 3 - Investments and information certified by the trustee:

Principal Life Insurance Company (Principal) and Principal Trust Company held the Plan's investment assets and executed investment transactions. Management has determined that Principal and Principal Trust Company were qualified institutions and the information prepared and certified by Principal and Principal Trust Company met the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal and Principal Trust Company.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used needed to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

- Mutual funds (or shares of registered investment companies) were valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Units of participation of the collective investment trust fund were valued at NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not have been used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may have occurred daily. If the Plan initiated a full redemption of the collective investment trust, the investment advisor reserved the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations would be carried out in an orderly business manner.
- Units of participation in pooled separate accounts were valued at the NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV was based on the quoted market prices of the underlying investments held in the pooled separate accounts at year-end.

The methodologies described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methodologies were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

All Plan assets were transferred to the Ravago Plan on December 29, 2023, thus there were no assets to be valued at the 2023 year end.

Note 5 - Related-party transactions:

Certain Plan investments were shares of mutual funds, a collective investment trust fund, and pooled separate accounts managed by an affiliate of the custodian/trustee of the Plan. Principal and Principal Trust Company were the custodian/trustee as defined by the Plan and; therefore, these transactions qualified as party in interest transactions and were exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services were included in net appreciation in fair value of investments.

Note 6 - Plan termination:

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In 2023, the board of directors of the Plan Sponsor elected to terminate the Plan by merger and all participants were 100% vested. In December 2023 the Plan was frozen at which time contributions ceased, other than those in-transit as of December 31, 2023. The Plan was terminated and the assets were transferred on December 31, 2023.

Note 7 - Tax status:

The underlying non-standardized pre-approved profit sharing plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the Plan was qualified under Section 401(a) of the Internal Revenue Code (IRC) and; therefore, the related trust was tax-exempt. The Plan Administrator determined that it was eligible to and chose to rely on the current IRS non-standardized pre-approved profit sharing plan opinion letter. Once qualified, the Plan was required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believed the Plan was being operated in compliance with the applicable requirements of the IRC and; therefore, believed that the Plan was qualified and the related trust was tax-exempt.

U.S. GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.
