Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of period) as of October 18, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

1. PLAN DESCRIPTION:

The following description of the Employees' Profit Sharing Plan of Woods Rogers PLC (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan was a defined contribution plan and was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective July 1, 2022, Woods Rogers PLC merged with Vandeventer Black LLP to form Woods Rogers Vandeventer Black PLC (the "Company"). The Plan reported in these financial statements covered substantially all employees of the legacy Woods Rogers offices.

Effective July 1, 2022, the Company established the Woods Rogers Vandeventer Black PLC Profit Sharing Plan that covered substantially all employees of the legacy Vandeventer Black offices through August 31, 2023.

Effective September 1, 2023, the Woods Rogers Vandeventer Black PLC Profit Sharing Plan was amended to cover substantially all employees of the Company. By October 18, 2023, substantially all of the Plan's net assets were transferred to the Woods Rogers Vandeventer Black PLC Profit Sharing Plan.

The Company's Board of Directors oversaw governance of the Plan. A plan committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Board of Directors.

Investment options:

Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered mutual funds (i.e. registered investment companies) and a stable value fund (i.e. common collective trust) as investment options for participants. In addition, participants could utilize an individual self-directed brokerage account, through which participants were able to invest in a variety of securities in accordance with the Plan's investment policy.

Contributions:

Plan participants could elect to defer up to 80% of their eligible compensation, not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code. Participant contributions were made through automatic payroll deductions every pay period. These contributions were not federally taxable to the participant until they were withdrawn from the Plan.

The Plan also had a Roth feature. Contributions were made from after-tax compensation. Participants would not be taxed on future distributions of their contributions and related earnings if certain requirements were met.

1. PLAN DESCRIPTION – (Continued):

Contributions – (Continued):

For the period ended October 18, 2023, the Company made discretionary matching contributions of \$236,495.

Participants who were members of a former employer's qualified plan could elect to make rollover contributions from that plan to the Plan.

Participant accounts:

Each participant's account was credited with the participant's contributions, the employer's contributions, and an allocation of Plan earnings, and charged with applicable administrative expenses paid by the Plan.

Vesting:

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's employer contributions, plus actual earnings were based on years of continuous service. A participant was 100% vested after six years of credited service.

Participant notes receivable:

Participants could borrow from their account a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their vested account balance. The term of a loan could not be longer than five years except for certain housing loans. Loans were secured by the balance in the participant's account and bore interest at rates of 4.25% to 9.50%. Principal and interest were paid ratably through payroll deductions.

Payment of benefits:

Upon termination of service, a participant could receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants could also rollover all or part of their vested interest to an eligible retirement plan.

Prior to terminating service or attaining normal retirement age, a participant under certain hardship conditions and with the approval of the Plan Administrator, could elect to receive a distribution equal to the lesser of their vested account balance or the amount needed to satisfy the hardship.

In-service withdrawals of vested balances could be elected by participants who have reached 65 years of age.

1. PLAN DESCRIPTION – (Continued):

Forfeited accounts:

Forfeited amounts were available to reduce employer contributions. At October 18, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$193,316, respectively. During the plan period ended October 18, 2023, \$131,078 was used to reduce employer contributions.

Administrative expenses:

Certain expenses of maintaining the Plan were paid by the Company and are therefore excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments. Administrative expenses of the Plan were allocated to participant accounts.

2. SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required the Plan Administrator to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Valuation of investments and income recognition:

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

Participant notes receivable:

Participant notes receivable were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account and were included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit payments:

Benefits were recorded when paid.

3. FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believed its valuation methods were appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

3. FAIR VALUE MEASUREMENTS – (Continued):

Level 1 - The fair values of mutual funds, exchange traded funds, common and preferred stocks, and publicly traded partnerships (included within registered investment companies and self directed brokerage accounts) are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 – The common collective trust is valued at the net asset value (“NAV”) of the units held by the Plan. The NAV is based upon the value of the underlying investments which are traded on an active market.

Level 3 – The self directed brokerage accounts include investment in a privately held limited liability company. The fair value of the limited liability company reflects the estimated fair value of the Plan’s interest based on recent appraisals and the views of company management. The following table reconciles the beginning and ending balances of fair value measurements using significant unobservable inputs of the limited liability company investment for the period ended October 18, 2023:

The Plan’s policy was to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the period ended October 18, 2023, there were no significant transfers into or out of Level 3.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain administrative functions were performed by officers or employees of the Company. These employees were also Plan participants. No such officer or employee received compensation from the Plan.

Plan participants could direct their investments into funds issued and managed by the Plan trustee. Investments in funds issued by the trustee were considered related party transactions. Fees paid by the Plan for trustee and investment advisory services amounted to \$151,923 for the period ended October 18, 2023.

5. PLAN TERMINATION:

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. As described in Note 1, substantially all of the Plan’s net assets were transferred to the Woods Rogers Vandeventer Black PLC Profit Sharing Plan by October 18, 2023. This was not considered a Plan termination as participants received essentially identical benefits under both plans.

6. INCOME TAX STATUS:

The Company adopted a volume submitter plan sponsored by OneAmerica Financial Partners Inc. The Internal Revenue Service determined and informed OneAmerica by a letter dated November 30, 2020 that the volume submitter plan and related trust were designed in accordance with applicable sections of the *Internal Revenue Code* (“IRC”). The Plan Administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC and that the Plan and related trust were tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate income tax positions taken by the Plan and recognize an income tax liability (or asset) if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator analyzed the income tax positions taken by the Plan, and concluded that as of October 18, 2023, there were no uncertain income tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by income tax authorities; however, there are currently no audits for any income tax periods in progress.

7. CERTIFICATION:
