Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Denihan Hospitality Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 31, 2023 (liquidation basis) and December 31, 2022 (liquidation basis), and the related statements of changes in net assets available for benefits for the period January 1, 2023 through October 31, 2023 (liquidation basis), and the related notes to the financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 1 to the financial statements, on March 30, 2022, the Plan Sponsor entered into a contribution agreement with a new investor whereby the Plan Sponsor transferred its interest in four of the hotels it owned and operated to the new investor and the Plan was subsequently terminated on July 31, 2022, and the Plan ceased to exist on October 31, 2023. As a result, the Plan changed its basis of accounting to the liquidation basis as of the plan termination date. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Plan Description

The following description of the Denihan Hospitality Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

On March 30, 2022, Denihan Ownership Company, LLC and its wholly owned subsidiaries (collectively, the “Plan Sponsor”), entered into a contribution agreement with a new investor. As part of the contribution agreement, the new investor formed a series of new wholly owned subsidiaries. On the closing date of April 26, 2022, the Plan Sponsor transferred its interest in four of the hotels it owned and operated to the new investor. The Plan Sponsor wound down operations during late 2022.

The Plan was terminated as of July 31, 2022. As a result of the plan termination, all participants became 100% vested in their accounts. Participants were notified and began the process of requesting distributions. During this period, the Plan was required to accrue and separately present any costs that it expected to incur and the income it expects to earn during liquidation. As of October 31, 2023, all of the Plan’s assets have been distributed or transferred out of the Plan.

Eligibility

The Plan was a defined contribution profit sharing plan covering all employees of Denihan Hospitality Group (“DHG” or the “Company”) that were not subject to a collective bargaining agreement. A participant was automatically entered in the Plan (unless they elect otherwise) on the first day of the month following three months of employment at 3% of eligible compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participants were eligible for matching contributions upon enrollment in the Plan and for profit sharing contributions after one year of service provided they have completed 1,000 hours of service in the Plan year and were an employee on the last day of the Plan year.

Contributions

Each year participants could contribute up to the amount allowed by the Internal Revenue Code (“IRC”) of pre-tax annual compensation, as defined in the Plan agreement. Participants who attained age 50 before the end of the Plan year were eligible to make catch up contributions up to the statutory permitted amount. Participants could also contribute amounts representing distributions from other qualified plans. The Plan allowed for discretionary matching contributions by the Company, up to 50% of the first 6% of annual compensation that a participant contributed to the Plan. DHG could also make profit sharing contributions to the Plan. Participants directed the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balance, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately and fully vested in their pre-tax contributions plus actual earnings thereon. Vesting in the employer matching and profit sharing contributions was based on years of continuous service. A participant was vested in all employer contributions as follows:

Sweep Account

The sweep account reflected the value of any contributions received not allocated, net of the value of any distributions payable from the Plan, pending settlement of the underlying investments, and any contributions held in the money market fund of the Plan's trustee.

Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance, not including any profit sharing contributions. Loan terms ranged from one to five years with the exception of loans for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at prime plus one percent per annum. Principal and interest was paid ratably through payroll deductions.

Interest on such loans accrued at the prime rate plus 1%. Interest rates on participant loans ranged from 4.25% to 6.00% at December 31, 2022.

Distributions

A participant's account would be distributed in a lump-sum payment upon termination, disability, retirement or death. The participant also had the option to receive the distribution in installments, if their balance was in excess of \$5,000. However, any non-vested portion of the account balance was forfeited, except in the case of disability, retirement or death. The Plan also provided for distributions under defined hardship distribution rules.

Forfeitures

Forfeitures were allocated first to reduce future Company matching contributions and then to reduce expenses incurred by the Plan. At October 31, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$68. During 2023, no forfeitures were used to reduce Company matching contributions and \$1,694 of forfeitures were used to reduce administrative expenses.

Administration

The Plan was administered by the Company. Bank of America, N.A., the Trustee of the Plan, was also the record keeper of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

As a result of Plan Termination (see Note 1), and in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), the Plan's financial statements for the period January 1, 2023 through October 31, 2023 are presented using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. The liquidation basis of accounting requires presenting assets and liabilities in the financial statements at the amount of cash or other consideration that the Plan expects to collect or pay during the course of liquidation. Such amounts, which aggregated \$1,052,788, were accrued for as of December 31, 2022 and are presented as liquidation basis adjustments in the statement of changes in net assets for the period ended December 31, 2023.

The preparation of financial statements in conformity with U.S. GAAP requires the Plan sponsor or plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. These estimates are based on information available at the time the estimates are made. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value and contract value. Mutual funds were stated at fair value as determined by quoted market prices, which represented the net asset value of shares held by the Plan at the period end. Common/collective trusts were valued based on the contract value of the underlying investment portfolio. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less withdrawals and transfers out (if any).

Interest income was recorded on an accrual basis. Dividend income was recorded on the ex-dividend date. Purchases and sales of securities were recorded on a trade date basis.

Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2023 to October 31, 2023.

US GAAP defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist.

The Plan's investments in mutual funds and amounts held in money market accounts were considered to be valued based on Level 1 inputs.

Notes Receivable from Participants

Notes receivable from participants were valued at their outstanding principal amounts plus accrued but unpaid interest. If a participant ceased to make loan repayments and the Plan administrator deemed the loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses incurred in connection with the general administration of the Plan were paid by the Plan and recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at October 31, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 through October 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America, N.A., the Trustee of the Plan and a qualified institution.

4. Investment in Common/Collective Trust – Contract Value

The Plan had entered into fully benefit-responsive common/collective trusts called the Invesco Stable Value Retirement Fund CL4 and Invesco Stable Value Retirement Fund GM CL4 (collectively the “trusts”), with Invesco Advisers, Inc. (the “Issuer”). The trusts were common/collective trusts that invested in actively managed fixed income commingled funds, as well as guaranteed investment contracts and insurance separate accounts. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The portion of the investment in common/collective trusts stated at contract value represented approximately 8% of the Plan’s net assets available for benefits as of December 31, 2022. The crediting interest rate of the trusts were 2.39% at December 31, 2022. There were no reserves against contract value for credit risk of the Issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the Issuer. Each investment contract had a zero percent floor on the crediting interest rate. The crediting interest rates were reset on a quarterly basis.

There were several risks specific to investment contracts. One of the primary risks involved was credit risk of the contract issuer. Credit risk for security-backed contracts included risks arising from the potential inability of the issuer to meet the terms of the contract wrapper and the potential default of the underlying fixed-income securities.

Secondly, liquidity was limited because of the unique characteristics of investment contracts and the absence of an actively traded secondary market. Interest rate risk was also present because rates may be fixed with these products. The net asset value (“NAV”) was calculated daily. Net investment income, if any, and realized and unrealized gains on investments are not distributed but rather are reinvested and reflected in the NAV of the fund. Units were issued and redeemed at the latest NAV. Redemptions by participating plans occurred at NAV following the 12-month notice period.

5. Tax Status

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2020.

The Internal Revenue Service ("IRS") has issued an opinion letter to the prototype plan document preparer dated June 30, 2020, which states that the Plan is designed in accordance with the applicable regulations of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

6. Party-in-Interest Transactions

Certain investments of the Plan were managed by the Trustee. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Fees paid by the Plan for administrative services to the Trustee and independent auditors amounted to \$55,571 for the period from January 1, 2023 through October 31, 2023.

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Company, who could be participants in the Plan, performed administrative services for the Plan at no cost to the Plan.
