## Independent Auditor's Report

To the Trustee and Participants of  
Assured Relocation, Inc. 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the accompanying financial statements of Assured Relocation, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the year ended December 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Plan Termination and Use of Liquidation Basis of Accounting***

As discussed in Note 1 to the financial statements, Assured Relocation, Inc. (the "Company") was acquired in April 2022. Those charged with governance made a decision to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from going concern basis to liquidation basis of accounting, starting with the 2022 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

### 1. Description of the Plan Prior to Plan Termination

The following description of the Assured Relocation, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was established on January 10, 2006 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees, as defined in the Plan, of Assured Relocation, Inc. (the "Company" and "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Certain administrative functions are performed by officers and employees of the Company. The assets of the Plan are held in a trust by Fidelity Management Trust Company ("Trustee"), who also serves as the Plan's record-keeper.

#### *Plan Termination*

In April 2022, the Plan Sponsor was acquired by an unaffiliated entity. A decision was made to terminate the plan effective July 31, 2022. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status of years of vested service. The Plan's termination also ceased employee contributions into the Plan and ceased new participant notes receivables from the Plan. The Plan's assets were fully distributed to participants during November 2022.

#### *Eligibility*

Employees of the Company are eligible to participate in the Plan after turning 21 and having completed three months of service. Participants may join the Plan on the first day of the month upon meeting the eligibility requirements.

#### *Contributions*

Eligible participants are required to enroll in the Plan directly with the Plan Sponsor and to specify their employee withholding percentage as a percentage of compensation, up to the legal maximum per year. The maximum deferral was \$20,500 for 2022. Participants who are age 50 or older are allowed to make additional contributions (catch up) up to the maximum amount allowed by the IRS. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan Sponsor may make discretionary profit-sharing contributions to the Plan as defined in the amended plan document. The Plan Sponsor made no discretionary profit-sharing contributions for the year ended December 31, 2022.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, rollovers, and allocations of Company's contributions and the Plan's earnings or losses. The Plan's earnings or losses are allocated based upon each participant's account balance. Certain fees are charged to the fund investments and are offset against the Plan's investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

#### *Investment Options*

Upon enrollment in the Plan, a participant may direct his or her contributions, in percentage increments, into a series of mutual funds or interest-bearing cash offered by the Plan. Participants may change their investment options at any time.

#### *Notes Receivable from Participants*

Participants may borrow from their accounts, subject to limitations. The minimum loan amount is \$1,000. The maximum loan amount is the lesser of \$50,000 or 50% of the vested interest of the participant in the Plan. The loans are secured by the balance in the participant's account. The balance outstanding to a single participant may not exceed \$50,000. Interest rates are determined periodically and ranged from 3.25% - 3.50% as of December 31, 2022. All loans are required to be repaid within five years of the date of the loan. Loans are to be repaid on the basis of substantially level amortization over the term of the loan with payments made through salary reduction in each pay period. Notes receivable from participants are measured at their unpaid principal plus any accrued interest.

#### *Payment of Benefits*

Employees are eligible for in-service early distributions prior to retirement for financial hardship, as defined in the Plan document.

Upon reaching the age of 59 ½ years, participants may elect to receive a distribution of any or all of their vested account balances. Participants may rollover their vested balances into another qualified retirement account such as an IRA or another 401(k) plan upon termination of employment with the Company.

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum distribution equal to the value of the participant's vested interest in his or her account or annual installments over the participant's life expectancy period.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

As a result of the decision to terminate the Plan, the Plan changed its basis of accounting from the accrual basis to the liquidation basis in the Plan's 2022 financial statements. Under the liquidation basis of accounting, assets and liabilities are stated at their estimated net realizable value and estimated costs through the liquidation period and are provided to the extent reasonably determinable. There were no material changes to the financial statements as a result of the change under the liquidation of accounting. The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America. Prior to the termination, the financial statements of the Plan were prepared using the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Sponsor to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. The Plan Sponsor believes that the estimates utilized in preparing these financial statements are reasonable and prudent. Actual results could differ from these estimates.

#### 2. Summary of Significant Accounting Policies (Continued)

##### *Notes Receivable from Participants*

Notes receivable from participants are recorded at their unpaid principal balances plus any accrued but unpaid interest. Interest income on participant loans is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2022.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor and the Trustee.

Purchases and sales of securities are reflected on a trade date basis. Interest is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments. Administrative expenses paid for the year ended December 31, 2022 were \$15,088.

#### 3. Information Certified by the Trustee

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, the Plan Sponsor has obtained certification from the Trustee that the following information included in the Plan's financial statements is complete and accurate:

- Investments and notes receivable from participants as of December 31, 2022, and
- Investment income and investment transactions for the year ended December 31, 2022.

### 4. Fair Value Measurements

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: The fair value is based on quoted market value of the shares held by the plan at year end.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

- Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.
- Interest-bearing cash: valued using fair value based on the outstanding balance.

As a result of the plan termination, as of December 31, 2022, no investments were held by the Plan as the distribution of assets was completed by the end of November 2022.

### 5. Tax Status

The Plan uses a prototype plan document sponsored by Fidelity Management and Research Co. who received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRS. The Plan itself has not received a determination letter from the IRS. Although the plan has been amended since receiving the opinion letter, the Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability or (asset) if the plan takes a position that is more likely than not to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

#### 6. Party-in-Interest Transactions

The Plan allows participants to borrow from their vested balances. All of the Plan's investments are offered by Fidelity, the Plan's recordkeeper and Trustee. These transactions qualify as party-in-interest transactions. All of these transactions are exempt from the prohibited transaction rules under ERISA.

#### 7. Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

#### 8. Non-Exempt Prohibited Transactions

During 2022, the Company failed to timely remit to the Plan withheld employee contributions in the aggregate amount of \$90,354 in accordance with the plan asset provision of the Department of Labor Regulation 2510.3-102, resulting in prohibited, or nonexempt, transactions. The accompanying schedule of delinquent participant contributions discloses these transactions with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Company failed to maintain fidelity bond coverage for the year ending December 31, 2022.

#### 9. Subsequent Events

The Plan evaluated subsequent events until August 13, 2024, the date the financial statements were available to be issued. No events have occurred subsequent to December 31, 2022 requiring recording or disclosure in these financial statements.
