INDEPENDENT AUDITOR'S REPORT

To the Trustees of
Tri-State Envelope Corporation 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tri-State Envelope Corporation 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 3, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 thru June 3, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tri-State Envelope Corporation 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 3, 2022 and December 31, 2021, and for the period January 1, 2022 thru June 3, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2021 Financial Statements section of our report. We are required to be independent of Tri-State Envelope Corporation 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting

As discussed in Note 8 to the financial statements, Tri-State Envelope Corporation was sold on December 6, 2021. Those charged with governance decided to terminate the Tri-State Envelope Corporation 401(k) Retirement Plan, and the plan was terminated on December 31, 2021. As a result, in accordance with accounting principles generally accepted in the United States of America, the Tri-State Envelope Corporation 401 (k) Retirement Plan has used the liquidation basis of accounting in presenting the June 3, 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tri-State Envelope Corporation 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Tri-State Envelope Corporation 401(k) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Tri-State Envelope Corporation 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial

statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Tri-State Envelope Corporation 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

GENERAL

The Plan is a qualified defined contribution plan which was established on May 1, 2001 covering all employees of Tri-State Envelope Corporation (the “Company”) except for:

- Employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, and
- Employees who have not completed three months of service as defined or have not been credited with at least 1,000 hours of service at the end of the twelve months period beginning on the date of hire.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the Chief Executive Officer of the Company. The Plan Administrator is also one of the Plan’s Trustees.

CONTRIBUTIONS

Participants may elect to defer up to one hundred percent (100%) of their pre-tax eligible compensation into the Plan, not to exceed the maximum amount allowable by the Internal Revenue Code of \$19,500 for 2021. Participants can also elect to make Roth 401(k) contributions, which allows for after-tax contributions to be made. Roth 401(k) contributions are subject to the same pre-tax contribution limitations. Participants aged fifty (50) or older as of the last day of the plan year may elect to make “catch-up” contributions of up to \$6,500 for 2021. This limitation is an aggregate limit that applies to all deferrals made to this Plan, and to any other salary deferral plan. In addition, participants may also rollover amounts representing distributions from other qualified plans. Pursuant to an automatic enrollment provision, a participant’s earnings are automatically reduced and contributed to the Plan as of the enrollment date by three percent (3%) per year unless the participant makes a different election or opts out.

The Company can elect to make discretionary matching contributions equal to a uniform percentage of each tier of participants’ salary deferrals to a maximum of \$150. The amount of the discretionary percentage is determined by the Company each year. For 2021, the matching contribution was equal to 3% of the employees’ contributions. The Company made matching contributions of \$0 and \$17,458 to the Plan during the period January 1, 2022 thru June 3, 2022 and year ended December 31, 2021.

Effective January 1, 2016, each year, the Company can make discretionary profit-sharing contributions to the Plan. The Company did not make any profit-sharing contributions to the Plan during the period ended January 1, 2022 thru June 3, 2022 and year ended December 31, 2021.

PARTICIPANT ACCOUNTS

Each participant’s account is maintained by Minnesota Life Insurance Company (“Minnesota Life”) and is credited with the participant’s contributions, rollover contributions, as well as allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

The participant determines the percentage or amount of compensation to be deferred (subject to the limitations stated above) and directs the investment of their contributions into various investment options offered by the Plan.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

INVESTMENT OPTIONS

The Plan's investments are held by Minnesota Life Insurance Company. Participants direct the investment of their contributions into various investment options approved by the Plan.

VESTING

Participants are vested immediately in their contributions, rollover contributions plus actual earnings thereon. The Company's matching contributions vest with twenty percent (20%) after two years of service and twenty percent (20%) for each year of service thereafter. Participants are one hundred percent (100%) vested after six (6) years of credited service. For the purpose of vesting, participants will be credited with a year of service if they work 1,000 hours during a Plan year.

Participants are 100% vested in the Company's matching contributions if they are employed on or after their normal retirement age of sixty five (65) or if they terminate employment on account of death or disability or upon plan termination. If a participant is terminated prior to being fully vested in employer contributions, they will forfeit the amount in which they are not vested.

PAYMENT OF BENEFITS

A participant may elect to receive benefit payments upon termination of employment due to death, disability, retirement or other reasons. Upon termination of employment, a participant, or his or her beneficiary, may elect to receive a distribution of the participant's vested account balance in either a single lump-sum payment or partial withdrawals.

In-service distributions may be made from a participant's 100% vested account at any time upon or after the occurrence of the following events:

- Hardships, as defined in the Plan document, or
- Participant's attainment of age fifty-nine and a half (59 ½).

HARDSHIP WITHDRAWALS

The Plan allows participant withdrawals for hardship in accordance with the provisions of the Plan document. In addition, the participant will be prohibited from making any elective deferrals into the Plan for the six-month period following the date of the hardship distribution.

FORFEITED ACCOUNTS

At June 3, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$69, respectively. These accounts will be used to pay reasonable Plan expenses or to reduce future employer contributions. In 2021, employer contributions were reduced by \$1,230 from forfeited non-vested accounts.

RECENT LEGISLATION

In January 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2020 ("Secure Act") that contained the largest package of retirement system reform in over a decade. Many of the provisions of the SECURE Act are effective on January 1, 2021 and will require significant changes to plan administration and record keeping.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan for the period January 1, 2022 thru June 3, 2022, are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. *FASB ASC 205-30-25-2* states that liquidation is imminent, when either of the following occurs:

- i) A plan for liquidation has been approved by the Board of Directors and the likelihood is remote that the entity will return from liquidation.
- ii) A plan for liquidation is imposed by involuntary bankruptcy and the likelihood is remote that the entity will return from liquidation.

USE OF ESTIMATES

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by custodian and insurance company. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

EXCESS CONTRIBUTIONS

Contributions in excess of amounts allowed by the IRS are recorded as a deduction from net assets when distributed. There were no excess contributions during the year ended December 31, 2021.

PAYMENT OF BENEFITS

Benefit payments to participants are recorded when paid.

ADMINISTRATIVE EXPENSES

As provided in the plan agreement, administrative expenses of maintaining the Plan may be paid either by the Plan or the Company. Administrative expenses are paid from the assets of the Plan.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Accordingly, no Level 1 inputs were available to the Plan.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 3, 2022 and December 31, 2021.

Pooled separate accounts: Valued based upon the units of such pooled separate accounts held by the Plan at year end multiplied by the respective unit value. As of June 3, 2022 and December 31, 2021, pooled separate accounts held by Minnesota Life are valued at their "accumulation unit value" (AUV). The AUV is determined based on the net asset value (NAV) of shares of the underlying fund. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The assets within the pooled separate accounts include fixed maturity securities, equity securities and cash and cash equivalents. The underlying assets can generally be quoted in an active market. The Plan has no unfunded commitments related to the pooled separate accounts and redemptions and subscriptions are permitted daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes the valuation methodologies are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of June 3, 2022 and December 31, 2021:

NOTE 4 – GROUP ANNUITY CONTRACT WITH MINNESOTA LIFE INSURANCE COMPANY

In 2010, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawal and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.50 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not have a scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Investments at contract value as of June 3, 2022 and December 31, 2021 were valued at \$0 and \$2,142,405, respectively.

NOTE 5 – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES (UNAUDITED)

The Plan's investments were held by Minnesota Life Insurance Company, the Plan's trustees for the period January 1, 2022 thru June 3, 2022 and year ended December 31, 2021. The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

Certain information related to investments as disclosed in the accompanying financial statements, including investments held at June 3, 2022 and December 31, 2021 and net appreciation in the fair value of investments, interest and dividends for the period January 1, 2022 thru June 3, 2022, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Minnesota Life Insurance Company (the Trustee of the Plan).

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments include units of participation in pooled separate accounts and a guaranteed return fund account managed by Minnesota Life. Minnesota Life is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services is included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Fees incurred and paid by the Plan for custodial and administrative services amounted to \$35,613 for the year ended June 3, 2022. The Employer provides certain accounting and administrative services to the Plan for which no fees are charged.

NOTE 7 – TAX STATUS

The Plan has adopted the Minnesota Life Volume Submitter Profit Sharing Plan with CODA. The Minnesota Life Volume Submitter Profit Sharing Plan received a favorable advisory letter from the Internal Revenue Service (“IRS”) on March 31, 2014, stating that the Minnesota Life Volume Submitter Profit Sharing Plan is qualified, under the Internal Revenue Code (“IRC”) and, therefore, the related trust is exempt from taxation. The Plan has been amended since the aforementioned date of the advisory letter. However, the Plan administrator believes that the Plan is currently designed, and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the date of the financial statements.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Pursuant to the Asset Purchase Agreement entered with the third-party buyer as of November 30, 2021, with an effective date of December 6, 2021, assets of the Company were sold and transferred to a third party buyer and the Plan was terminated on December 31, 2021. When the Plan was terminated, the proportional interest of each participant vested one hundred percent (100%). After the required waiting period, the Participants had the option of rolling over their holdings in the plan into the new employer’s 401(k) plan in accordance with their eligibility rules, transfer the balance into their IRA or liquidate their investments.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan holds certain investments that each represents 10% or more of the total investments held by the Plan. As of December 31, 2021, the Plan had investments concentrated in two funds totaling \$4,408,876.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 14, 2024, the date the financial statements were available to be issued. There were no material subsequent events that require recognition or additional disclosure in the financial statements.
