### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Muskingum University Defined Contribution and Tax Deferred Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 1, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1, 2023 to October 1, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of October 1, 2023 and December 31, 2022, and for the period January 1, 2023 to October 1, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Disclaimer of Opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions is not reasonably determinable. Accounting principles generally accepted in the United States of America ("GAAP") require that these accounts and the related income and distributions be included in the accompanying financial statements.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audits of the Financial Statements**

Our responsibility is to conduct audits of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

NOTES TO FINANCIAL STATEMENTS

**Note 1. Description of Plan**

The following is a summary of certain provisions of the Muskingum University Defined Contribution and Tax Deferred Annuity Plan (the "Plan"). Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was a defined contribution plan with a salary deferral provision subject to Section 403(b) of the Internal Revenue Code ("IRC"). The Plan was sponsored by Muskingum University (the "Employer"), an exempt organization under Section 501(c)(3) of the IRC.

The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Employer had the right to amend or terminate the Plan under the provisions of ERISA. The Muskingum University Plan Governing Committee was responsible for oversight of the Plan, determined the appropriateness of the Plan's investment offerings and monitored investment performance.

Effective October 1, 2023, the Muskingum University Plan Governing Committee passed a resolution to merge the Plan into the Association of Independent Colleges and Universities of Ohio Multiple Employer Plan ("AICUO MEP"). Plan management instructed Teachers Insurance & Annuity Association of America and College Retirement Equities Fund (together, "TIAA-CREF"), the Custodian of the Plan, to terminate the custodial agreement and signed a participation agreement with the AICUO MEP. Total assets transferred from the Plan to the AICUO MEP was \$91,026,656.

**Contributions**

Employees were permitted to make elective deferrals under the universal availability requirements. Students who were employees at the University were generally not eligible to participate, as well as employees who normally worked less than 20 hours per week. Eligible participants who had completed one consecutive year of service, had over 1,000 hours of compensated time in the completed year and were age twenty-one or older were required to contribute a minimum 5% of pretax annual compensation, as defined in the Plan, and receive an employer contribution. Participants who had attained age 50 before the end of the Plan year or participants with 15 years of service or more were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Employer contributed a discretionary amount, as determined by the employer, to be allocated as a uniform percentage of compensation. For the period January 1, 2023 to October 1, 2023, the employer contribution was 7% of the participant's annual compensation. Contributions were subject to certain Internal Revenue Service ("IRS") limitations.

**Note 1. Description of Plan (Continued)**

**Participants' Accounts**

TIAA-CREF maintained an individual account for each participant. These accounts were credited with contributions and related earnings, and charged with an allocation of any administrative expenses. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. Participants elected to maintain their aggregate contributions in the investment funds. Separate accounting for each of the funds was made pursuant to the participant's designated election. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Notes Receivable From Participants**

Participant loans were issued directly from the participant's account. Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account. The loan interest rate was based on the prevailing rate of prime plus 1% at the time of the loan. Principal and interest were paid ratably through payroll deductions. As of December 31, 2022, the participants had loans totaling \$74,202.

Prior to 2020, participants could borrow from their accounts; however, the loans were administered by TIAA-CREF and transacted outside of the Plan. At December 31, 2022, these outside loan balances were \$4,886 and were secured by plan assets in the borrowing participants' accounts at 110% of the loan amount. As these loans were repaid, the collateral balance was reduced accordingly.

**Vesting**

Participants were at all times vested in all contributions and earnings thereon.

**Payment of Benefits**

On termination of service, a participant was able to elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, partial payments, installment payments or apply the value of his or her vested interest toward the purchase of an annuity contract. Elective deferrals were able to be distributed upon incurring a disability, attainment of age 59½, attainment of normal retirement age before severance of employment and on account of hardship.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Basis of Accounting (Continued)**

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The financial statements of the Plan do not include amounts related to certain investment contracts which became inactive prior to January 1, 2009. As contemplated in the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*, the Employer has made a good faith effort to determine the population of plan participants and has included amounts related to all known contracts in these financial statements. Accordingly, these financial statements are acceptable to the Department of Labor as part of the Plan's Form 5500 filing. However, because of the uncertainty involved in ascertaining all previous arrangements, it is possible that contracts may exist related to this Plan which have not been included in these financial statements and those amounts may be material. Accounting principles generally accepted in the United States of America require these amounts to be included in the financial statements.

**Investment Valuation and Income Recognition**

The Plan's investment in the benefit-responsive guaranteed investment contract is reported at contract value. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. All other Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Muskingum University Plan Governing Committee determines the Plan's valuation policies utilizing information provided by TIAA-CREF. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued and unpaid interest. When a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Note 2. Summary of Significant Accounting Policies (Continued)**

**Payment of Benefits**

Benefits are recorded when paid by the Plan.

**Administrative Expenses**

Certain expenses incurred by the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of plan loans are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation in fair value of investments.

To discourage short-term trading and to help protect the long-term value of certain funds, a redemption fee is charged equal to 2% of money transferred out of certain funds less than 60 days following the initial purchase date. Redemption fees imposed on these funds are paid by the affected participants.

The Plan has entered into a contract with TIAA-CREF that returns to the Plan, as a Plan asset, revenue that exceeds the amount required to operate the Plan. A revenue sharing credit of \$43,851 was earned by the Plan for the period January 1, 2023 to October 1, 2023 and is included in net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits. The revenue credit may be used either to (i) pay direct, reasonable and necessary expenses of the Plan which the Plan is allowed to pay or (ii) provide benefits for plan participants and beneficiaries in the form of revenue credits. The plan sponsor reviews the revenue credit to ensure appropriate usage and maintains a process for ensuring that the revenue credit is disbursed in a timely manner. The unused and unallocated balance at October 1, 2023 and December 31, 2022 was \$-0- and \$20,868, respectively.

**Subsequent Events**

The Plan has evaluated subsequent events through May 9, 2024, which is the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

The Plan estimated the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value were classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities.

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3 – Unobservable inputs in which little or no market data exists.

**Note 3. Fair Value Measurements (Continued)**

The following is a description of the valuation methodologies used for plan assets measured at fair value:

Non benefit-responsive ("NBR") investment contracts are reported at estimated fair value as determined by TIAA-CREF based upon the individual purchases and sales of individual contracts and the correlation between the contracts' crediting rate with the highest quality debt security yields, adjusted for contract liquidity. These are classified as Level 3.

The investment in the pooled separate account was held and managed by TIAA-CREF. The fair value of investments held in this account is based on its reported net asset value ("NAV") per share (or its equivalent) as a practical expedient, therefore, it has not been classified in the fair value hierarchy.

Included in registered investment companies are TIAA-CREF funds which are based on market quotations or prices from independent pricing services and are classified as Level 1. Also included are various CREF funds that are not available for sale on any securities exchange but whose underlying investments consist of equity securities and fixed income instruments. The valuation of these funds is based upon the daily quoted net asset value of shares held by the Plan and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in methodologies used from 2022 to 2023. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) The pooled separate account's value is principally derived from the market value appraisals of the underlying real estate holdings or other real-estate related investments. The TIAA general account provides this real estate fund with a liquidity guarantee to ensure there are funds to meet redemption, transfer or cash withdrawal requests.

**Note 4. Unaudited Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the TIAA-CREF has certified to the completeness and accuracy of all investments reflected in the statements of net assets available for benefits at October 1, 2023 and December 31, 2022, the related investment activity reflected in the statement of changes in net assets available for benefits for the period January 1, 2023 to October 1, 2023 and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 5. Guaranteed Investment Contracts**

The Plan had guaranteed investment contracts with TIAA-CREF, portions of which were considered to be benefit-responsive. Contributions were maintained by TIAA-CREF in a general, unallocated account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because portions of the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for these portions of the net assets available for benefits attributable to the guaranteed investment contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in these funds at contract value. Portions not considered to be benefit-responsive are reported at fair value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but is guaranteed to be between 1% and 3%. Such interest rates are reviewed on a monthly basis for resetting. In addition, the Board of Trustees of TIAA-CREF votes annually to determine if it will add a discretionary crediting interest rate to remain in effect for the remainder of the declaration year. Certain events may limit the ability of the Plan to transact at contract value with the issuer. However, the plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contracts were not deemed to be terminated as a result of the plan termination.

The guaranteed investment contracts did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6. Income Tax Status**

The Plan had been designed to qualify under Section 403(b) of the IRC. The terms of the Plan had been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan was required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of October 1, 2023, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 7. Party-in-Interest Transactions**

Certain Plan investments were managed by TIAA-CREF who also received administrative fees from the Plan. TIAA-CREF was the Custodian as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services were included in net appreciation or depreciation in fair value of investments, as they were paid through revenue sharing, rather than a direct payment.
