## Independent Auditor's Report

To the Benefits Committee of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Centauri, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 2, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the for the period January 1, 2023 through October 2, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Centauri, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 2, 2023 and December 31, 2022, and for the period January 1, 2023 through October 2, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

### Note 1—Description of Plan

The following description of the Centauri, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended and restated, for a more complete description of the Plan's provisions. Effective January 1, 2022 (Freeze Date), the Plan was frozen and restated so that no new participants or contributions are allowed in the Plan.

*General* – The Plan was established on January 1, 1999. The Plan is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As of January 1, 2021, the Plan covered all employees, except interns and Puerto Rico based employees, of Centauri, LLC (the Company or Plan Sponsor) and its wholly owned subsidiaries, Pacific Defense Solutions, LLC (PDS) and Integrity Technology Solutions, LLC. During 2022, PDS was merged into Centauri, LLC. There is no minimum age or length of service requirement to participate in the Plan.

Effective January 1, 2020, the Plan was amended to add Xebec Global Corporation (Xebec) and Dependable Global Solutions, LLC (DGS) as adopting employers. Accordingly, the employees of Xebec and DGS became eligible to participate in the Plan effective January 1, 2020. The Company also has several affiliated entities. Effective January 4, 2021, the Plan was amended to add several of the affiliated companies to the Plan as adopting employers. Those companies are The Design Knowledge Company (TDKC), Kord Technologies, LLC (Kord), and PreTalen, LTD (PreTalen). Accordingly, the employees of TDKC, Kord and PreTalen became eligible to participate in the Plan effective January 1, 2021. During 2022, TDKC and PreTalen were merged into Centauri, LLC.

Effective January 1, 2020, Chares Schwab Trust Bank was appointed directed trustee.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

*Plan Merger* – The Plan Sponsor was acquired by a wholly owned subsidiary of KBR, Inc. (KBR) in October 2020. Pursuant to a merger agreement dated September 22, 2023 between the Plan and two other plans that are sponsored by KBR subsidiaries, the Plan merged its net assets available for benefits of approximately \$241,878,000, effective October 2, 2023, as follows: 1) approximately \$233,622,000 to the KBRwyle Technology 401(k) Plan and 2) \$7,200,000 to the Kellogg Brown & Root, Inc. Retirement and Savings Plan. Additionally, Notes Receivable from Participants of approximately \$1,056,000 were merged into those plans on October 2, 2023.

The information summarized below represents provisions in the Plan prior to the merger.

*Participant Contributions* – Prior to January 1, 2022, participants could make salary deferral contributions, including “catch-up” contributions if they qualified, subject to the limitations of the IRC. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution.

*Company Contributions* – The Plan is a “Safe Harbor Plan”. Prior to January 1, 2022, the Plan Sponsor was required to match 100% of the first 4% of each participant's eligible compensation contributed to the Plan. Additionally, the Plan Sponsor had the option to make a discretionary profit-sharing contribution to the Plan, with the amount determined annually. Plan Sponsor discretionary profit-sharing contributions were allocated to participants based upon compensation, as defined in the Plan document. All participants in the Plan were eligible to receive the discretionary contribution, if any, provided they continued to work for the Plan Sponsor or adopting employer and receive compensation.

*Participants' Accounts* – Participants may have a Schwab Personal Choice Retirement Account (PCRA), which is a self-directed brokerage account or a “core” funds account, or both. Accounts are maintained for each

participant and each participant account includes the participants' salary deferral contribution, plus an allocation of the Plan Sponsor matching and discretionary contribution (if any) and plan earnings/losses, including realized and unrealized gains and losses on investments. Participant accounts are charged with an allocation of administrative expenses.

*Vesting* – Participants are immediately fully vested in their salary deferral and rollover contributions and the earnings thereon. Participants are also immediately vested in Plan Sponsor matching and discretionary profit-sharing contributions.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their eligible account balance, reduced by any outstanding loan balance. Participant loans require the employee to sign a promissory note for the face amount of the loan and interest and must be repaid, in most cases, within five years. The interest rate will be determined by the Plan administrator. Participant loans require that payments will be made through payroll deductions unless earnings for a pay period are not enough to cover the loan payment, at which point the employee will be responsible to make a payment. The participant may have only one loan outstanding. At December 31, 2022, interest rates ranged from 4.25% to 8.50%.

*Payment of Benefits* – Distributions to participants or their beneficiary are made after retirement, termination of service, death or disability. The Plan also provides for in-service distributions once a participant attains the age of 59 1/2. Generally, a participant may elect to receive (1) a lump-sum cash distribution (which is automatic for vested amounts up to \$5,000) or (2) installment payments not exceeding the assumed life expectancy of the employee and his or her beneficiary.

The Plan permits hardship distributions if certain conditions are met.

### **Note 2—Summary of significant accounting policies**

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

*Use of Estimates* – The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at fair value, net realized and unrealized appreciation and depreciation are reflected in the Statement of Changes in Net Assets Available for Benefits.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

*Payments of Benefits* – Benefits are recorded when paid.

*Administrative Expenses* – Administrative expenses of maintaining the Plan are paid by the Company and the Plan. Recordkeeping services for participant loans and distributions are paid by the Plan or by the account of the participant.

*Risks and Uncertainties* – The Plan utilizes various investment instruments, including mutual funds, a common collective trust, self-directed brokerage accounts, and interest-bearing cash funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits. Individual participants' accounts bear the risk of loss resulting from fluctuations in investment values.

### **Note 3–Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices available in active markets for identical assets or liabilities that the Plan has the ability to access on the reporting date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for instruments measured at fair value. There have been no changes in the methodologies used at October 2, 2023 and December 31, 2022.

*PCRA* – Securities within the PCRA are valued at closing price reported on the active market for which the individual securities are traded. Money market accounts are valued on a historical cost basis plus accrued interest which approximates fair value. Securities within the PCRA are classified within level 1 of the valuation hierarchy.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds

are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust* - Composed primarily of fully benefit-responsive investment contracts and is reported at fair value using net asset value (NAV) as a practical expedient. The stable value fund calculates NAV per share in a manner consistent with the measurement principles in FASB Accounting Standards Codification Topic 946 *Financial Services-Investment Companies*. Those measurement principles indicate that, in the determination of a stable value fund's NAV, the relevant measurement is net assets which include the fully benefit-responsive investment contracts held by the fund at contract value. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table provides the amount and corresponding level of hierarchy for the Plan's investments that were measured at fair value on a recurring basis.

The Morley Stable Value Fund (the Fund) is a common collective trust fund whose objective is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile and liquidity for benefit responsive payments. The Fund invests primarily in a variety of high-quality stable value investment contracts (the performance of which may be predicted on underlying fixed income securities), as well as cash and cash equivalents.

Participants ordinarily may direct either the withdrawal or transfer of all or a portion of their investment at contract value. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value. Plan management believes that the occurrence of events that would cause the Fund to transact at less than contract value is not probable.

Redemption is generally permitted daily. Individual participant redemptions for benefit payments and redemptions by participants to reinvest in options that do not compete with the common collective trust are generally permitted without restriction. Were the Plan to initiate a full redemption of the common collective trust, a twelve-month advance written notice is required.

### **Note 4–Tax status**

The Plan has adopted a non-standardized prototype pre-approved defined contribution profit sharing plan with the IRC Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated September 21, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of October 2, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or require disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2020.

### **Note 5–Information prepared and certified by the trustee**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information certified by Charles Schwab Trust Bank, the trustee, except for comparing such information certified by the trustee to information included in the Plan’s financial statements.

Charles Schwab Trust Bank has supplied the Plan administrator with a certification to the completeness and accuracy of all investment and notes receivable from participants information presented in the accompanying Statements of Net Assets Available for Benefits as of October 2, 2023 and December 31, 2022 and the Statement of Changes in Net Assets Available for Benefits for the for the period January 1, 2023 through October 2, 2023. Accordingly, Charles Schwab Trust Bank has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as of October 2, 2023 and December 31, 2022.
- Net appreciation in fair value of investments and interest and dividends for the period January 1, 2023 through October 2, 2023.
- Interest income on notes receivable from participants for the period January 1, 2023 through October 2, 2023.

### **Note 6–Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA.

As discussed in Note 1, the Plan was merged into other plans that are sponsored by subsidiaries of KBR, effective October 2, 2023.

### **Note 7—Related party and Parties-in-interest transactions**

Under ERISA rules related to 401(k) plans, transactions with related parties of the plan such as a plan sponsor, administrator, trustees or participant (Parties-in-interest) are considered either exempt or nonexempt from ERISA prohibited transaction provisions. Nonexempt transactions are subject to penalty taxes.

Certain Plan investments and the related transactions at December 31, 2022 and for the period January 1, 2023 through October 2, 2023 are invested in funds sponsored by Charles Schwab Trust Bank and Charles Schwab Bank. Transactions involving these investments are considered to be party-in-interest transactions for which statutory exemption exists under the Department of Labor Regulations. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

### **Note 8—Subsequent events**

The Plan has evaluated events through August 12, 2024 in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.
