Linen King 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Linen King 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical

requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, the Plan sponsor was acquired by HLSG Holdco, LLC (HLSG) on December 28, 2022. On June 23, 2023, HLSG management decided to merge the Plan into the Shelbyville Laundry, Inc. 401(k) Profit Sharing Plan and Trust effective October 1, 2023. All Plan assets were transferred to the Shelbyville Laundry, Inc. 401(k) Profit Sharing Plan and Trust on September 29, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Information Required by ERISA

The supplemental information, schedule of delinquent participant contributions for the period from January 1, 2023 through October 1, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental information, other than the information in the supplemental information that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental information related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

October 1, 2023 and December 31, 2022

Note 1 – Description of the Plan

Linen King (the Company or Employer) sponsored the Linen King 401(k) Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established for the benefit of the Company's employees, except for union employees and nonresident aliens. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was administered by the Company. Reliance Trust Company (Reliance) held the Plan assets. Transamerica Retirement Solutions LLC (Transamerica) maintained the records of the participant data. NOVA 401(k) Associates served as the third-party administrator of the Plan.

The Company was acquired by HLSG Holdco, LLC (HLSG) on December 28, 2022. On June 23, 2023, HLSG management decided to merge the Plan into the Shelbyville Laundry, Inc. 401(k) Profit Sharing Plan and Trust effective October 1, 2023. Plan assets in the amount of \$2,743,597 were transferred to the Shelbyville Laundry, Inc. 401(k) Profit Sharing Plan and Trust on September 29, 2023. Participants of the Plan became participants of the Shelbyville Laundry, Inc. 401(k) Profit Sharing Plan and Trust effective October 1, 2023.

Eligibility

Nonexcluded employees who had reached 18 years of age and had completed six months of service were eligible to participate in the Plan. Participants were automatically enrolled in the Plan on the first day of the quarter after satisfying eligibility requirements.

Contributions

Participants could contribute up to 90% of their compensation, as defined in the Plan document, as either pretax or Roth deferrals. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans.

Eligible employees were automatically enrolled in the Plan with a 3% deferral rate. Eligible employees who did not wish to participate in the Plan could affirmatively elect to opt out, or they could elect a different deferral percentage.

The Plan also provided for Employer matching contributions equal to 50% of deferrals up to 6% of a participant's compensation. Employer matching contributions were based on deferrals made each payroll period.

The Plan also provided for discretionary Employer nonelective contributions. Unless termination was due to death, disability, or retirement, participants must have been employed on the last day of the Plan year

and worked 1,000 hours during the Plan year to receive an allocation of Employer nonelective contributions. Employer nonelective contributions were allocated at the Employer's discretion with each participant constituting a separate classification. There were no Employer nonelective contributions for the period from January 1, 2023 through October 1, 2023.

Participants directed the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain limitations of the Internal Revenue Code (the Code).

Participant accounts

Each participant's account was credited with participant contributions, Employer matching contributions, and allocations of Employer nonelective contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in Employer contributions was based upon years of continuous service as follows:

<u>Years of service</u>	<u>Vesting percentage</u>
Less than two years	0%
Two, but less than three	20%
Three, but less than four	40%
Four, but less than five	60%
Five, but less than six	80%
Six years or more	100%

Participants automatically became 100% vested upon normal retirement (attainment of age 65), disability, or death. Participants who terminated for any other reason were entitled to the vested amount of their accounts.

Payment of benefits

Upon retirement, termination, or death, a participant, or his or her beneficiary in the event of death, could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants could take in-service distributions upon reaching age 59½. Upon termination, automatic distributions were required for balances of less than \$5,000. Automatic distributions above \$1,000 made without the participant's consent were rolled into an individual retirement account designated by Transamerica. The Plan allowed hardship withdrawals, subject to account balance limits and applicable laws.

Forfeitures

Forfeitures could be used to restore participant balances previously forfeited, to pay Plan administrative expenses, to reduce Employer contributions, or be allocated to participants. The Plan had unallocated forfeitures of \$0 and \$63,855 as of October 1, 2023 and December 31, 2022, respectively. For the period from January 1, 2023 through October 1, 2023, no forfeitures were utilized.

Administrative expenses

The Plan allowed certain administrative expenses to be paid from Plan assets. Investment expenses netted against investment income represent amounts associated with the net expense ratios of the investments in the Plan's fund lineup.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by Transamerica. See Note 4 for discussion of fair value measurements and Note 5 for contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

Contributions

Participant contributions, and the related Employer matching contributions, are recorded in the year in which the participant deferrals are withheld from compensation. Employer nonelective contributions are recorded as contributions once approved by the Company's management for the respective Plan year.

Payment of benefits

Benefit payments are recorded when paid. There were no benefits requested before the year-end that were not paid.

Subsequent events

The Plan administrator has evaluated subsequent events through August 15, 2024, the date the financial statements were available to be issued.

Note 3 – Information Certified by Reliance

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of October 1, 2023 and December 31, 2022;
- Net investment activity as shown in the statement of changes in net assets available for benefits for the period from January 1, 2023 through October 1, 2023;
- Investment information included in the footnotes as of October 1, 2023 and December 31, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used as of October 1, 2023 and December 31, 2022. During the period from January 1, 2023 through October 1, 2023, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds – Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Fully Benefit Responsive Investment Contract

The Plan held a stable value core option contract issued by Transamerica. This contract was considered a traditional fully benefit responsive investment contract and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Transamerica was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The effective credited interest rate was set semi-annually and was effective on January 1 and July 1. Contract charges could reduce this return. Although participants generally could withdraw assets from the contract, Transamerica could impose a hold period in the event of a full contract discontinuance or partial contract discontinuance. There was a 12-month redemption restriction and no unfunded commitments at the time of transfer to Shelbyville Laundry, Inc. 401(k) Profit Sharing Plan and Trust (see Note 1).

The Plan's ability to receive amounts due in accordance with the fully benefit responsive investment contract was dependent on Transamerica's ability to meet its financial obligations. Transamerica's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

In addition, certain events allowed Transamerica to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include:

- Plan termination
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer
- The sum of the contract account values at any time equals \$20,000 or less

No events were probable of occurring that might limit the ability of the Plan to transact at contract value with the issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6 – Related Party and Party-in-Interest Transactions

Certain administrative expenses, totaling approximately \$58,500, were paid by the Company on behalf of the Plan for the period from January 1, 2023 through October 1, 2023. The Company does not expect reimbursement from the Plan for these expenses. Certain administrative functions were performed by officers and employees of the Company. No officer or employee received compensation from the Plan for these services.

The investments were managed by Transamerica. These transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan are included in net appreciation in fair value of investments.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contribution portion of their accounts.

Note 8 – Tax Status

The Company adopted a preapproved defined contribution plan (the Preapproved Plan) sponsored by Nova 401(k) Associates, Inc. The Internal Revenue Service determined and informed the Preapproved Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Preapproved Plan was designed in accordance with the applicable sections of the Code. The Preapproved Plan's opinion letter was being relied on by the Plan. Plan management believed the Plan was designed and was being operated in compliance with the applicable requirements of the Code. The Plan administrator has indicated that it will take the necessary steps, if any, to maintain the Plan's tax-exempt status.

Note 9 – Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

Note 10 – Prohibited Transactions

During the period from January 1, 2023 through October 1, 2023, the Company inadvertently failed to deposit \$55,977 of participant contributions within the required timeframe as stated by the DOL. The DOL considers late deposits to be nonexempt prohibited transactions.
