**Independent Auditor's Report**

**Scope and Nature of the ERISA Section 103(a)(3)(c) Audit**

We have performed audits of the accompanying financial statements of Renegade Services Employee Savings 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 10, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

#### 1. Description of Plan

The following description of the Renegade Services Employee Savings 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all of the employees of RWLS, LLC dba Renegade Services (the Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established and began operations in 2018. The trustees of the Plan are individual officers of the Company not under the control of a corporate trustee. Minnesota Life Insurance Company is an agent for the trustees. Securian Financial provides recordkeeping services to the Plan pursuant to a services agreement with the plan sponsor, whereby Minnesota Life Insurance Company is authorized to act as an agent for the trustees to provide these services. Securian Financial Group, Inc. is the parent corporation of Minnesota Life Insurance Company. Securian Financial, as recordkeeper, is responsible for receiving, conducting, and recording these transactions. Securian does the asset valuation daily, processes trades, and performs reconciliation and reporting roles and is responsible for these assets.

Eligibility – Employees are eligible for participation in the Plan after completing six months of service and attainment of age 21 years. The Plan entry dates are the first day of each month upon which eligibility requirements are met. The Plan has an automatic enrollment provision.

Contributions – Under the Plan, the participant and the Employer are both allowed to make contributions. The participants are allowed to contribute a portion of their salary in pre-tax and Roth contributions to the Plan subject to those limitations provided for in Section 402(g) of the Internal Revenue Code.

The Employer has the option to make discretionary matching contributions, profit sharing contributions, and qualified non-elective contributions. During the periods ended October 10, 2023 and December 31, 2022, the Employer did not make contributions.

Forfeitures – Forfeitures are the non-vested portion of the Employer matching contributions of a terminated participant's account balance. These may be used to reduce matching contributions or to pay administrative expenses of the Plan. The Plan had no forfeitures in 2023 or 2022.

Participant Accounts – Each participant has one account that is credited with the participant's contributions, Employer matching contributions, and the earnings of the specific investment vehicles selected. Participants may self-direct their contributions to several investment vehicles, including mutual funds.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer discretionary accounts vest at a rate of 20% per year after the first year of credited service until fully vested after six years.

If a participant dies or becomes disabled, the participant's accrued benefit derived from Employer contributions becomes 100% vested without regard to the above schedule. In the event of full or partial termination of the Plan, an affected participant's rights to the accrued benefit shall be 100% non-forfeitable.

Payment of Benefits – Upon normal retirement age or death, a participant or beneficiary may receive a lump-sum distribution equal to the vested balance of the participant's account, or substantially equal installments over a period not to exceed the participant's lifetime or the joint lifetime of the participant and spouse. Participants may receive in-service distributions, including hardships, from their vested account balances. Distributions to terminated participants will be made as soon as administratively feasible and an automatic distribution will be made to those participants with a vested balance below \$1,000. Loans are not permitted under the Plan.

#### 2. Summary of Accounting Policies

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Benefits are recorded when paid.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the period. Actual results could differ from those estimates.

#### 3. Administration of Plan Assets

The Plan assets are held by the Trustee of the Plan. Employer and participant contributions are invested by the Trustee as directed by the participants. The administrative expenses associated with the third-party administrator for the Plan are paid directly by the employers. Other expenses associated with the Trustee of the Plan are paid by the participants. Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and recordkeeper as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

**5. Fair Value Measurements**

Financial Accounting Standards Board (FASB), *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 10, 2023 and December 31, 2022.

Pooled separate accounts consist of the assets of two or more participating entities and are maintained for the collective investment and reinvestment of assets contributed thereto. Investments in pooled separate accounts are valued on a per unit market value basis as determined by the issuer, which reflects the fair value of the investments comprising the separate pooled funds. Underlying investments of these pooled accounts include various mutual funds whose shares are valued at net asset value. Minnesota Life Insurance Company verifies that for the Pooled Separate Accounts there are no unfunded commitments, redemptions can be made daily, and there are no other restrictions or penalties.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Concentrations of credit risk exist if a number of investments are engaged in similar activities and have similar economic characteristics that could cause their ability to meet contractual obligations to be similarly affected by changes in economic or other conditions. The Plan has invested in a variety of financial instruments and investments involving diverse industries and geographic areas to mitigate exposure to credit risk.

Gains and losses (realized and unrealized) included in changes in net assets for the period above are reported in net appreciation (depreciation) in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

**6. Net Asset Value (NAV) Per Share**

Under the amended guidance of FASB ASU No. 2009-12, *Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)* (ASU 2009-12), entities are permitted, as a practical method, to estimate the fair value of investments within its scope using the NAV per share of the investment as of the reporting entity's measurement dates. The amended guidance also requires additional disclosures to better enable users of the financial statements to understand the nature and risks of the reporting entity's investments that fall under these rules.

In accordance with ASU No. 2009-12, the Plan expanded its disclosure to include the category, fair value, redemption frequency, and redemption notice period for those assets whose fair value is estimated using the net asset value per share or its equivalent for which the fair value is not readily determinable at October 10, 2023 and December 31, 2022. For the Plan, such assets include investments in pooled separate accounts.

**7. Plan Termination**

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

During the period ended October 10, 2023, the plan sponsor terminated and ceased all contributions to the Plan. Participant balances were rolled over into a Pooled Employer Plan (PEP).

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**9. Tax Status**

The Plan is operating under a prototype plan filed by Minnesota Life Insurance Company. The Plan administrator and Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan adopted the "uncertain tax positions" provisions of accounting principles generally accepted in the United States of America. The primary tax position of the Plan is its filing status as a tax exempt entity. The Plan determined that it is more likely than not, that its tax positions would be sustained upon examination by the Internal Revenue Service (IRS), or other State taxing authority. There were no penalties or interest recognized during the periods ended October 10, 2023 and December 31, 2022. The Plan is no longer subject to U.S. federal income tax examinations by federal taxing authorities for years before 2020.

**10. Related Party Transactions**

Certain Plan investments are shares of mutual funds that are managed by Securian Financial. Securian Financial is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the periods ended October 10, 2023 and December 31, 2022, fees that were paid by the Plan for the investment management services amounted to \$4,860 and \$6,119, respectively.

**11. Subsequent Events**

The Plan's management has evaluated subsequent events through August 13, 2024, the date which the financial statements were available for issue.



