To the Participants and Administrator of the

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the TSC Bank 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of October 20, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the period January 1, 2023 to October 20, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 20, 2023 and December 31, 2022, and for the period January 1, 2023 to October 20, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control-related matters that we identified during the audits.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the TSC Bank 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees except summer and/or seasonal employees of TriState Capital Bank (Company) and its wholly owned subsidiary, Chartwell Investment Partners, L.P. (Chartwell), who have attained the age of 21 or older. During the year ended December 31, 2022, the Company finalized an agreement resulting in the merger of the Company with Raymond James Financial. As a result of the merger, all the Plan assets were transferred to the Raymond James Financial, Inc. 401(K) plan on October 20, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute from 1% up to 84% of pretax annual compensation, as defined in the Plan. They may make Roth elective deferral contributions, which are subject to federal income taxes in the year of deferral. The Roth deferral and the earnings on the deferral are not subject to federal income taxes when distributed to the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan within 45 days after their eligibility date unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral set at 6% of eligible compensation, and their contributions are invested in a designated fund until changed by the participant. All employees eligible to participate in the Plan receive the nonelective employer contribution. Nonelective employer contributions are subject to approval by the compensation committee and are allocated to each participant's account as a percentage of their eligible compensation. There was a 3% nonelective employer contribution in 2023 and 2022. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants' Accounts - Each participant's account is credited with the participant's contribution and nonelective employer contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. A participant who terminates employment is entitled to a benefit with respect to employer contributions and earnings thereon based on the following vesting schedule:

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 reduced by their highest outstanding loan balance during the previous one-year period or 50% of their vested account balance. Notes receivable are secured by the balance of the participant's account and are required to be repaid through payroll deductions within five years, except those used in the purchase of a primary residence, which must be repaid within a period of no more than 30 years. Notes receivable bear interest at the prime rate at the time of the loan, plus one percent.

Payment of Benefits - On termination of service, including death, disability or retirement, a participant may elect to receive the value of the participant's vested interest in his or her account in the form of a lump-sum payout or have the payment paid as a direct rollover to another qualified plan. If the participant's vested account balance is less than \$5,000 on the valuation date coincident with or immediately following termination of employment, the Company may cash the entire account balance out of the Plan. If the participant's vested account balance is greater than \$1,000 but less than \$5,000 and the participant has not elected a lump-sum payout or a direct rollover, the Company has the option to roll over the balance to an individual retirement account (IRA) established by an IRA provider selected by the Company. Hardship distributions may also be granted in accordance with the guidelines of ERISA.

Forfeitures - At December 31, 2022, forfeited nonvested accounts totaled \$24,700. Forfeited nonvested accounts are used to reduce future employer contributions. Employer contributions were reduced by approximately \$76,000 for the period January 1, 2023 to October 20, 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by Plan management in the preparation of the accompanying statement of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid from Plan assets, while other expenses are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments. A Plan expense account is maintained to hold revenue sharing funds the Plan receives that are available to pay qualified Plan administrative expenses and total approximately \$168,000 in a non-allocated account at December 31, 2022. This balance was transferred to the Raymond James Financial, Inc. 401(K) plan as a result of the merger disclosed in Note 1.

NOTE 3 - CERTIFIED INVESTMENTS (UNAUDITED)

Certain information related to the investments and notes receivables from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at December 31, 2022, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the period January 1, 2023 to October 20, 2023, was obtained by Plan management from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this topic are described as follows:

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value.

Money Market and Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by employees or officers of the Company at no cost to the Plan.

NOTE 6 - TAX STATUS

The underlying standardized prototype plan has received an opinion letter from the IRS dated October 6, 2020 stating that the form of the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2020.
