## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators and Participants

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Visiting Physicians Association 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 2, 2023 (date of merger) and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through October 2, 2023 (date of merger), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 2, 2023 (date of merger) and December 31, 2022, and for the period from January 1, 2023 through October 2, 2023 (date of merger), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 - Description of plan:

The following description of the Visiting Physicians Association 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan sponsor was VPA, P.C. (VPA). The Plan was a defined contribution plan covering substantially all employees of VPA and certain participating and predecessor employers as named in the Plan Document (collectively the Company or Plan Administrator) who had completed at least two months of service and had attained age 18. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

To align participation under the two defined contribution plans sponsored by VPA, employees were transferred into, or out of, the U.S. Medical Management Savings Plan, renamed HarmonyCares 401(k) Plan (HarmonyCares 401(k) Plan). These are reflected on the Plan's Statement of Changes in Net Assets Available for Benefits within transfers. Employees whose balances were transferred became participants in the plan to which the assets were transferred, on or near the date that the balances were transferred.

The board of directors of the Company approved the merger of the Plan into the HarmonyCares 401(k) Plan. All of the Plan's assets were transferred on September 28, 2023 and the Plan was merged out of existence on October 2, 2023 (date of merger).

#### Contributions

Prior to merger out of existence, participants could contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically-enrolled participants had their deferral rate set at 3% of eligible compensation, increasing annually by 1%, until reaching 10%, and their contributions invested in a designated default investment fund until changed by the participant. The Company could make discretionary matching and/or profit sharing contributions. For 2023, the Company made discretionary matching contributions of 100% of the first 2% of eligible compensation that a participant contributed to the Plan, amounting to \$460,816. No profit sharing contributions were made to the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Investment Options

Prior to merger out of existence, participants directed the investment of their contributions into various investments offered by the Plan. Participants could invest in various funds, each with different risk exposure and return potential. The Plan offered various mutual funds and a common collective trust fund as investment options for participants. Participants could also elect to invest in self-directed brokerage accounts. Participants could change their investment options daily.

Participant accounts

Prior to merger out of existence, each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Prior to merger out of existence, participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contributions and earnings thereon were based on years of continuous service.

Participants became vested in Company matching and profit sharing contributions in accordance with the following schedule:

#### Vesting - continued

Participants were immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Company. Forfeitures of terminated participants' non-vested accounts were used to reduce the Company's contributions for the plan year, or to pay Plan expenses.

#### Forfeitures

At October 2, 2023 (date of merger) and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$25,595, respectively. The forfeiture balance at the time of merger into the HarmonyCares 401(k) Plan was \$38,291. This amount was transferred into the HarmonyCares 401(k) Plan. During 2023, \$75,535 of forfeitures were used to reduce Company contributions.

#### Payment of benefits

Prior to merger out of existence, a participant was entitled to receive a lump-sum amount equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability, or death. A participant could request a withdrawal from the Plan while still under the employment of the Company for reasons of financial hardship, and the sources of the withdrawal were limited in accordance with Plan document.

For termination of service due to other reasons, and if the vested account balance exceeded \$1,000, a participant could elect to receive a lump sum distribution or to remain in the Plan. If the vested account balance was less than \$1,000, the Plan Administrator would distribute the participant's entire vested account balance as a lump-sum distribution as soon as administratively feasible.

#### Notes receivable from participants

Prior to merger out of existence, participants could borrow from the Plan in any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms were for a period not exceeding five years unless for the purchase of a principal residence, in which case the note repayment period could be longer. Notes were secured by the balance in the participant's account and bore interest at an agreed-upon percentage based on prevailing market rates. Principal and interest was paid ratably through payroll deductions. Participants were allowed one outstanding note.

#### Administrative expenses

Prior to merger out of existence, certain expenses of maintaining the Plan, including audit fees, were paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Common collective trust fund

Investments in the common collective trust fund were required to be reported at fair value. The common collective trust fund was composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts were not considered fully benefit-responsive to the Plan as the underlying contracts were not direct investments between the Plan and the issuer. The Plan elected to value the common collective trust fund using net asset value (NAV) as a practical expedient to determine fair value.

#### Investment valuation and income recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisors and Empower Trust Company, LLC (Empower).

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

#### Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded. If a participant ceased to make note repayments and the Plan Administrator deemed the participant note to be in default, the participant note balance was reduced and a benefit payment or deemed distribution was recorded.

#### Payment of benefits

Benefits were recorded when paid.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it was at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### Recent legislative developments

In December 2019 and December 2022, Congress passed the SECURE Act and SECURE 2.0 Act, respectively, which included numerous reforms to existing retirement law and allows plan sponsors to make certain immediate plan operational changes without formal amendment of the plan document. If adopted, plan documents are required to be formally amended in accordance with IRS guidelines. The Plan Administrator timely amended the plan for any applicable changes.

Subsequent events

The Plan has evaluated subsequent events through August 15, 2024, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of October 2, 2023 (date of merger), have been incorporated into these financial statements.

Note 3 - Investments and information certified by the trustee:

Empower was the trustee for the Plan from January 1, 2023 through October 2, 2023 (date of merger), and as of December 31, 2022. Empower held the Plan's investment assets and executed investment transactions. Management determined that Empower is a qualified institution and the information prepared and certified by Empower meets the requirements of ERISA Section 103(a)(3)(C). Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements at October 2, 2023 (date of merger) and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 through October 2, 2023 (date of merger), was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification No. 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value.

- Mutual funds (or shares of registered investment companies) are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Units of participation of the common collective trust fund are valued at the net asset value (NAV) provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.
- Self-directed brokerage accounts consist primarily of certificates of deposit that are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Certificates of deposit are classified as Level 2.

### Note 4 - Fair value measurements - continued:

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 - Plan termination:

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. The board of directors of the Company voted to merge the plan into the HarmonyCares 401(k) Plan. All of the Plan's assets were transferred into the HarmonyCares 401(k) Plan on September 28, 2023, and the Plan was merged out of existence on October 2, 2023.

Note 7 - Tax status:

The underlying non-standardized pre-approved plan received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan was qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust was tax-exempt. The Plan Administrator determined that it was eligible to and chose to rely on the most recent IRS pre-approved plan opinion letter. Once qualified, the Plan was required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan was being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
