### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Kyani, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended December 31, 2023 and 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

1. DESCRIPTION OF PLAN

The following description of Kyani, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all full-time employees of the Company who have completed three consecutive months of service following the employee's employment commencement date, have attained age eighteen, and are not considered an excluded employee. The Plan uses Unified Trust as the trustee.

Contributions

Employees are permitted to make salary deferral contributions to the Plan under a 401(k) arrangement up to the maximum allowable amount not to exceed limits of Code Section 401(k), 402(g), 404, and 415. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan does not permit participant nondeductible contributions.

The Company provides discretionary matching contributions based on compensation levels of each employee. The Company matched up to 4% of contributions for the year ended December 31, 2023.

The Company may also contribute a profit-sharing contribution determined annually at the discretion of the Company's management. The profit-sharing contribution, if any, is allocated to the participants' accounts based upon the participants' compensation as a percentage of the total. The Company has elected to not make profit-sharing contributions for the year ended December 31, 2023.

The Plan accepts qualified rollover contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, if any, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting of the Company's contribution portion of participant accounts is based on years of continuous service. A participant vests 20 percent per year starting after the second year of service and is 100 percent vested after 6 years of credited service. In addition, upon normal retirement at age 65, permanent disability, or death before retirement, the participant will be fully vested, regardless of years of service.

Forfeited Accounts

Forfeitures result from termination of employment before full vesting has occurred. Forfeitures are first used to reduce administrative expenses of the Plan, then any remaining forfeitures shall be applied to reduce discretionary Company matching contributions. Forfeitures of \$8,397 and \$17,604 were used to pay administrative expenses for December 31, 2023 and 2022, respectively. There were no forfeitures used to reduce discretionary Company matching contributions during 2023 and 2022. At December 31, 2023 and 2022, the balance of the forfeited unvested accounts totaled \$0 and \$4,215.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have two outstanding loans at a given time. The loans are secured by the balance in the participant's account.

Loan terms range from one to five years and bear interest at a rate comparable to local prevailing rates as determined by the Plan trustee. Principal and interest are paid ratably through monthly payroll deductions.

Loans are treated in default if any scheduled payment remains unpaid more than 90 days.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination, a participant with a vested Account Balance over \$5,000 may receive a distribution of the vested Account Balance in any form permitted. Account Balances with vested amounts under \$5,000 may receive a lump-sum distribution of the vested Account Balance. The Plan also provides for hardship distributions to participants who have not separated from service. Payment of benefits is recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's policy is to have its financial statements prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

Subsequent events were evaluated through August 12, 2024, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on observable market prices of the underlying investment within the fund less liabilities. The NAV for the underlying assets of the fund is readily determinable measure of their fair value and is the basis used by the fund for current transactions. The common collective trust assets are made up of target date funds, also known as lifecycle funds. These funds shift their asset allocation to become increasingly conservative as the target retirement year approaches.

#### 4. GUARANTEED INVESTMENT CONTRACT WITH TRUST COMPANY

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Unified Trust Company, N.A. ("UT"). UT maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at fair value with an adjustment to contract value in arriving at net plan assets available for benefits. Contract value, as report to the Plan by UT, represents contributions made on the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all of a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events included (1) amendments to the Plan documents (included complete or partial Plan termination or merger with another Plan) (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes significant withdrawal from the Plan, (4) the failure of the trust to qualify for

exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The estimated fair value of this investment contract was equal to the contract value for the years ended December 31, 2023 and 2022.

5. PLAN TERMINATION

Due to an acquisition of Kyani, Inc by Amare Global, Inc. the Plan was merged into a new plan sponsored by Amare Global. Net plan assets of \$3,343,48 were transferred to this new plan during the year ended December 31, 2022. Employees who held assets under the Kyani, Inc. 401(k) retirement plan were eligible to participate immediately.

6. TAX STATUS

The Plan has not obtained a determination letter from the Internal Revenue Service (“IRS”) stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the document sponsor by letter dated March 31, 2014, that the volume submitter Plan document and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax Counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related Trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United State of America (“GAAP”) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that it is no longer subject to income tax examinations for the years prior to 2020.

7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes a third-party administrator. Advising, record keeping, and broker fees were paid by the Plan in accordance with the Plan document. The Plan’s investments were held by Unified Trust Company, N.A., which is the custodian as defined by the Plan; therefore, these transactions, as well as forfeiture balances, qualify as exempt party-in-interest transactions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
