- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of LN & JN Investments LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about LN & JN Investments LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.



Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the LN & JN Investments LLC 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.



- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about LN & JN Investments, 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter

As discussed in Note 1, the Plan was merged with and into Parsons Corporation Retirement Savings Plan. The transfer of assets from the Plan occurred on October 31, 2023.

Notes to Financial Statements

October 31, 2023 and December 31, 2022

Note 1 Plan Description

Effective January 1, 2007, IPKeys Technologies, LLC established the IPKeys Technologies, LLC 401(k) Plan. IPKeys Power Partners, Inc. is a participating employer to the Plan.

During July 2022, in connection with the sale of IPKeys Technologies, LLC to another entity, IPKeys Technologies, LLC adopted a resolution whereby the participation by the employees of IPKeys Technologies, LLC in the IPKeys Technologies, LLC 401(k) Plan will terminate immediately before the sale. The account balances of employees of IPKeys Technologies, LLC were permitted to be transferred to the employee benefit plan of the entity that purchased IPKeys Technologies, LLC. Effective July 31, 2022, IPKeys Technologies, LLC 401(k) Plan was amended to continue with LN & JN Investments LLC (“Company”) as the new plan sponsor and to change the plan name to LN & JN Investments LLC 401(k) Plan (“Plan”).

In April 2023, IPKeys Power Partners, Inc. was acquired by Parsons Corporation. As a result of the acquisition a resolution was made to merge the Plan into the Parsons Corporation Retirement Savings Plan effective October 31, 2023. The Plan asset transfer amount includes assets in the amount of \$6,807,563 that transferred on October 31, 2023, and the investment in Key Guaranteed Portfolio Fund in the amount of \$96,675 which ultimately transferred in June of 2024 due to withdrawal restrictions. Also, in connection with the acquisition, contributions to this Plan ceased in July 2023.

The following description of the Plan provides only general information. Participants should refer to the Plan Document for more complete information of the Plan’s provisions.

General

The Company established the Plan to provide employees with a systematic means of savings and investing in the future. Regular full-time, hourly employees of the Company, as defined by the Plan Document, who have attained the age of 21 and completed one month of service are eligible to participate in the Plan. Part-time employees who complete 1,000 hours and have attained the age of 21 are also eligible to participate in the Plan. Deferrals begin on the first day of the month subsequent to enrollment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Company. The Plan’s Trustee is Great-West Life & Annuity Insurance Company. Effective August 1, 2022, Great-West Life & Annuity Insurance Company was renamed Empower Annuity Insurance Company of America. The Plan’s recordkeeper is Empower Retirement.

Note 1 Plan Description (continued)

Plan Contributions

Participants may contribute a certain percent of their base pay by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code (“IRC”) and other limitations to the Plan. The Plan is a safe harbor plan and may also make discretionary matching contributions. The safe harbor contribution equals 3% of a participant’s annual compensation, as defined in the Plan. During 2023, the Company made safe harbor contributions amounting to \$117,947. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants’ Accounts

Each participant’s account is credited with the participant’s contributions, allocations of the Company’s contributions, and Plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Vesting

Participants are 100% vested at all times in their voluntary contributions and the Company’s safe harbor contributions. Participants are vested for any employer discretionary matching contributions as follows:

Investment Options

Upon enrollment in the Plan, participants direct the investment of their contributions and the Company’s contributions into various investment options offered by the Plan.

Payment of Benefits

Upon termination of service due to retirement, disability, death, or termination of employment, a participant may elect to receive a lump-sum amount equal to the participant’s vested interest in their account or, at the participant’s election, in annual installments, as defined by the Plan. In-service distributions and hardship withdrawals are also permitted by the Plan.

Note 1 Plan Description (continued)

Notes Receivable from Participants

Participants may borrow from their account balances with interest charged at a rate 1.000% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Loan terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence. The minimum loan is \$1,000 and the maximum loan is the lesser of \$50,000 or 50 percent of the participant's vested account balance.

The loans are secured by the balance in the participants' account. Principal and interest are paid ratably through payroll deductions. Participants may only have one loan outstanding at any time. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Forfeitures

Forfeitures resulting from the non-vested portions of accounts of participants who terminate employment prior to being fully vested are used to pay plan expenses, reduce any nonelective contribution or reduce any matching contribution. At December 31, 2022, forfeited non-vested accounts totaled \$5,702.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value; see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are measured on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the ten-month period ended October 31, 2023.

Note 2 Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. Delinquent notes receivable from participants are reclassified as a distribution based on the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain of the Plan's administrative expenses are paid by the Company and are excluded from the Plan's financial statements. Certain fees related to the administration of participant accounts are charged directly to the respective account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments.

Note 3 Fair Value Measurement

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 3 Fair Value Measurement (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at October 31, 2023 and December 31, 2022.

The following is a description of the valuation methodology used for assets measured at fair value:

- **Mutual funds:** Valued at the daily closing price as reported by the Fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 Information Prepared and Certified by the Plan's Trustee

The following is a summary of the investment information regarding the Plan as of October 31, 2023 and December 31, 2022, and for the ten-month period ended October 31, 2023, included in the Plan's financial statements, that was prepared or derived from information provided by Empower Annuity Insurance Company of America, the Trustee of the Plan, and furnished to Plan management. Plan management has obtained certifications from the Trustees that such information is complete and accurate.

Note 5 Insurance Company General Account

The Plan entered into a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America. The Key Guaranteed Portfolio Fund is a guaranteed interest account provided through a group annuity contract. It is a non-tradable obligation of Empower Annuity Insurance Company of America. The investment contract or proceeds cannot be assigned or sold to another party without the consent of Empower Annuity Insurance Company of America. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Empower Annuity Insurance Company of America. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable, for example, a significant decline in creditworthiness of Empower Annuity Insurance Company of America, the Key Guaranteed Portfolio Fund investment choice may no longer be considered fully benefit-responsive.

The interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate and prevailing market conditions. The effective guaranteed crediting interest rate is set on a quarterly basis. The guaranteed rate of interest will not change during the four-month period for which it is effective.

Note 5 Insurance Company General Account (continued)

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield interest rates were approximately 1.23% and 0.93% for the ten-month period ended October 31, 2023 and the year ended December 31, 2022, respectively. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the four-month period. There is no stated minimum or maximum interest rate for the stable value option investment choices. Generally, there are no events that could limit the ability of the Plan to transact at contract value with the issuer or the participants. There are also no events that allow the issuer to terminate the contract, and which require the plan sponsor to settle at an amount different than contract value.

Note 6 Tax Status

IPKeys Technologies, LLC 401(k) Plan was an adoption of the Great-West Trust Company, LLC Pre-Approved Non-Standardized Profit-Sharing Plan with Cash or Deferred Arrangements (“CODA”) which received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020 stating that the Pre-approved Plan and related trust are designed in accordance with the provisions of the IRC. Effective July 31, 2022, the Plan is an adoption of the Empower Retirement LLC Non-Standardized Pre-Approved Profit-Sharing Plan with Cash or Deferred Arrangements (“CODA”) which received an opinion letter from the IRS dated November 14, 2022 stating that the Pre-approved Plan and related trust are designed in accordance with the provisions of the IRC. The Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 7 Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Plan provides that the amounts in each participant's account will be fully vested and distributed in accordance with the provisions of the Plan and in compliance with all applicable regulations. The Plan merged into the Parsons Corporation Retirement Savings Plan effective October 31, 2023.

Note 8 Party-In-Interest Transactions

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 2, certain fees related to the administration of participant accounts are paid from Plan assets. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions.

Certain plan investments are managed by Empower Annuity Insurance Company of America, the Plan's Trustee, and therefore these transactions qualify as party-in-interest transactions.

The Plan makes loans to participants and therefore, these transactions qualify as a party-in-interest.

Note 9 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 Subsequent Events

The Plan has evaluated subsequent events through August 15, 2024, the date on which the financial statements were available to be issued.
