## INDEPENDENT AUDITOR'S REPORT

To the Members of the Board of Directors

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 27, 2023 and for the period from January 1, 2023 through December 27, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Terminating Plan***

As further discussed in Note 1 to the financial statements, Wildflower Court, Inc.'s Board of Directors, the Plan's sponsor, voted on June 29, 2023 to terminate the Plan effective July 9, 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing Plan basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of Wildflower Court Retirement Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's provisions.

General

The Plan was initially effective in January 1992 and was restated effective August 1, 2016. The Plan is a defined contribution plan for employees of Wildflower Court, Inc. (the Organization), a nonprofit organization, who have at least six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

On June 29, 2023, the Wildflower Court, Inc. Board of Directors made a motion and approval to terminate the Plan effective July 9, 2023, at which time all employees and employer contributions into the Plan ceased. Upon termination of the Plan, all participants became 100% vested in their account balances. Participant balances were distributed to participant IRA accounts or the participant's current employer's plan. All balances were distributed by December 27, 2023. The below provisions were in effect prior to the termination.

Contributions

Each year, participants may contribute up to the legal limit of pretax annual compensation as defined in the Internal Revenue Code. Participants may also make rollover contributions representing distributions from other qualified plans. The Organization may make discretionary matching contributions equal to a uniform percentage to be determined each year by the Organization and has the option to make yearly profit-sharing contributions. Each year the Organization will make the required 3% safe harbor contribution based on the employee's eligible compensation. An employee will become eligible for employer matching, safe harbor, and profit-sharing contributions after completion of six months of eligible service. Participants direct the investment of their contributions into various investment options offered by the Plan including money market and mutual funds.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (1) the Organization's contribution and (2) Plan earnings. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their participant account a maximum of the lesser of 50% of their vested account balance or \$50,000. Loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 9.25%, which are commensurate with local prevailing rates as determined quarterly by the associated custodian. Loans must be repaid within a five-year period, except for loans used to acquire or construct a dwelling, which is or will be used as the participant's principal residence.

Payment of Benefits

Distributions from the Plan are made when a participant retires, dies (in which case, payment shall be made to his or her beneficiary, or if none, his or her legal representatives), becomes disabled, or otherwise terminates employment with the Organization. Hardship withdrawals are permitted

under certain circumstances. Participants should consult the Plan agreement for detailed information concerning distribution options.

Vesting

Participants are vested immediately in their deferral contributions, employer matching contributions and safe harbor contributions plus actual earnings thereon. A participant's interest in the Organization's profit sharing fully vests when the participant (a) attains normal retirement age, as defined in the Plan document, (b) completes five years of service, (c) dies or (d) becomes totally and permanently disabled. Upon termination of a participant's employment for any other reason, the participant's interest in the employer profit sharing contribution is vested in accordance with the following schedule:

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

As discussed in Note 1, the Plan was approved to be terminated effective July 9, 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan uses the liquidation basis of accounting in the financial statements for the period January 1, 2023 to December 27, 2023.

Investment Valuation and Investment Income

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are valued at their unpaid principal balance, plus accrued interest. No allowance for doubtful accounts has been recorded as all notes receivable from participants are deemed collectible. If a loan becomes delinquent it is treated as a deemed distribution to the participant.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to certain administration items, including notes receivable from participants, are charged directly to the participant's account, and are included in

administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

The Plan allocates forfeitures of terminated participants' non-vested accounts to the employer match. Forfeited nonvested accounts totaled \$-0- and \$5,875 at December 27, 2023, and December 31, 2022, respectively. Forfeited accounts will be applied to reduce employer contributions.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 3 – FAIR VALUE MEASUREMENT**

FASB ASC 820, Fair Value Measurements and Disclosure, defines fair value as the exchange price that would be received on the measurement date to sell an asset, or the price paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. FASB ASC 820 also establishes a three-level fair value hierarchy that describes the inputs that are used to measure assets and liabilities. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 27, 2023, and December 31, 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market:* Valued at accumulated cash contributions plus accrued interest.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held no assets on December 27, 2023. The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2022, segregated by the level of the valuation inputs within the fair value hierarchy utilized to measure the fair value:

**NOTE 4 – INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 27, 2023 and December 31, 2022, and investment income for the period January 1, 2023 through December 27, 2023, that is disclosed in the accompanying financial statement, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Ascensus Trust Company, the certifying custodians of the Plan.

**NOTE 5 – TAX STATUS**

The IRS has determined and informed Wildflower Court, Inc. by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in

compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations preceding the three-year statute of limitations.

**NOTE 6 – TRANSACTIONS WITH RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Vanguard Group, Inc. has retained Ascensus, LLC, Ascensus Trust Company's parent company, as a sub-contractor to provide certain recordkeeping and administrative services on behalf of Vanguard. Ascensus is not affiliated with Vanguard or any of its affiliates. Ascensus Trust Company is the custodian as defined by the Plan. Transactions with Vanguard and Ascensus, LLC, and Ascensus Trust Company qualify as party-in-interest transactions. In addition, Wildflower Court, Inc. has contracted with Kestra Advisory Services to provide consulting services in regard to Plan investments, which qualify as party-in-interest transactions. Fees paid by the Plan for all services amounted to \$40,358 for the year ended December 27, 2023.

**NOTE 8 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported on the statement of net assets available for benefits.

**NOTE 9 – SECURE 2.0**

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.
