To Whom It May Concern: Please take this letter as a Sworn Statement of Reasonable Cause for the failure to file the above- mentioned returns. The following statement is made under penalties of perjury, as required under Section 2560.502c2 (e).

Hwashin America Corporation was unaware of the Federal Form 5500 requirement for group insurance. We have correctly filed the 401(k) Plan 5500's each year. As soon as we discovered this requirement, which was brought to our attention by our consultant, we took immediate action.

To my knowledge, the Company did not receive any late notices. We are complying with this requirement under the DOL Delinquent Filer Voluntary Correction Program. The Company has updated its engagement with Murfee Meadows, Inc., to include all future Forms. We have the data collected and will process all delinquent 5500's as soon as possible. The 2023 Form5500 will be filed within the allowed required date.

Please accept this failure to file occurrence as a one-time mistake. The Company has never had an issue filing Form 5500's prior to this incident and has made appropriate changes to its internal control environment to ensure this mistake is not repeated in the future. Based on the changes made to the Company's internal control environment to prevent this error from recurring, the Company's past filing history, and based on the Company's prompt response, we request all penalties to be abated.
