## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of WAGI 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 29, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended December 29, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 29, 2023 and December 31, 2022, and for the period ended December 29, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Other Matter**

As discussed in Note 1 to the financial statements, the Plan merged into the GI Alliance Management Company 401k Savings Plan effective January 1, 2023. The Plan assets were not transferred to the GI Alliance Company 401k Plan until December 29, 2023.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1. Description of the Plan**

The following description of the WAGI 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General:

The Plan was established February 28, 1973 and benefits the employees of Washington Gastroenterology PLLC and the following affiliated entities (collectively referred to the Plan Sponsor): Western Washington Endoscopy Center, LLC and the Eastside Endoscopy Center, LLC. The affiliated entities are participating employers in the Plan as a member of an affiliated service group within the meaning of Internal Revenue Code (IRC) section 414(m).

Employees must be twenty years of age and have completed one year of service, at which point the employee becomes eligible to enter the Plan and will be automatically enrolled unless the employee opts out or elects a different deferral amount. All employees covered by a collective bargaining agreement, leased employees, or non-resident aliens are not eligible to participate in the Plan. Eligible employees may enter the Plan at the beginning of each quarter following meeting the eligibility requirements.

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law, which provides both required and optional future enhancements to tax qualified retirement plans and their participants. The provisions of the SECURE 2.0 Act may be effective and operationalized prior to formally amending the Plan document. The Plan has been timely implementing all required provisions as they become effective.

Plan Merger:

The Plan Trustees of WAGI 401(k) Plan resolved to merge the Plan into The GI Alliance Management Company 401k Savings Plan effective January 1, 2023. As such, effective January 1, 2023 all eligible participants began participating in the The GI Alliance Management Company 401k Savings Plan and thus no participant deferrals were remitted to the Plan during 2023. The Plan provided proper notice to participants informing them of the transfer and related blackout period, and on December 29, 2023 the Plan transferred all assets into The GI Alliance Management Company 401k Savings Plan.

Contributions:

Upon meeting eligibility requirements, participants were automatically enrolled in the Plan with salary deferrals of 6 percent of eligible compensation with no automatic annual increase. Participants may elect to opt-out of automatic enrollment.

Each year participants may contribute pre-tax or Roth salary deferrals up to the maximum amount allowed by the Internal Revenue Code of annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Sponsor may contribute a discretionary matching contribution. For the period ended December 29, 2023, the Sponsor made no discretionary matching contributions.

The Plan allows safe harbor contributions and a discretionary profit sharing contributions. No such contributions were made for the period ended December 29, 2023.

Participant Accounts and Investment Options:

Contributions to participant accounts were deposited into participant-directed funds at John Hancock Life Insurance Company. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor periodically reviews the investment fund options available to participants and drops or adds investment funds as warranted.

Each participant's account is credited with the participant's contribution and allocation of the Sponsor's annual contribution, Plan earnings, and charged with an allocation of maintenance fees. Allocations are based on participant compensation or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Notes Receivable:

Participants may borrow from their accounts a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer between investment funds and the Participant Loan fund. The loan repayment period is up to five years, or more if for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 1 percent over prime rate at the time of the loan initiation. Interest rates range from 4.25 percent to 9.50 percent at December 29, 2023. Principal and interest is paid ratably through payroll deductions. As of December 29, 2023, all loans were transferred to The GI Alliance Management Company 401k Savings Plan.

Vesting:

The participants are 100 percent vested in employee salary deferrals, rollovers, Sponsor safe harbor and qualified nonelective contributions, and the related earnings at all times. Vesting in the Sponsor's discretionary contributions and the related earnings is based on years of credited service. Generally, a participant is 100 percent vested after six years of credited service or upon retirement, death, disability, or termination of the Plan.

Forfeitures:

Forfeitures of terminated participants' nonvested account balances can be used to reduce the Plan's administrative expenses for the plan year or reduce the Sponsor's contributions.

Nonvested account balances forfeited into the Plan for the period ended December 29, 2023 and year ended December 31, 2022, were \$22,250 and \$64,712, respectively. During 2023, \$51,239 was used to pay Plan expenses.

Payment of Benefits:

A participant's normal retirement age is 62. An individual ceases to be a participant upon retirement, death or permanent disability. Upon termination of service a participant may elect to leave their vested account balance invested in the Plan or receive a lump-sum amount equal to the value of his or her account. Additionally, the Plan allows for in-service withdrawals as defined by the Plan.

**NOTE 2. Summary of Significant Accounting Policies**

Basis of Presentation:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America and present the net assets available for Plan benefits and the changes in those net assets.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments were held in participant directed accounts at John Hancock Life Insurance Company. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends, if any, are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan documents.

Payment of Benefits:

Benefits are recorded when paid.

Administrative and Investment Management Expenses:

The Plan's expenses were paid either by the Plan or Plan Sponsor, as determined by the trustees, plan document, or service provider agreements. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements and are not intended to be reimbursed by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**NOTE 3. Concentration of Credit Risk**

The Plan was exposed to market and credit risk due to the various foreign and domestic investment securities that may be selected by the participant in any combination. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 4. Information Certified by the Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified as complete and accurate as of December 29, 2023 and December 31, 2022, and for the period ended December 29, 2023 by John Hancock Life Insurance Company as follows:

- Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 29, 2023 and December 31, 2022.
- Net appreciation in fair value of investments, and interest income from notes receivable from participants reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the period ended December 29, 2023.

**NOTE 5. Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 29, 2023 and December 31, 2022.

*Pooled Separate Accounts:* The value of each pooled separate account is stated at net asset value as provided by John Hancock Life Insurance Company. Realized and unrealized gains and losses from the assets in the pooled separate accounts are credited to or charged against the accounts without regard to other income, gains or losses of John Hancock Life Insurance Company. In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques and inputs is appropriate and consistent with other market participants, the use of different techniques and inputs or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6. Party-in-Interest Transactions and Administration of Plan Assets**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee organization, or a relative of such persons mentioned.

The Plan's investment options were held in participant directed accounts at John Hancock Life Insurance Company, the custodian of the Plan; therefore, any transaction executed with John Hancock Life Insurance Company qualifies as a party-in-interest transaction.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activities to various service providers. These transactions are party-in-interest transactions.

The Plan Sponsor is a party-in-interest. Certain administrative functions are performed by employees of the Sponsor. No such employee receives compensation from the Plan. The Sponsor has the discretion to appoint or remove any trustee or agent of the Plan. The Trustees have the full power to administer the Plan and apply all of its provisions on behalf of the Sponsor.

**NOTE 7. Tax Status**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Definiti, LLC. and received a favorable opinion letter dated June 30, 2020. Although the opinion letter is not specific to the Plan, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code; therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and has taken no material uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.
