NOTES TO FINANCIAL STATEMENTS JANUARY 31, 2019 AND DECEMBER 31, 2018

1. DESCRIPTION OF PLAN

The following description of the Hy-Pro Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan by Hy-Pro Corporation (the Employer or Plan Sponsor), which includes a salary reduction feature that meets the requirements of section 401(k) of the Internal Revenue Code (IRC), and covers employees of Hy-Pro Corporation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2017, the Plan Sponsor was acquired by another company. In anticipation of the merger of the Plan with another qualified retirement plan, the Plan was frozen effective December 31, 2018, and no further contributions were made to the Plan for plan years beginning after December 31, 2018. All assets of the Plan were liquidated and merged into another qualified retirement plan effective January 14, 2019.

Contributions

Prior to January 1, 2019, eligible employees could defer a portion of their annual compensation, as defined in the Plan, up to the maximum amount allowable by the IRC. These contributions could be made through a combination of pre-tax contributions (traditional 401(k)) and after-tax contributions (Roth 401(k)). Participants could also contribute amounts representing qualified rollover distributions from other qualified plans. Prior to the Plan being liquidated and merged, the Plan allowed for a matching contribution as determined by the Employer.

Participant Accounts

Each participant's account is credited with the participant's contributions and Employer's matching contributions, as well as allocations of the Plan's earnings and administrative expenses. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account. Participants can direct the investment of their contributions and their respective allocation of the Employer's contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (or losses) thereon. Vesting in the Employer's matching contribution portion of their accounts plus actual earnings (or losses) thereon is based on year of service, as defined. Participants vest on a graduated schedule and become fully vested after six years of credited service. If not already vested, a participant becomes fully vested upon the occurrence of the participant's attainment of Normal Retirement Age, death while employed by the Employer, or satisfying the requirements for Disability Retirement.

Payment of Benefits

Upon termination of service due to attainment of Normal Retirement Age (as defined), death, disability, or other reasons, a participant could have elected to receive a lump-sum distribution equal to the value of the Participant's vested interest in his or her account, have the balance rolled over to an eligible retirement plan, or leave the funds in the Plan for distribution at a later time. The Plan allowed for in-service distributions and hardship distributions subject to certain restrictions as defined by the Plan document.

Forfeited Accounts

Upon termination of employment and distribution of a participant's entire vested account balance for any reason other than death, disability, or attainment of Normal Retirement Age, the Employers' contributions on their behalf, not then vested, are transferred to a forfeiture account. Forfeited accounts are used to pay administrative expenses of the Plan, or to reduce the Employer contributions. At January 31, 2019 and December 31, 2018, there were no forfeited non-vested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

All assets of the Plan were liquidated and merged into another qualified retirement plan effective January 14, 2019. Current accounting standards require the liquidation basis to be applied when liquidation is deemed to be imminent before year end and accordingly revalue assets to amounts expected to be paid during liquidation. The revaluation, and thus application of the liquidation basis compared to the accrual basis, did not have a significant effect on these financial statements.

Estimates

The preparation of the financial statements in conformity with the liquidation basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

American United Life Insurance Company (AUL) maintains the Plan's investment funds. Investments in pooled separate accounts are credited with earnings and gains or losses on the pooled investments. The separate accounts are stated at fair value as reported to the Plan by AUL, based on the quoted prices of the underlying mutual funds.

Purchases and sales are recorded on a trade-date basis. Interest and dividends are recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Contract with Insurance Companies

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Investment contracts held by the Plan are not deemed fully-benefit-responsive investment contracts. The fair value of investment contracts held by the Plan are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Risk and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets in liquidation available for benefits.

Notes Receivable from Participants

Prior to termination of the Plan, notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document. The notes were due through 2042 and bore interest at 8.0%. No allowance for credit losses has been recorded as of January 31, 2019 or December 31, 2018. If a participant ceased to make repayments and the plan administrator deems the note to be in default, the note balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Expenses of the Plan

The Plan Sponsor provides administrative and accounting services to the Plan at no cost. The majority of the Plan's expenses including certain administrative expenses and accounting fees are paid directly by the Plan Sponsor. Certain investment and other advisory related expenses are included in administrative expenses.

Subsequent Events

Subsequent events were evaluated through August 2, 2024, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets in liquidation available for benefits as of January 31, 2019 and December 31, 2018, and related investment activity reflected in the statement of changes in net assets in liquidation available for benefits for the plan period from January 1, 2019 to January 31, 2019.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2019 and December 31, 2018:

- *Pooled separate accounts* – Investments in pooled separate accounts are credited with earnings and gains or losses on the pooled investments. The separate accounts are stated at fair value as reported to the Plan by American United Life Insurance Company, based on the quoted market prices of the underlying mutual funds. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate

account by the number of units in the separate account. The investment strategies for the pooled separate accounts vary based on the degree of risk chosen by the participants.

- *Investment Contracts* – The underlying investments are mostly guaranteed investment contracts or synthetic investment contracts issued by insurance companies. The incremental value of the contract itself is based on issuer ratings as determined by credit ratings, which are published by rating agencies and the present value of the change in each contract's replacement cost.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan's investments in investment contracts are considered Level 2 investments.

5. TAX STATUS

The Plan is based on a volume submitter plan which has received a favorable opinion letter from the Internal Revenue Service stating that the volume submitter plan is designed to qualify as being exempt from Federal income taxes. The Plan Sponsor has not separately applied for a determination letter from the Internal Revenue Service. However, the Plan Sponsor believes that the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code, and therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's tax returns are subject to routine examination by the appropriate regulatory authorities. However, as of the date the financial statements are available to be issued, there were no audits for any tax periods in progress.

6. PARTIES-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others.

American United Life Insurance Company is the custodian of the Plan, and receives payments for contract administrative services as well. Blue & Co., LLC is the independent auditor for the Plan and receives payment from the Plan Sponsor for its services.

7. RISKS AND UNCERTAINTIES

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets in liquidation available for benefits.

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.

The investment company, the underlying investment portfolio, and the annual compensation percentages are shown below.
