### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Breakwater Energy Partners, LLC 401(k) Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of May 5, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended May 5, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of April 30, 2023 and December 31, 2022, and for the period ended April 30, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**Note 1 - Description of the Plan**

The following description of the Breakwater Energy Partners, LLC 401(k) Plan ("Plan") provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

General

The Plan, originally effective on May 1, 2019, was a qualified retirement plan adopted to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was recently restated to comply with various changes in the tax laws. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Select Energy Services acquired Breakwater Energy Partners, LLC ("Company") through a stock-for-stock transaction. Effective May 1, 2023, the Plan was merged into the Select Energy Services, LLC 401(k) Plan. On May 5, 2023, total assets of \$1,041,660, consisting of \$1,009,782 in investments and \$31,878 in notes receivable from participants, were transferred into the Select Energy Services, LLC 401(k) Plan.

Eligibility

Employees of the Company were eligible to participate in the Plan when they had completed two months of service. The entry date was the first day of the month coinciding with or next following the date they satisfied the service requirement.

Contributions

A participant could elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a salary deferral. There were two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Total deferrals in any taxable year could not exceed a dollar limit which was set by law. A participant at least age 50 or would attain age 50 before the end of a calendar year could elect to defer additional amounts called catch-up contributions to the Plan. A participant was permitted to modify or revoke their salary deferral election at any time during the plan year. A participant was also permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant accounts

Each participant's account was credited with the participant's contributions, employer contributions, and plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Participants were able to direct the investment of their interest in the Plan in any of several investment options. Participants could change their investment options among the various investment securities either through direct transfers from one security to another or by changing the percentage of future contributions allocated among the investment securities.

**Note 1 - Description of the Plan (Continued)**Vesting

Participants were always 100% vested in their salary deferrals, rollover contributions, and employer contributions plus actual earnings thereon.

Notes receivable from participants

Loans were available to participants on a reasonably equivalent basis. All loans were adequately secured and charged a reasonable interest rate. Generally, the term of the loan could not exceed 60 months; however, if the loan was for the purchase of a principal residence, the Company could permit a longer repayment term. The loan was limited to the lesser of \$50,000 or ½ of the participant's vested interest in the Plan. No loan in an amount less than \$1,000 would be made. The maximum number of plan loans that a participant could have outstanding at any one time was one.

Benefit payments

Participants were entitled to receive an in-service distribution. Generally a participant could receive a distribution from the Plan from certain accounts prior to termination of employment if they had attained age 59½ or incurred a financial hardship for certain immediate and heavy financial needs.

Participants could also receive a distribution of the vested portion of some or all of their accounts in the Plan for termination of employment, normal retirement, disability, or death. If the vested account balance did not exceed \$5,000, then the vested account balance was only distributed to the participant in a single lump-sum payment. If the vested account balance exceeded \$5,000, the participant had to consent to any distribution before it was made. The participant could elect to receive the distribution of their vested account balance in a single lump-sum payment, installments over a period of not more than their assumed life expectancy, or partial withdrawals. Benefits under the Plan were generally paid in cash.

**Note 2 - Summary of Accounting Policies**Basis of accounting

The financial statements of the Plan were presented on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") required the Company to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contribution to the applicable participants prior to March 15, 2023.

Payment of benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through July 19, 2024, the date the financial statements were available to be issued.

**Note 3 - Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at April 30, 2023 and December 31, 2022, and net appreciation in fair value of investments and dividends for the period ended April 30, 2023, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provided a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to fair value measurement. Valuation techniques maximized the use of relevant observable inputs and minimized the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common/collective trust - Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liability. **Note 5 - Related Party Transactions and Party in Interest Transactions**

All money contributed to, or equitably belonged to, the Plan was held in a trust fund. Reliance Trust Company used the trust fund's assets only for the exclusive benefit of the Plan's participants and beneficiaries. While all Plan assets were held in a trust fund, the Company separately accounted for each participant's interest under the Plan. The Plan also provided notes receivable from participants, which were party in interest transactions that were exempt from the prohibited transaction rules.

**Note 6 - Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7 - Tax Status**

The pre-approved plan adopted by the Company received its latest opinion letter dated October 6, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan had been amended since receiving the opinion letter, the Company believed that the Plan was designed, and was currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust fund was tax-exempt.

GAAP required the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
