Ladies and Gentleman,

My name is Jossie Norminton, I am 77 years old. Since 1992 I worked several jobs at my husband, Thomas M. Norminton's office.

We were very small, but in 2001 we started a 401K Plan and of course I became the Plan Administrator. I am proud to say that I never missed a filing.

In August of 2019, my husband became very ill rendering him incapacitated for the job almost immediately. His partner had retired in a previous year, and I was forced to close the business on my own.

I kept the original Plan Termination Distribution Forms that were submitted to Ascensus-Vanguard. Everyone in the plan chose an IRA at Vanguard, with the exception Ms. Kathleen Dority-Fuster who requested a check to be written to a broker's company named JPMS, LLC. Ascensus has all the records.

It was the most painful time in our lives, that same year I had a stroke. Then, Covid came in 2020, and I lost track of every part of my life. I became the full time caregiver for my husband. Then he had a stroke in 2022 and after a fall a craniotomy in 2023. I kept his Professional Corporation open hoping that one day he could do some work. I have lost all hope now, he was diagnosed with Alzheimer and dementia a few months ago.

Please advise me on what to do next. This was all an unintentional oversight and we cannot afford the potential penalties. I am still my husband's full time caregiver, which has become only more challenging and now the worry about this is consuming the little life I have left.
