As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 4, 2023 and December 31, 2022 and for the period January 1, 2023 through December 4, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

December 4, 2023 and December 31, 2022

(1) **Description of Plan**

The following description of BDS Solutions Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

(a) **General**

The Plan is a defined contribution plan sponsored by BDS Connected Solutions, LLC (the “Company”). The Plan was established effective January 1, 2000, with an Internal Revenue Code 401(k) provision covering substantially all employees of the Company. The Plan is subject to the provisions of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 16, 2022, the employer sponsoring the Plan changed their name from BDS Connected Solutions, LLC to Channel Partners Group, LLC.

Effective August 1, 2022, the Plan was amended and restated with the Lincoln non-standardized profit-sharing plan, Plan Adoption Agreement.

Effective March 26, 2023, the Plan was amended to allow employees acquired from Beam Team, Inc. to become eligible employees.

Effective December 4, 2023, the plan was terminated and transferred to Aon Pooled Employer Plan (“Aon PEP”), with all assets and loan balances of the participants being transferred from Lincoln Financial Group Trust Company, Inc to Voya Financial, the recordkeeper of the Aon PEP.

(b) **Eligibility**

Full-time and part-time employees may elect to participate in the Plan as of the first day of the calendar month after the service requirements have been met and an employee has attained 21 years of age. The service requirement is considered to be upon completion of a 60-day period of service for full-time employees, and upon completion of 12-month period of service using the Elapsed Time Method for part-time, temporary, and seasonal employees.

(c) **Contributions**

Participants may contribute up to 100% of their eligible compensation. Pre-tax and Roth 401(k) contributions are subject to Internal Revenue Service (“IRS”) limitations. A participant who has attained age 50 may also make catch-up contributions, subject to IRS limitations. Roth Deferrals are subject to federal income tax in the year of the deferral.

(c) **Contributions - Continued**

Employer matching contributions are discretionary. The Company elected to match of 50% of employee contributions up to a maximum of 3% of eligible compensation contributed to the Plan during the period January 1, 2023 through December 4, 2023.

The Plan also accepts rollovers and direct transfers from other tax-qualified plans.

(d) **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions from other qualified retirement plans, and an allocation of (a) Company matching contributions and (b) Plan earnings. Each participant's account is reduced by benefits paid to the participant and an allocation of investment loss and depreciation in the value of investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(e) **Forfeitures**

Terminated participants that are less than 100% vested in the Company's discretionary matching contribution portion of their account will forfeit the non-vested portion of their account. The forfeiture will occur in the Plan year in which the participant receives a distribution of the entire vested account. Forfeitures can be used to reduce future employer matching contributions or offset administrative fees. The Company did not use forfeitures to offset employer matching contributions for the period January 1, 2023 through December 4, 2023. There were approximately \$2,400 forfeited non-vested account balances as of December 31, 2022. Approximately \$40,000 of forfeited non-vested account balances were transferred to into the Aon Pep on December 4, 2023 (see Note 1(a)).

(f) **Vesting**

Participants are immediately vested in their own elective deferral contributions plus actual earnings thereon. Participants become vested in the Company's discretionary matching contribution and related earnings based on years of vesting service using the elapsed time method, as follows:

A participant whose account balance includes amounts transferred from the Apollo Retail Specialist, LLC 401(k) Plan as a result of the merger of such plans into the Plan shall vest in the participant's share of discretionary matching contributions and earnings and losses thereon in accordance with the following schedule:

2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

Regardless of vesting schedule, a participant will become fully vested upon reaching their normal retirement date (age 65), death, or retirement due to disability.

(g) Hardship Distribution

The Plan allows participants to withdraw a portion of their elective deferral account, rollover contributions, and the vested portion of the Company's discretionary matching contribution account in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to Plan provisions.

(h) Payment of Benefits

On termination of service due to death, disability, separation of service or retirement, a participant may elect to receive an amount up to the value of the participant's vested interest in his or her account. The remaining non-vested balance of the account, if any, shall be forfeited. Account balances under \$5,000 may be automatically distributed or the Participant may elect to rollover account balances to a qualified employer 401(k) plan.

The Plan allows participants to withdraw a portion of their account balance. Any hardship or in-service withdrawals are limited and must comply with respect to Plan provisions. Benefits are recorded when paid. Participants are limited to two in-service withdrawals in a given 12-month period.

(i) Notes Receivable from Participants

Participants may borrow from their accounts subject to limitations. Loan amounts must be at least \$1,000, with only one loan outstanding at a time. Loan terms range from one to five years or fifteen years if used to purchase a residence. The loans are secured by the balance in the participant's account with new loans issued bearing interest at Prime Rate plus one percentage point. Principal and interest are paid ratably through monthly payroll deductions.

(j) Investment Options

The Plan permits participants to direct the investment of their elective deferrals and Company discretionary matching contributions into various investments offered by the Plan. The investment options include a variety of mutual funds, and a guaranteed interest account. Fund investment allocation percentages may be changed by participants at any time.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and present the net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

(b) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

(c) Investment Valuation

The Plan's investments in mutual funds are stated at fair value based on quoted market prices.

The Plan offers participants the option to invest in the Lincoln Stable Value Account ("SVA"), a guaranteed interest account, which is a fixed annuity contract issued by Lincoln National Life Insurance Company and is considered a fully-benefit responsive investment contract. The SVA is backed by the general account issuing company; as such there are no specifically identifiable underlying assets. The SVA guarantees a fixed interest rate to participants with a minimum of 1%. The value of the SVA is recorded at contract value, which represents the amount participants would receive if they were to initiate a benefit-responsive transaction under the terms of the ongoing plan.

Withdrawals from the SVA to pay participant benefits are made at contract value. Certain events may limit the ability of the Plan to transact at contract value at which time a surrender charge is applicable and market value adjustment or withdrawals are made in installment payments only over a period of time as elected by the contract holder. The Company does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(d) Notes Receivable from Participants

The Plan's notes receivable from participants are stated in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Update 2010-25, *Reporting Loans to Participants by Defined Contribution Pension Plans* (ASU 2010-25). ASU 2010-25 requires participant loans to be measured at their principal balance plus any accrued but unpaid interest and to be classified as notes receivables from participants. Interest income related to notes receivable from participants has been separately presented as interest from notes receivable from participants. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 4, 2023 and December 31, 2022. If a participant ceases to make loan repayments, the loan balance is reduced, and a benefit payment is recorded.

(e) Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

(f) Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(3) Information Certified by Trustee (Unaudited)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln, the Plan's trustee, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Total investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2022;
- Total investment income, and related investment activity and interest from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period January 1, 2023 to December 4, 2023.

(3) **Information Certified by Trustee (Unaudited) - Continued**

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) **Tax Status**

The Plan has adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by Lincoln effective August 1, 2022. Lincoln received its latest opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the non-standardized pre-approved profit-sharing plan with CODA is qualified under Section 401(a) of the Internal Revenue Code, and therefore, the related plan is exempt from taxation.

The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 4, 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) **Parties-in-Interest**

Certain plan investments are shares of guaranteed interest accounts managed by the trustee of the Plan during the year. The Plan paid Lincoln approximately \$179,000 in record keeping and administrative fees during the period January 1, 2023 through December 4, 2023.

(6) **Fair Value Measurements**

Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under ASC Topic 820 are described below. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability;

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

The mutual fund accounts are valued at the net asset value of shares held by the Plan at year end based on quoted market prices. The plan did not hold any investments as of December 4, 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
