Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cannon Memorial Hospital Employees' Pension Plan Agreement, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023, and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1. Description of Plan

The following description of the Cannon Memorial Hospital Employees' Pension Plan Agreement (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution money purchase pension plan covering all employees of Cannon Memorial Hospital d/b/a AnMed Health Cannon (the "Hospital") who have completed one year of service, except for employees classified as supplemental staff and employees working under grant programs. The Hospital controls and manages the operation and administration of the Plan. Variable Annuity Life Insurance Company d/b/a Corebridge Financial serves as the custodian of the Plan (the "Custodian" or "VALIC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective December 31, 2023, legal control of the Plan was transferred and net assets of the Plan merged into the AnMed Health 401(a) Retirement Plan (the "Successor Plan"). Assets transferred out of the Plan totaled \$2,905,508 and are controlled by the Successor Plan. No assets remained in the Plan as of December 31, 2023.

Contributions

The Plan provides for Hospital discretionary profit-sharing contributions. For participants who worked at least 1,000 hours during the plan year and have at least one year of service, the Hospital contributes 3% of eligible wages. Contributions are subject to certain limitations of the Internal Revenue Code ("IRC"). Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Investment options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers variable annuities invested in mutual funds, mutual funds, and guaranteed interest accounts as investment options for participants.

Participant accounts

Each participant's account is credited with allocations of the Hospital's contributions and plan earnings (losses) and charged with benefit payments, transaction fees related to loans to participants and distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions representing distributions from other qualified defined benefit or defined contribution plans plus actual earnings thereon. Vesting in the Hospital's contribution portion of a participant's account plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

Loans to participants

Participants may borrow from VALIC up to the lesser of a maximum \$50,000 or 50% of their vested account balance. The loans are secured by collateral in the amount of the loan, which is transferred from the participant account into a collateral fund. An additional amount equal to one quarter of interest plus all applicable surrender charges is transferred from the participant's account and held in escrow until the loan is repaid. Both these amounts are invested in fixed interest accounts and bear interest ranging from 1.0% to 3.5%. Principal and interest are paid directly by the participant to VALIC over a period not to exceed five years, unless the loan proceeds are applied to the purchase of the principal residence of the participant. In such case, the term of the loan may be repaid over a reasonable period of time that exceeds five years. In the case of default, the note and collateral are not foreclosed on until the occurrence of a distributable event. As of December 31, 2023, and 2022, \$0 and \$26,900, respectively, of such loans were collateralized by plan assets and are included in investments at contract value on the statements of net assets.

Payment of benefits

On termination of service, death, disability, retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. Amounts contributed representing distributions from other qualified defined benefit or defined contributions plans may be withdrawn at any time.

Forfeitures

At December 31, 2023 and 2022, forfeited non-vested accounts totaled approximately \$0 and \$9,512 respectively. These accounts may be used to pay administrative expenses or to reduce employer contributions. During 2023, no forfeitures were used.

Note 2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment valuation and income recognition

Investments are reported at fair value, except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded upon distribution.

Administrative expenses

The Plan's administrative expenses are paid by either the Plan or the Hospital, as provided by the plan document. Certain administrative functions are performed by employees of the Hospital. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (loans and distributions) are charged directly to the participant's account.

Subsequent events

The Plan has evaluated subsequent events through July 31, 2024, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2023 and 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Variable annuities

Quoted prices are not available in active markets for identical instruments. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics. The value of variable investment option is determined by calculating the cash value (net

asset value equivalent). The cash value is calculated by determining the accumulation unit value less an account charge attributable to the separate account. The accumulation unit value is determined by taking into consideration a participants purchase payments, transfers from other investment options, and publicized value of the investment funds.

In accordance with Topic 820, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. As such, variable annuities of \$0 and \$889,338 as of December 31, 2023 and 2022, respectively, have not been included in the fair value hierarchy.

The variable annuity contracts are agreements between VALIC and the Plan, in which VALIC gives each participant the variable investment options based on the investment funds within a separate account. A participant may transfer amounts among investment options with the following restrictions: VALIC reserves the right to limit allocation amounts and investment options to seven at any one time and also requires transfers to be at least 30 days apart. There are no unfunded commitments at December 31, 2023. These annuities seek preservation of capital and long-term capital appreciation and income by investing in a variety of stocks and other investments.

All investments as of December 31, 2023 are held by the Successor Plan. The following tables, set forth by level within the fair value hierarchy, the Plan's assets accounted for at fair value on a recurring basis as of December 31, 2022:

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Fully Benefit-Response Investment Contract

The Plan holds a portfolio of guaranteed investment contracts with VALIC. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. At December 31, 2023, and 2022, guaranteed investment contracts totaled \$0 and \$1,099,955, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 1.50%. Such interest rates are reviewed on a semi-annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Either party to the group annuity contract may terminate the contract with at least 60 days advance written notice to the other party.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

Note 5. Unaudited Information Certified by Custodian

The accompanying financial statements include the following unaudited information as of December 31, 2023, and 2022, and for the year ended December 31, 2023 that was obtained from data prepared and certified to be complete and accurate by the Plan's custodian, with the exception of the certified investments balances which are held by the Successor Plan:

Note 6. Exempt Party-In-Interest Transactions

Certain plan investments are managed by VALIC. VALIC is the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions as defined by ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to VALIC by the Plan for administrative services were \$2,209 for the year ended December 31, 2023.

Note 7. Tax Status

The plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain its tax exemption. Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
