Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of The Now Parent LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2023 and December 31, 2022, the related statements of changes in net assets available for benefits for the period ended November 30, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended November 30, 2023 and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1 - Description of Plan

The following description of the The Now Parent LLC 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan document or the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan was established by The Now Parent LLC (the "Company" or "Plan Sponsor") as a defined contribution plan effective January 1, 2020. Substantially all employees of the Plan Sponsor (The Now Parent LLC) and all participating employers (The Now LLC, MatoMato LLC, Post Real Estate Group LLC, and RV Ranch Management LLC) who have completed at least 1 year of service, have attained the age of 21, and are not covered by a collective bargaining agreement and not a non-resident alien, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

During 2022, the respective defined contribution plans of MatoMato LLC, Post Real Estate Group LLC, RV Ranch Management LLC, and The Now LLC merged into the Plan. Total assets transferred into the Plan totaled \$2,514,252 in 2022.

In January 2023, the plan was amended to include My First Call Services as a participating employer. All employees were eligible under the eligibility provisions above.

Effective November 30, 2023, the Plan merged into a pooled employer plan. Accordingly, net assets totaling \$4,225,225 were transferred to the Architect Retirement Pooled Employer Plan (successor) on August 25, 2023. The remaining \$45,339 of contributions were transferred to the successor on November 30, 2023.

Contributions

Participants could elect to contribute up to ninety-one percent (91%) of their annual eligible compensation as pre-tax or Roth contributions, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified plans (rollovers). Additionally, participants age fifty (50) or older, who were making contributions to the Plan, were allowed to make catch-up contributions as defined in the Plan.

The Plan was a safe harbor plan, as defined by the IRC, and required a non-elective safe harbor match of one hundred percent (100%) of deferrals up to the first four percent (4%) of participant compensation deferred. The Plan could also make discretionary profit sharing contributions. Employees must be employed on the last day of the plan year to be eligible for profit sharing contributions. There were no profit sharing contributions during 2023 or 2022.

Participant investment account options

The Plan offered a variety of mutual funds held by Mid Atlantic Trust Company (MATC).

Participant accounts

Each participant's account is credited with the participant's deferral contribution and allocations of the Company's contributions, plus a proportionate interest in the invest earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions portion of their accounts is based on years of continuous service. Vesting is determined on a six (6) year graded scale, as shown below. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

Notes receivable from participants

Participants may borrow from their individual accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and may have no more than two (2) loans outstanding at any given time. The loans are secured by balance in the participant's account and bear interest at a rate equal to the current prime lending rate plus one percent (1%). Principal and interest are repaid ratably through payroll deductions.

Payment of benefits

Upon termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive an amount not to exceed the value of the participant's vested interest in his or her account in either a lump-sum amount or a direct rollover. For termination of service due to other reasons, a participant may receive the value of the interest in his or her account as a lump-sum distribution or a direct rollover. Withdrawals by a participant while still employed are limited to those requested due to events of financial hardship as defined in the Plan document or upon attainment of age 59½.

Forfeited accounts

If an employee terminates before his or her profit sharing contribution accounts have become fully vested, such portion of the accounts is forfeited. Participant forfeitures are used to pay plan expenses, offset future employer contributions, or be reallocated to participant balances, as defined by the plan document.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 30, 2023 or December 31, 2022.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, MATC, the trustee of the Plan, has certified that the following data included in the accompanying financial statements are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividend income
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described below.

Note 4 - Fair value measurements (continued)

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2022. There were no investments as of November 30, 2023 due to the plan merging into the successor plan.

Note 5 - Related party transactions and party-in-interest transactions

Certain Plan investments include interests in certain mutual funds managed by MATC. MATC is the trustee of the Plan and therefore these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments as they are paid through revenue sharing rather than direct payment. The Plan made direct payments to the trustee totaling \$21,442 for the period ended November 30, 2023 and \$18,421 for the year ended December 31, 2022, which was not covered by revenue sharing. These transactions are party-in-interest transactions. The plan sponsor pays directly any other fees related to the Plan's operations.

Note 6 - Plan termination

During 2023, the Plan merged into the Architect Retirement Pooled Employer Plan, effective November 30, 2023. In connection with the merger and immediately prior to the transfer of plan assets to the successor plan, all participants' account balances became 100% vested.

Note 7 - Tax status

The Internal Revenue Service (IRS) has determined that the Pre-Approved Profit Sharing Plan is designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated August 31, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that is more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and uncertainties and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Risks and uncertainties and concentrations (continued)

As of December 31, 2022, approximately 20% and 17% of the Plan's investments were invested in the Vanguard Target Retirement 2040 Investment Fund and the Vanguard Target Retirement 2030 Investment Fund, respectively.

Note 9 - Delinquent participant contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$121,788 were not remitted within the required time period for the period ended November 30, 2023 and the year ended December 31, 2022. The prior year lost earnings were corrected during 2023. The Company corrected a portion of the 2023 lost earnings and is working with the successor plan's trustee to remit the remaining current year lost earnings.

Note 10 - Subsequent events

Plan management has evaluated subsequent events through July 30, 2024, which is the date the financial statements were available to be issued and noted no items requiring disclosure.
