SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed an audit of the financial statements of Outpatient Imaging Affiliates Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets in liquidation available for benefits as of October 5, 2023 and December 31, 2022, and the related statement of changes in net assets in liquidation available for benefits for the period from January 1, 2023 through October 5, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 5, 2023 and December 31, 2022 and for the period from January 1, 2023 through October 5, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION

In our opinion, based on our audits and on procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

EMPHASIS OF MATTER - PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING

As further discussed in Notes 1 and 8 to the financial statements, the Board of Trustees of Outpatient Imaging Affiliates Retirement Plan approved a plan of liquidation in October 2023, and management determined liquidation is imminent. As a result, Outpatient Imaging Affiliates Retirement Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

AUDITOR'S RESPONSIBILITIES FOR THE AUDIT OF THE FINANCIAL STATEMENTS

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of Outpatient Imaging Affiliates Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Prior to liquidation, the Plan was a participant directed defined contribution plan, covering all full-time employees of certain participating employers of OIA Staffing, Inc. Outpatient Imaging Affiliates, LLC is the Plan's Sponsor (the "Employer"), as a member of a control group. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Trustees was responsible for oversight of the Plan and works with an independent investment advisory services company to help determine the appropriateness of the Plan's investment offerings and monitor investment performance.

The Employer also maintained a safe harbor 401(k) defined contribution plan ("Outpatient Imaging Affiliates Savings Plan") that had been adopted by certain other employers of OIA Staffing, Inc. The financial statements of Outpatient Imaging Affiliates Savings Plan should be read in conjunction with these financial statements. Occasionally, participants transferred locations between employers of OIA Staffing, Inc. that had adopted the Outpatient Imaging Affiliates Savings Plan.

Effective January 6, 2023, the Employer and Plan Professionals, LLC, as Plan Administrator of the AccrueWise PEP (the "Successor Plan"), and their respective defined contribution plans, entered into an Agreement of Merger (the "Agreement") whereas the Employer agreed to transfer all the Plan assets into the Successor Plan, remove the Employer as the plan sponsor and plan administrator and name Plan Professionals, LLC as the plan sponsor and plan administrator. The Agreement appoints a new plan service provider, Pinnacle Financial Services ("Pinnacle"), to provide investment options as well as certain third-party administrator functions for the Plan. Plan assets were transferred from Empower Trust Company, LLC to Pinnacle as soon as administratively practical from the Agreement date. The merger did not impact participant benefits as the benefit provisions were incorporated in the Successor Plan and as protected under the Internal Revenue Code ("IRC").

Eligibility

Prior to liquidation of the Plan, all employees, other than union employees and nonresident aliens, were eligible to participate in the Plan beginning the January 1, April 1, July 1 or October 1 after reaching age 21 and completing 6 months of service, as defined in the plan document.

Contributions

Prior to January 1, 2023, participants elected to defer up to 100% of their compensation, as defined in the plan document. Participants could also contribute amounts representing distributions from other qualified plans. Participants could change their salary deferral percentage at any time. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Newly eligible participants, except those who had an affirmative election in effect, become automatically enrolled in the Plan at a deferral rate of 3% of compensation. Participant deferrals were automatically escalated by 1% each year upon three years of service with a maximum automatic increase to 6% of compensation upon five or more years of service.

Contributions to the Plan ceased effective January 1, 2023 in accordance with the Agreement.

The Employer matched 50% of a participant's contribution up to 6% of the participant's compensation. Prior to January 1, 2022, the Employer could also make certain discretionary contributions, as defined in the plan document. Effective January 1, 2022, the Plan removed the Employer profit sharing contribution.

Employer matching contributions may be discontinued in accordance with various provisions of the Plan.

Contributions are subject to certain limitations in accordance with applicable regulatory requirements.

Participant accounts

Prior to liquidation, each participant's account was credited with the participant's contributions, allocations of Employer contributions and plan earnings, and reduced by an allocation of administrative expenses, any distributions and plan losses. Allocations were based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Investment options

Prior to liquidation, participants directed the investment of their contributions into various investment options offered by the Plan. Participants were able to change their investment options any time throughout the year.

Vesting

Prior to liquidation, participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in Employer contributions is based on years of continuous service. Participants were 20% vested after two years of service and an additional 20% thereafter, resulting in 100% vesting after six years of credited service. Participants were also 100% vested upon reaching the Plan's normal retirement age, which is the later of age 65 or the fifth anniversary of the Plan year in which participation commenced, or upon their death or disability.

On January 6, 2023, all participants became 100% vested in their Employer contributions in accordance with the Agreement.

Payment of benefits

Prior to liquidation of the Plan, benefit distributions equal to a participant's vested account balance were payable to the participant or their beneficiaries upon normal retirement (later of age 65 or the fifth anniversary of the Plan year in which participation commenced), death, disability or termination of employment. The method of distribution was determined by the Plan Administrator in accordance with the provisions of the Plan. If the vested value of a terminated participant's account was less than \$1,000, the total vested balance was distributed as an automatic lump-sum cash payment. If the vested value of a terminated participant's account was between \$1,000 and \$5,000, the total vested balance was distributed as an automatic rollover IRA.

Forfeitures

Forfeitures result from termination of employment under circumstances which do not entitle the participant to be fully vested in their Employer contributions and are available to be used to pay any Plan expenses or reduce the Employer's contributions to the Plan. Forfeitures remaining at October 5, 2023 and December 31, 2022 amounted to \$0 and \$12,074, respectively. All forfeitures as of December 31, 2022 were transferred to AccrueWise PEP in accordance with the Agreement.

In-service withdrawals

Prior to the liquidation of the Plan, in-service withdrawals were permitted by participants who had reached the age of 59½. Earlier withdrawals could also be made in the case of financial hardship, as determined by the Employer in accordance with the plan document. Hardship withdrawals were limited to the cumulative amount of the participant's contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

Due to the decision to terminate the Plan during 2023, management determined liquidation of the Plan is imminent and the financial statements for 2023 have been prepared using the liquidation basis of accounting. The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment valuation and income recognition

Prior to liquidation, investments were stated at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the investment advisers and Custodian. See Note 4 for discussion of fair value measurements.

All investments reported in the Statement of Net Assets in Liquidation Available for Benefits as of October 5, 2023, are reported at liquidation value. For all investments, fair value approximated the amount the Plan expected to collect upon liquidation.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit payments were recognized in the year paid.

Administrative expenses

Prior to liquidation, the Plan was responsible for its administrative expenses unless paid by the Employer. Investment-related expenses were included in net appreciation in fair value of investments.

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between October 5, 2023 and August 15, 2024, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements including investments held at October 5, 2023 and December 31, 2022, and investment income for the period from January 1, 2023 through October 5, 2023, was obtained by management and agreed to or derived from information certified by Empower Trust Company, LLC, the Custodian of the Plan.

NOTE 4 - FAIR VALUE

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

Mutual funds	Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
Collective trust funds	Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

There have been no changes in the valuation methodologies used at October 5, 2023 and December 31, 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table summarizes, by level, within the fair value hierarchy, investments measured at fair value on a recurring basis as of December 31, 2022:

Prior to liquidation, there were no participant redemption restrictions for these investments; the notice period is applicable only to the Plan. If the Plan initiates a full redemption of the account, the issuer reserves the right to require 12 months' notification in order to ensure that security liquidations will be carried out in an orderly business manner.

The description of the significant investment strategies for each category of investment in the collective trust fund follows:

- (a) This category invests its assets in a diversified portfolio of Stable Value Investment Contracts issued by life insurance companies, banks, and other financial institutions, the performance of which may be predicated on underlying fixed income investments. The principal value of these assets is designed to preserve capital and remain stable regardless of stock and bond market fluctuations.

NOTE 5 - INCOME TAX STATUS

The Plan has adopted a pre-approved plan document (Pre-Approved Plan). The Pre-Approved Plan received its latest opinion letter on November 30, 2020, in which the Internal Revenue Service ("IRS") stated the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not applied for a separate determination letter.

The Pre-Approved Plan has been amended and restated since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan and Pre-Approved Plan are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invested in investment securities which are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At December 31, 2022, the Plan had a concentration of investments in three mutual funds, which represented approximately 39% of total investments.

NOTE 7 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Plan investments are held by the Custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, rather than a direct payment.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.

NOTE 8 - PLAN MERGER AND TERMINATION

As discussed in Note 1, the Employer and Plan Professionals, LLC as Plan Administrator of the Successor Plan, and their respective defined contribution plans, entered into the Agreement. The Employer has the right to terminate the Plan subject to provisions of ERISA. Liquidation was imminent at the end of the Plan year end, and substantially all of the assets of the Plan merged into the Successor Plan during the period from January 1, 2023 through October 5, 2023.
