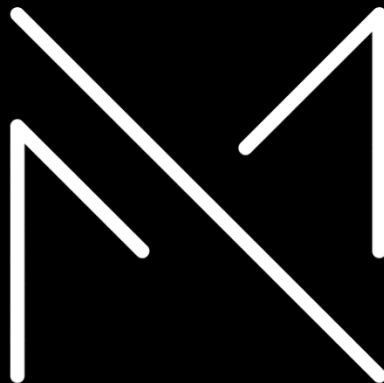

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2020 Financial Statements

We have performed an audit of the financial statements of Mister Sparky 401(k) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2020, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2020 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2020, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2020 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2020 Financial Statements section of our report —

- the amounts and disclosures in the 2020 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the 2020 financial statements referred to above related to assets which provide benefits under the plan and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Their report dated August 19, 2022, indicated that (a) because of the significance of the information that they did not audit, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the financial statements and supplemental schedules, and (b) the form and content of the information included in the financial statements and supplemental schedules other than that derived from the certified information, were presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of the Mister Sparky 401(k) (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Service Minds, Inc. dba Mister Sparky (Company) who are age 21 or older and have completed one year of service with 1,000 hours. The Plan excludes employees whose employment is governed by a collective bargaining agreement under which retirement benefits were subject to good faith bargaining and nonresident aliens with no US source income. Eligible employees can enter the Plan on the first day of the month following the date on which eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan assets are held and managed by MassMutual Life Insurance Company, which invests contributions and Plan earnings, makes investment transactions as directed by the Trustee and provides certain recordkeeping services. Dyatech acts as the third-party administrator for the Plan and performs certain plan administration and annual ERISA compliance testing.

Contributions

Each year, participants may contribute a portion of their annual compensation, as defined in the Plan, into a pre-tax deferral account and/or an after-tax Roth account subject to the limits under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may elect to make a discretionary profit sharing contribution. All employees eligible for the Plan are eligible to receive the profit sharing contribution. During the year ended December 31, 2020, management elected a profit-sharing contribution of approximately \$170,000, which was deposited after year end.

Investment Elections

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan that are designated by the Plan's Administrative Committee. If no election is made, contributions are placed into a target retirement fund, the Plan designated default investment, based on the participant's projected retirement age. Participants can change their investment elections daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions and Plan earnings, and is charged with an allocation of administrative expenses and any related transaction fees for loans and distributions that are paid by the Plan. Allocations are made based on participant earnings, account balance, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. A participant is 20% vested after one year of credited service and 100% vested after five years of credited service. Any amount not vested upon a participant's separation from service is forfeited and can be used in any way permitted by the plan document. A participant becomes fully vested in the entire balance of his or her account upon retirement, disability, death or termination of the Plan.

Notes Receivable from Participants

Loans to participants are not permitted by the Plan.

Note 1 – Description of Plan, continued

Payment of Benefits

On termination of service due to any reason, participants with vested account balances of \$1,000 or less receive an automatic lump-sum distribution, unless the participant requests that it be rolled-over to an Individual Retirement Account (IRA) provider or another qualified retirement plan. Participants with vested account balances of less than \$5,000 and more than \$1,000 receive a lump sum distribution or an automatic distribution to an IRA. Participants with vested account balances of \$5,000 or more may leave their balance in the Plan, elect to receive a single lump-sum amount, installment payments, or choose to rollover their balance into another qualified retirement plan or IRA. Participants may also take in-service distributions subject to the terms of the Plan and Internal Revenue Service (IRS) regulations.

Forfeited Accounts

Generally, a participant's unvested portion of the Company's contribution is forfeited upon termination of employment. Forfeitures are maintained in a separate account and can be used to pay Plan expenses, reduce Company contributions, or to restore forfeitures.

At December 31, 2020 and 2019, there were no forfeited nonvested accounts. During the year ended December 31, 2020, \$876 in forfeitures were used to pay plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees are charged to participants on a pro rata basis, equally to participant accounts, or to a participant account for transactions specifically related to that participant.

Certain investment management fees and other charges are offset against fund performance in the net appreciation in fair value of investments on the Statement of Changes in Net Assets Available for Benefits and are not, therefore, separately reflected as administrative expenses. Additionally, certain Plan expenses are paid directly by the Company and therefore are excluded from these financial statements.

Note 2 – Summary of Significant Accounting Policies, continued

Payment of Benefits

Benefits are recorded when paid.

Risks, Uncertainties, and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2020, approximately twenty five percent of the Plan's investments were invested in the JPMorgan SmartRetirement 2055 Fund, and approximately twenty one percent of the Plan's investments were invested in the JPMorgan SmartRetirement 2040 Fund.

Subsequent Events

The Plan has evaluated subsequent events through September 22, 2023, the date the financial statements were available to be issued.

In October 2021, the Plan changed recordkeepers from MassMutual Life Insurance Company to ADP Retirement and changed custodians from MassMutual Life Insurance Company to Reliance Trust Company.

Effective March 5, 2022, the Plan was amended and restated as part of the required 3rd Cycle Restatement of the Dyatech volume submitter Plan document which has been adopted by the Plan.

Effective June 1, 2022, the Plan was amended and restated in its entirety to adopt the Automatic Data Processing Non-Standardized Defined Contribution Pre-Approved Plan. As part of the restatement, the name of the Plan was changed to the Service Minds Inc 401(k) Plan, and Supply Spot LLC and SoutheastFL Home Services LLC were added as participating employers.

During 2022, it was discovered that eligibility provisions for Plan were not properly applied in calculating the profit sharing contribution. Certain eligible participants were improperly excluded and did not receive a contribution. The Plan Administrator identified the affected participants and deposited approximately \$153,000 of additional profit sharing contributions into the Plan on December 19, 2022 to make the affected participants and the Plan whole, including lost earnings. These amounts are included in the financial statements in employer contribution receivable as of December 31, 2020.

Note 3 – Certified Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2020 and 2019, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2020, was obtained by management and agreed to or derived from information certified as complete and accurate by MassMutual Life Insurance Company, the custodian of the Plan.

Note 4 – Tax Status

The IRS has determined and informed by a letter for the prototype plan adopted by the Plan, dated June 30, 2020 that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan Administrator believes that the Plan is designed, and is currently being operated in compliance with, the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2020 and 2019.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
