The Plan was transferred into the ADP TotalSource Retirement Savings Plan, a professional employer organization plan, in August of 2020. Hometown Medical Supply, LLC was later acquired by the parent of Reliable Medical Supply, LLC.

Due to changes in personnel, service providers and other issues, Reliable Medical Supply, LLC has had difficulties in gaining access to certain 2020 Plan information.
