World Gospel Mission, the Plan’s sponsor, is a church and the Plan is therefore a church plan within the meaning of ERISA section 3(33). World Gospel Mission has never made an election to be subject to ERISA and to forego church plan status for Internal Revenue Code purposes, as is permitted by section 410(d) of the Internal Revenue Code of 1986, as amended (“Code”).


ERISA section 4(b)(2) provides that a “church plan” is exempt from the provisions of Title I of ERISA (including the annual reporting requirements). The IRS has confirmed that church plans that do not make a Code section 410(d) election are not required to file the annual Form 5500. *See* IRS Announcement 82-146, 1982-47 I.R.B. 55.

Although the Plan has been a church plan since its inception in 1986, and was therefore never required to file Form 5500, World Gospel Mission mistakenly believed that it was required to file Form 5500 with the Department of Labor (“DOL”), and did so for several years. However, recently, World Gospel Mission determined that it was not required to file annual reports with the DOL with respect to the Plan because of the Plan’s church plan status.

Because World Gospel Mission maintains a church plan for which the election under Code section 410(d) has not been made, the 2023 Form 5500 will be the final filing for the Plan. Effective with the 2024 plan year which begins January 1, 2024, the Plan will no longer file Form 5500. Please adjust your records accordingly.
