NOTE A. DESCRIPTION OF THE PLAN

The following description of the Helpmates, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company, with the exception of union employees, who have at least six months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance. Effective December 31, 2022, the Plan changed to a calendar year end. The Plan was frozen as of December 31, 2023, and the assets of the Plan were transferred to the Penn Highlands Healthcare 401(k) Plan on February 2, 2024. The Plan was terminated February 29, 2024.

Contributions

The Plan is funded through employer contributions and pre-tax employee payroll deductions. Each year participants can elect to defer a percentage of their pre-tax annual compensation to the Plan to a maximum dollar amount as determined annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company offers various mutual fund options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a default investment option until changed by the participant. The amount a participant may defer in any tax year is limited by law.

In addition, the Company, in its discretion, may make a matching contribution equal to a percentage, determined by the Company, of the participant’s 401(k) contributions for the plan year. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors.

There were no matching or profit-sharing contributions made in 2024.

NOTE A. DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's respective deferral, the employer's basic match contribution and profit-sharing contribution and plan earnings. Participant accounts are charged with administrative expenses relating to participant hardship distributions and distributions that are paid by the Plan. Participants are able to direct the investment of their contributions to the Plan based on investment choices made available to them. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in amounts attributable to employee deferrals and earnings. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant's vested account value is \$1,000 or less, the entire amount will be paid to the participant upon termination.

Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan document. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59 ½.

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may either be used by the Plan at the discretion of the plan administrator for payment of plan expenses, or allocated to the participants. At February 29, 2024, there were no forfeited non-vested accounts.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan’s valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Reclassification

Amounts in the prior period’s financial statements are reclassified whenever necessary to conform to current period presentations.

Date of Management’s Review

Management has evaluated subsequent events through the date of the report, which is when the financial statements were available to be issued.

NOTE C. CERTIFICATION OF FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements, including investments held at February 29, 2024 and December 31, 2023, and net appreciation in fair value of investments for the short plan year ended February 29, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan.

NOTE D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 1, Level 2 or Level 3 inputs were available to the Plan.

The fair value of the pooled separate accounts is measured at the NAV of each account on the last day of the plan year. The NAV is based on the market value of the underlying assets.

In accordance with Subtopic 820-10, certain investments that are measured at fair value using the NAV per share practical expedient have not been categorized in the fair value hierarchy. See Note E for discussion on investments measured at NAV.

Gains and losses included in changes in net assets available for benefits for the short plan year ended February 29, 2024 are reported in net appreciation in fair value of investments.

NOTE F. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The plan sponsor, Helpmates, Inc., provides the Plan with accounting and administrative services for which no fees are charged. In addition, certain plan investments are shares of pooled separate accounts managed by John Hancock Life Insurance Company. Fees paid by the Plan for administrative services amounted to \$492 for the short plan year ended February 29, 2024.

The plan sponsor directly pays most administrative expenses for the Plan.

All of these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

NOTE G. TAX STATUS

The Internal Revenue Service has determined and informed the custodian by a letter dated June 30, 2020, the Plan is qualified and the trust established under the Plan is tax exempt, under the appropriate sections of the Internal Revenue Code (IRC). The plan administrator and its qualified tax counsel do not anticipate that changes in the Plan after the date of the amendments covered by the Internal Revenue Service determination letter will affect the qualified and tax-exempt status of the Plan and the Trust, respectively.

NOTE G. TAX STATUS (CONTINUED)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded as of February 29, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
