Opinion

We have audited the financial statements of Total Logistics, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets in liquidation as of December 31, 2023 and 2022, and the related statement of changes in net assets in liquidation for the year ended December 31, 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position (in liquidation) of Total Logistics, Inc. Employee Stock Ownership Plan as of December 31, 2023 and 2022 and the changes in net assets available for benefits (in liquidation) for the year ended December 31, 2023, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

As described in Note 1 to the financial statements, on October 29, 2021, the board of directors of Total Logistics, Inc., the Plan's sponsor, authorized the termination of the Plan and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis to the liquidation basis used in presenting the Plan financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Independent Auditor's Report

Auditor's Responsibilities for the Audit of the Financial Statements

Notes to the Financial Statements

December 31, 2023 and 2022

1. Description of Plan

The following brief description of the Total Logistics, Inc. Employee Stock Ownership Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

General

The Plan was formed on January 1, 2018 and is a defined contribution leveraged employee stock ownership plan ("ESOP") whose purpose is to reward eligible employees by providing them with retirement benefits through a beneficial interest in Total Logistics, Inc. (the "Company" or "Employer"). The trust department of an independent third-party bank is the trustee.

The Plan is designed to meet the requirements of the Internal Revenue Code Section 401(a) and, to the extent applicable, Internal Revenue Code Sections 409 and 4975(e)(7) and the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

On October 29, 2021, 100% of the issued and outstanding common stock of Total Logistics, Inc. was sold to Cox Holding Company, LLC. As a result, the Plan received cash proceeds from the sale of approximately \$12,737,000. Approximately \$772,000 was paid to the Plan in October 2021, with the remaining \$11,965,000 held in a post-closing adjustment escrow in accordance with the agreement and which was to be paid during 2022. In June 2022, the Plan received funds of approximately \$9,475,000 from the post closing adjustment escrow. The remaining escrow amount of approximately \$2,490,000, which included the additional escrow payment of approximately \$249,000, was received in October 2022.

Effective October 29, 2021, in connection with the sale as described previously, Total Logistics, Inc. Board of Directors approved to terminate the Plan and accounts of all participants became 100% vested. Pending the resolution of the escrow and complete distribution of all Plan assets, the Plan is no longer considered an employee stock ownership plan, but rather a profit sharing plan following the termination date. As a result of the approved termination of the Plan, management has determined that liquidation is imminent, and the Plan began using the liquidation basis as its basis of accounting beginning in 2021. The Plan was completely liquidated by December 2023.

On June 27, 2023 the Plan received a determination letter from the IRS approving the termination of the Plan which does not affect its qualification for federal tax purposes.

Eligibility and Contributions

Prior to 2021, substantially all employees are eligible to participate in the Plan upon completing 1,000 hours with the Company. Participants that were not employed on the last working day of the plan year (December 31) were generally not eligible for an allocation of the Company contributions.

In 2021, due to the termination of the Plan in October 2021, all employees were eligible to participate in the Plan and receive an allocation of the employer contribution upon completing 833.33 hours during January 1, 2021 through October 29, 2021 and if actively employed on October 29, 2021.

Contributions

Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year. The Company makes discretionary contributions as determined by the Company's Board of Directors. Such contributions are generally made in cash or shares of Company common stock. Participating employees are not permitted to make contributions to the Plan. The Company made no discretionary contributions in 2023 or 2022.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account, cash and common stock contributed by the Company, forfeitures of terminated participants' non-vested accounts, and cash balances, if any. Only those participants who are eligible employees of the Plan will receive such an allocation. Plan participants also receive allocations of investment earnings, including net appreciation in the value of Company stock. Allocations are based on participant earnings and years of service as defined in the Plan's agreement.

Vesting

Prior to the termination of the Plan, funds accruing to participants over the age of 18 began to vest at 20% after two years of service, with an additional 20% vesting each year thereafter. All accounts became 100% vested after completion of six years of service, reaching the age of 65 while employed by the Company, or death or disability while employed by the Company. A participant who accumulated less than 500 hours of service during a Plan year were generally not given a year of service for vesting purpose.

Forfeited Accounts

Prior to the termination of the Plan, if a participant terminated employment before becoming fully vested in their account balance, the forfeited portion of the account balance was allocated among participants based on a predetermined formula utilizing the current year compensation for the year and the years of service as of the end of the plan year. Forfeitures allocated to participants during December 31, 2023 totaled \$0. Forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2023 and 2022 were \$0.

Payment of Benefits

Prior to the termination of the Plan, upon termination of service due to death, disability, or retirement after reaching the age of 65, a participant will receive a distribution of their vested account beginning in the first plan year following the plan year in which the participant separated service. If the participant separates service for reasons other than death, disability, or retirement after reaching the age of 65, a distribution of the vested account will be offered beginning five years after the participant separated service. Distributions of accounts of \$1,000 or less will be made in the form of a lump sum payment. For account balances more than \$1,000, the Company will distribute the vested balance in substantially equal annual installments over a period not to exceed five years, subject to minimum distribution amounts.

The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock, except that any distribution eligible for floor price protection are distributed in shares only. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Put Option

Prior to the termination of the Plan, under federal income tax regulations, if the employer securities held by the Plan were distributed to a participant and were not readily tradable on an established market, or were subject to trading limitations, they included a put option (liquidity put). The liquidity put provides the holder, upon termination of employment, retirement, disability, or death, the right to demand the Company buy shares of stock held by the participant for which there is no market. The put price is representative of the fair market value of the stock. Under the terms of the Plan, and subject to limitations, the Company could redeem the shares in a lump-sum payment or incrementally on an annual basis over a term not to exceed 10 years or the participant's life expectancy. The purpose of the liquidity put was to ensure that the participant had the ability to ultimately obtain cash.

Voting Rights

Prior to the termination of the Plan, in certain situations, as defined by the Plan, each participant was entitled to exercise voting rights attributable to the shares allocated to his or her account.

Each participant was entitled to exercise voting rights attributable to the shares allocated to his or her account and was notified by the Trustee prior to the time that such rights were to be exercised. The Trustee was not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee was required, however, to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

Related Party and Party-In-Interest

Prior to the termination of the Plan, the Plan is invested in Company common stock. The Company is considered a party-in-interest under ERISA.

Diversification

Prior to the termination of the Plan, diversification was offered to participants close to retirement such that they had an opportunity to sell part of the value of their investment in Company stock and receive a cash distribution to an individual retirement account or other qualified plan designated by the participant to receive the distribution. Participants between the ages of 55 and 59 with a minimum of 10 years of participation in the Plan may elect to diversify up to 25% of the aggregate shares of Company stock deposited into their account since participating. Upon attaining the age of 60, these qualified participants may elect to diversify up to 50% of the aggregate shares deposited into their account since participating. Participants who elect to diversify receive a cash distribution, unless eligible for floor price protection, in which case shares are distributed. The election to diversify is made subsequent to year end based upon the shares of employer stock in the participant's account at year end.

2. Summary of Significant Accounting Policies

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein. The most significant estimates relate to the expenses expected to be incurred in liquidation and the estimated timing of the final liquidation of the Plan. Actual results could differ from those estimates and those results could be significant.

Payment of Benefits

The plan utilized the liquidation basis of accounting when recording benefit payments.

Administrative Expenses

As provided in the Plan agreement, administrative expenses are paid by the Plan. The Plan utilized the the liquidation basis for 2023 and recorded all liquidation-related expenses in 2022, resulting in an accrual at December 31, 2022 for amounts that would be paid in 2023. As a result, there are no administrative expenses recorded during 2023 nor accrued as of December 31, 2023.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Subsequent Events

The Plan has evaluated subsequent events through August 12, 2024, the date which the financial statements were available to be issued.

3. Tax Status

On June 27, 2023 the Plan received a determination letter from the IRS approving the termination of the Plan and does not affect its qualification for federal tax purposes.

Prior to the termination of the Plan, the trust, established under the Plan to hold the Plan's assets, is qualified pursuant to the appropriate section of the IRC, and accordingly, the trust's net investment income is exempt from income taxes. The Plan obtained a favorable tax determination letter from the IRS dated May 1, 2020 that the Plan is in compliance with the requirements of section 401(a) of the IRC. The Plan was amended since receipt of the latest determination letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. No provision for income tax has been included in the Plan's financial statements.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is not currently under audit with respect to any tax periods in progress.
