## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the September 30, 2021 Financial Statements*

We have performed an audit of the financial statements of The Austin Company of Greensboro Employees' 401(k) Plan and Trust ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits, as of September 30, 2021 and 2020, and the related statement of changes in net assets available for benefits for the year ended September 30, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank, similar institution, or insurance carrier ("qualified institution") that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from Branch Banking and Trust Company and Ascensus Trust Company ("the Trustees"), as of and for the year ended September 30, 2021, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

### *Opinion on the September 30, 2021 Financial Statements*

In our opinion, based on our audit and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the September 30, 2021 Financial Statements* section –

- the amounts and disclosures in the September 30, 2021 financial statements, other than those agreed to, or derived from, the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the September 30, 2021 financial statements related to assets held by, and certified to by, a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion on the September 30, 2021 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). **A. DESCRIPTION OF THE PLAN**

The following description of The Austin Company of Greensboro (“the Company”) Employees' 401(k) Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General.** The Plan is a defined contribution qualified retirement 401(k) plan for which all employees are eligible after completing one year of service and credited with 1,000 hours. The employee can enter the Plan the first day after year end and the first day of the seventh month after the year end. It is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”).
2. **Contributions.** Participants may contribute a portion of their annual wages, not to exceed \$19,500 (adjusted annually) plus \$6,500 additional catch-up for age fifty (50) and over, for the years ended September 30, 2021 and 2020, respectively. The employer will contribute a matching amount based on a percentage of the participant's compensation as determined each year. In addition, the employer may make a discretionary nonelective contribution to the Plan that is allocated to eligible participants.
3. **Participants' Accounts.** Each participant's account is credited with the participant's contribution and an allocation of (1) the Company's contribution and (2) Plan earnings. Allocations are based on particular earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
4. **Vesting.** Participants are fully vested in the salary deferral portion of their 401(k) account balances at all times. The employer’s matching portion of 401(k) account balances vest according to the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

5. **Investment Options.** Upon enrollment in the Plan, a participant may direct employee contributions into various investments offered by the Plan. The Plan currently offers money market and mutual funds offered by Truist Bank (“the Trustees”).
6. **Participant Loans.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment funds from (to) the Participant Notes fund. Loan terms range from one to five (1-5) years. The loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%. The prime rate ranged from 3.25% to 5.50% through September 30, 2021. Principal and interest are paid ratably through weekly payroll deductions.

7. **Payment of Benefits.** Upon termination of service, if a participant terminates employment before age sixty-two (62) or normal retirement age, the participant will receive a single lump-sum payment in cash. If the participant terminates employment on or after normal retirement age and the balance does not exceed \$5,000, then the participant will receive a single lump-sum payment in cash. If the balance exceeds \$5,000, the participant may elect to take payment in installments.
8. **Forfeitures.** As of September 30, 2021 and 2020, forfeited non-vested accounts totaled \$842 and \$0, respectively. The funds in these accounts can be used to reduce future Company contributions or pay Plan expenses.

**B. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Shares of registered investment companies are valued at quoted market prices that represent the net asset value ("NAV") of shares held by the Plan at year end. Participant notes receivable are valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements, in conformity with generally accepted accounting principles, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

**C. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**D. RELATED PARTY TRANSACTIONS**

Certain Plan investments are income-based and equity-based mutual funds managed by the Trustees; therefore, as defined by the Plan, these transactions qualify as party-in-interest transactions.

**E. TAX STATUS**

The Internal Revenue Service has determined and informed the Plan Administrators by letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended and restated since receiving the determination letter to bring the Plan into compliance with recent legislation using a prototype non-standard plan provided by the Trustees. The Plan Administrators and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

As of September 30, 2021, management believes there are no uncertain tax positions.

As of September 30, 2021, and including the previous three (3) years considering extensions, the Plan's Form 5500 is open and subject to examination by tax authorities with relevant jurisdiction. Should such an examination take place, management does not anticipate any significant issues related to the open years.

**F. PLAN EXPENSES**

The Plan's sponsor has elected to pay all administrative expenses of the Plan, as permitted by the Plan document.

**G. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES**

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Furthermore, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

**H. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Codification establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three (3) levels of the fair value hierarchy under FASB Codification are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liabilities;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2021.

***Insured deposit program:*** Valued at the closing price reported on the active market.

***Mutual funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily NAV to transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
