- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Exploring Management 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Exploring Management 401(k)'s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a

material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Exploring Management 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter--Supplemental Schedule Required by ERISA**

The supplemental schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

### EXPLORING MANAGEMENT LLC 401 (k) PROFIT SHARING PLAN AND TRUST

December 31, 2023

#### NOTE A--DESCRIPTION OF PLAN

The following description of the Exploring Management LLC 401(k) Profit Sharing Plan and Trust ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a single employer defined contribution plan covering substantially all employees of Exploring Management, LLC and certain affiliated companies ("the Plan Administrator" and "the Employer"). During the year ended December 31, 2023, the affiliated companies included Exploring, Inc.; Exploring Graphics, LLC; Perfect Flooring, LLC; ID3 Group LLC; FRLV, LLC; Fabrication Resources LLC; and Abcom, Inc. All employees are eligible to participate except employees covered by a collective bargaining agreement and nonresident aliens. Eligibility requirements include a minimum age of eighteen years and 3 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

In March 2020, the President of the United States signed the Coronavirus Aid, Relief, and Economic Security Act ("the CARES Act"), which provides for modifications to provisions regarding distributions, loans, and rollovers for qualified participants affected by COVID-19. The Plan Sponsor has implemented the provisions of the CARES Act and expects to formally amend the Plan prior to December 31, 2025.

Contributions: The Plan provides for employee elective pre-tax and/or after-tax contributions. Plan participants may make contributions from their compensation, not to exceed the Federal statutory maximum or 92% of compensation. The Employer matching contribution is 50% of the participant's elective deferrals, for deferrals up to 6% of the participants compensation. A participant must have completed a year of service to be eligible for Employer's matching contributions. The match is calculated on a pay period basis.

The Plan provides for a discretionary, non-elective Employer profit-sharing contribution for all Plan participants who were employed on the last day of the Plan year and had at least a year of service. Allocation of the annual contribution is made based on the ratio that each participant's compensation bears to the total annual compensation for all participants. No profit-sharing contribution was made for the year ended December 31, 2023.

## NOTES TO FINANCIAL STATEMENTS--Continued

### EXPLORING MANAGEMENT LLC 401(k) PROFIT SHARING PLAN AND TRUST

#### NOTE A--DESCRIPTION OF PLAN--Continued

Participant Accounts: Each participant's account is credited with their contributions, the Employer's matching contributions, their account's earnings or losses, an allocation of administrative expenses, and an allocation of any Employer's profit-sharing contribution. All investments are participant directed. Participants may change their investment options on a daily basis.

Vesting: Participants are immediately vested in their voluntary contributions and allocated earnings thereon. Employer contributions and earnings thereon do not vest for the first two years of service. Once a participant reaches three years of credited service, or in the event of participant death, disability or normal retirement, they become immediately vested in their Employer contributions and earnings thereon. Forfeited amounts can be used to pay administrative or other related expenses of the Plan or reduce future Employer contributions to the Plan.

Notes Receivable from Participants: Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of the lesser of \$50,000, reduced by the highest outstanding loan balance in their account during the prior twelve month period, or 50 percent of their vested account balance, whichever is less. Participants may take out up to two loans at a time from their Plan balances. All outstanding loans to the participant from plans maintained by the participant's Employer or a related Employer will be considered for purposes of determining the maximum amount of a loan to the participant. The loans are secured by the balance in the participant's vested account and bear interest at a reasonable rate of interest determined by the Plan Administrator. At December 31, 2023, interest rates on outstanding participant notes receivable ranged from 4.25% to 9.50%.

Payment of Benefits: In the case of termination of service due to death, normal retirement (age 65), retirement due to permanent disability, or termination of employment, participants may elect to receive the value of their accumulated Plan benefits, in accordance with the provisions of the Plan, in a lump-sum distribution. The Plan allows in-service distributions at age 59½ from a participant's vested accounts.

Administration: The Plan is administered by the Employer. At December 31, 2023 and 2022, all funds in the Plan were held by Mid Atlantic Trust Company as the custodian and trustee (the "Custodian"). The Plan's Custodian invests participants' account balances, as directed by the participants, in a combination of equity and fixed income mutual funds.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan follows the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative guidance.

## NOTES TO FINANCIAL STATEMENTS--Continued

### EXPLORING MANAGEMENT LLC 401 (k) PROFIT SHARING PLAN AND TRUST

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

The financial statements of the Plan are prepared under the accrual method of accounting.

The Plan's investments are stated at fair value, as further described in Note C. Investment securities, in general, are exposed to various risks, including credit, interest, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in values of investment securities will occur and that such changes could materially affect the amount reported in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Realized gains and losses on the sale of investments are calculated based on the difference between the selling price and cost on an average cost basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as the change in unrealized gains/losses for securities held at the end of the year.

Contributions are recorded on the accrual basis, which recognizes participants' contributions, and the related Employer matching contributions, at the time the participants' contributions are withheld from their wages. Employer discretionary profit-sharing contributions are recorded in the period recognized in the Employer's financial statements.

Benefits are recorded when paid.

The Employer pays certain administrative expenses of the Plan excluding those allocable to the accounts of particular participants.

The loans to participants are reported separately from plan investments as notes receivable and are recorded at their unpaid balance, plus all accrued and unpaid interest.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through August 15, 2024, which is the date the financial statements were available to be issued.

#### NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs into valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under current accounting guidance are described below:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
  
- Level 2            Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.  
  
                          If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the quoted market price, which represents the net asset value of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## NOTES TO FINANCIAL STATEMENTS--Continued

#### NOTE C--FAIR VALUE MEASUREMENTS--Continued

There have been no changes in the methodologies used at December 31, 2023 and 2022.

At December 31, 2023 and 2022, the Plan's investments consisted solely of mutual funds. These investments are classified in their entirety within Level 1 of the fair value hierarchy. The fair value of these investments were \$4,696,808 and \$3,496,303 as of December 31, 2023 and 2022, respectively.

#### NOTE D--TRANSACTIONS WITH PARTIES IN INTEREST

The Plan has an agreement with the Custodian to maintain the investments of the Plan and to provide administrative and participant record keeping services for the Plan. For the year ended December 31, 2023, contributions to the Plan of \$748,287 were deposited with the Custodian for investment, and participants of the Plan received distributions of \$161,109 from funds held by the Custodian. At December 31, 2023 and 2022, the Plan had \$4,696,808 and \$3,496,303, respectively, of assets under the Custodian's custody.

#### NOTE E--TAX STATUS

The Plan is intended to satisfy the tax qualification requirements under Section 401 (a) of the Internal Revenue Code; therefore, the trust funds of the Plan are intended to be exempt from Federal income taxes. The amended Plan has not requested a favorable determination letter from the IRS since the prototype on which the Plan is based has been determined to be qualified under Section 401 (a) of the Internal Revenue Code.

#### NOTE F--PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

#### NOTE G--FORFEITED NON-VESTED ACCOUNTS

At December 31, 2023 and 2022, \$161 and \$-0-, respectively, was held in forfeited non-vested accounts. The Employer may use this forfeited amount to pay the Plan's administrative expenses or the Employer's contributions to the Plan. No forfeitures were utilized during the year ended December 31, 2023.

NOTE H--SUMMARY OF INFORMATION CERTIFIED BY PLAN CUSTODIAN

The total value of the Plan's net assets was \$4,827,180 and \$3,600,318 at December 31, 2023 and 2022, respectively. With the exception of notes receivable from participants, the Plan's Custodian has supplied the Plan Administrator with a certification as to the completeness and accuracy of all information presented in the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, and in the statement of changes in net assets available for benefits for the year ended December 31, 2023, with regard to investment activity.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE I--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

As of December 31, 2023 and 2022 and for the year ended December 31, 2023, there were no significant differences between the financial statements and Internal Revenue Service Form 5500.
