Note 1 – Plan Description

The following description of the RPS 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of RPS Americas, Inc. (the “Company” or “Employer”). The Plan, which commenced effective April 1, 1996, was amended and restated effective January 1, 2021, to comply with the latest rules and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustees

Voya Institutional Trust Company (“Voya” or the “Custodian”) is the Plan Custodian. The Custodian maintains custody of all investments held by the Plan, maintains the Plan’s participant account balances, and provides recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds, and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Members of the Plan Administrative Committee serve as Trustees of the Plan.

Eligibility and Plan Entrance Date

Except for union employees, employees of the Company are eligible to participate in the Plan after completing six months of service and attaining the age of 21. Eligible employees are permitted to enter the Plan on the first day of each month after which the employee has satisfied the eligibility requirements.

Participant Contributions

The Plan permits eligible employees to contribute, on a pre-tax or Roth basis, up to 100% of their annual compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$22,500 for 2023. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2023.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Employer Contributions

The Plan provides for Safe Harbor Employer matching contributions to all eligible participants in an amount equal to 100% of the first 5% of each participant’s eligible compensation contributed to the Plan as employee contributions. The Plan uses a year-end true-up matching contribution feature to allow participants to receive the maximum matching contribution available by making up any loss in matching contributions resulting from the participant’s individual savings strategies. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant account is credited with the participant’s contributions, Safe Harbor Employer matching contributions, and an allocation of net Plan earnings, and charged with an allocation of administrative expenses.

Note 1 – Plan Description (continued)

Participant Accounts (continued)

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their pre-tax or Roth deferred contributions, rollover contributions, Safe Harbor Employer matching contributions, and any related income or loss. As identified below, certain accounts are subject to alternate vesting schedules. A participant immediately becomes 100% vested in any unvested account balances upon retirement, disability, or death. A participant's period of service with the following entities will be counted for vesting purposes: C Exploration Consultants, Inc. dba RPS Energy; Cambrian Consultants America, Inc. dba RPS; Hydrosearch USA, Inc. dba RPS Energy; Evans Hamilton, Inc. dba RPS Evans Hamilton; Espey Consultants, Inc. dba RPS; Applied Science Associates, Inc. dba RPS ASA; RPS JDC, Inc. dba RPS; the Scotia Group, Inc.; APA USA, Inc.; the GeoCet Group LLC; Rudall Blanchard Associates, Inc.; Knowledge Reservoir, LLC; and GaiaTech, Inc. The following accounts vest according to alternate vesting schedules, as defined below.

Employer assets contributed to Evans Hamilton Profit-Sharing Plan prior to its merger into the Plan on August 1, 2012, as well as any earnings thereon, vest according to the following schedule:

Participant-Directed Investments

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The options vary in types of investments, rates of return, and investment risk.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are secured by the balance in the participant's account and bear interest at the Prime rate, as defined. Principal and interest are paid ratably through payroll deductions at least quarterly.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump sum payment equal to the value of their vested balance. Partial withdrawals or installments are only permitted for participants, or beneficiaries, who must receive required minimum distributions under the IRC. Vested account balances of less than \$5,000 are immediately distributable in a lump sum payment under the terms of the Plan, without the participant's consent. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

Forfeited Accounts

Per the provisions of the Plan Document, forfeited nonvested accounts are to be used to reduce Employer contributions or pay administrative expenses. At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$6,270 and \$29,606, respectively, and Employer contributions were reduced by \$41,261 from forfeited nonvested accounts for the year ended December 31, 2023.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Note 2 – Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of Plan additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, Custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments on the statement of changes in net assets available for benefits.

The Plan receives revenue sharing credits from investments in Voya share class mutual funds based on invested balances. This revenue is used to offset certain amounts owed to the Custodian for its administrative services to the Plan. If the revenue the Plan received from the mutual fund service provider exceeds the amount owed under the agreement, the Custodian remits the excess to the Plan's trust on a monthly basis. Such amounts may be used to pay Plan administrative expenses. Administrative expenses of \$11,235 were paid from the recordkeeping expense account for the year ended December 31, 2023. At December 31, 2023 and 2022, the Plan recordkeeping expense account totaled \$44,053 and \$55,642, respectively. The Plan or Plan Sponsor may make a payment to the Custodian for administrative expenses not covered by revenue sharing.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

- **Pooled Separate Accounts** – These investments are valued using the net asset value (“NAV”) of units held by the Plan at year-end as provided by the Custodian. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2023 and 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate.

The Plan’s independent auditor did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements and supplemental information.

Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan maintains the Voya Fixed Account, a guaranteed investment contract-related investment option issued by Voya Retirement and Insurance and Annuity Company (“VRIAC”). The contract underlying the investment option meets the fully benefit-responsive investment contract criteria; thus, the investment contract is reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The Fixed-Account minimum guaranteed interest rate, which is guaranteed for the lifetime of the contract, is 2.00%. The contracts cannot be terminated before the scheduled maturity date. The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 5 – Guaranteed Investment Contract with Insurance Company (continued)

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include, but are not limited to, the following: (i) the Company provides effective communication to the Custodian that the agreement will be fully or partially terminated as of a date selected by the Company, which will be no earlier than thirty days from the date the Custodian was notified of the agreement termination; (ii) the IRS determines that the Plan no longer meets the requirements of Code section 401(a), 403(a), 414(d), 414(e), or any other applicable Code provision; (iii) there is a termination or partial termination of the Plan; (iv) the Company breaches a provision of the agreement; or (v) the Custodian provides effective communication to the Company that the agreement will be terminated as of a date, which will be no earlier than ninety days from the date the Company was notified of the agreement termination.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6 – Related Party and Party-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts and fully benefit-responsive investment contracts, which are both managed by the Custodian. As such, both types of transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to service providers.

The Plan has notes receivable from participants as of December 31, 2023 and 2022. These receivables and all related transactions qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 8 – Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized defined contribution pre-approved plan and custodial document sponsored by VRIAC. This non-standardized plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter from the IRS dated June 30, 2020, stating that the non-standardized plan constituted a qualified plan under Section 401 of the IRC, and therefore was not subject to tax. Though the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes the Plan is designed and currently being operated in compliance with applicable requirements of the IRC. As such, the Plan Administrator believes that the Plan is qualified and the related trust is tax exempt, and no provision for income taxes has been made in the Plan's financial statements.

Note 8 – Tax Status (continued)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan as of December 31, 2023, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2020.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Note 11 – Subsequent Events

The Plan has evaluated subsequent events through August 19, 2024, the date the financial statements were available to be issued.

Plan Merger

Effective January 1, 2024, the Plan was merged into the Tetra Tech, Inc., and Subsidiaries Retirement Plan (“Tetra Plan”). Principal Trust Company (“Principal”) became the new Custodian and recordkeeper. To aid with the transition to Principal, the Plan instituted a blackout period for all activity with the new Custodian. On January 9, 2024, the transfer of all assets, except for the Voya Fixed Account, was completed and net assets totaling \$56,492,275 were transferred from this Plan to the Tetra Plan. The Voya Fixed Account Agreement with VRIAC provides for restrictions of withdrawal from the contract.
