May 20, 2022

1. Description of the Plan

The following description of the Arbico/Peak, LLC 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan available to eligible employees of Arbico East, LLC and affiliated entities (collectively, the Employer), who had completed one year of eligible service and were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer was responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring the investment performance. Transactions were processed through Reliance Trust Company (Reliance), the trustee of the Plan, and ADP Retirement Services (ADP) provided the maintenance of records and the day-to-day administrative services for the Plan.

The Employer elected to terminate the Plan effective February 28, 2022 (termination date). In accordance with accounting principles generally accepted in the United States of America, the Plan used the liquidation basis of accounting in presenting the 2022 financial statements. The liquidation basis of accounting did not have a significant impact on the Plan's financial statements.

As a result of the decision to terminate the Plan, effective the termination date, no new participants were admitted to the Plan, all participant accounts became fully vested and contributions ceased. The net assets of the Plan were allocated as prescribed by ERISA and its related regulations. Upon termination, there were no unallocated assets of the Plan. The Plan distributed all assets to participants by May 20, 2022.

Contributions

Each year, participants could contribute up to 90% of their pre-tax annual compensation, as defined in the Plan. In addition, participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could change the investment options previously elected at any time. Contributions to the Plan ceased in February 2022.

1. Description of the Plan (continued)

Contributions (continued)

Prior to the termination date, the Employer could elect to make discretionary matching contributions to the Plan. During 2022, the Employer did not make any discretionary matching contributions. Participants were eligible to receive the discretionary matching contributions if they were 21, had completed 1,000 hours of service during the year, and were employed on the last day of the Plan year. The Employer could also elect to make discretionary qualified nonelective contributions. During 2022, the Employer did not make any discretionary qualified nonelective contributions.

Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Employer's discretionary matching and qualified nonelective contributions and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions and discretionary qualified nonelective contributions plus actual earnings on these contributions. Vesting in the Employer's discretionary matching contribution portion of their account plus related earnings thereon was based on years of vesting service in which the participants completed 1,000 hours of service, as follows:

Effective as of the termination date, all participants were immediately 100% vested in all accounts.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

If the participant's vested benefit in the Plan did not exceed \$5,000 at the time of termination of employment, the participant's benefit could be distributed in a single lump-sum payment or rolled over into another individual retirement account. If the participant's vested benefit in the Plan exceeded \$5,000 at the time of termination of employment, the participant could elect to either maintain their account in the Plan, receive a lump-sum distribution or rollover their account balance into another individual retirement account. Participants could also withdraw their vested account balances at any time on or after the age of 59½, or upon retirement, death or disability. The Plan permitted in-service and hardship withdrawals under certain conditions.

Forfeitures

Forfeitures were created when participants terminated employment before becoming entitled to their full benefits under the Plan and were considered nonparticipant-directed investments. Forfeitures could first be used to pay administrative expenses and then to reduce future Employer contributions. During 2022, administrative expenses were reduced by \$6,260 from forfeited non-vested accounts. As of December 31, 2021, forfeited non-vested accounts totaled \$6,247.

2. Significant Accounting Policies

Basis of Accounting

The 2022 financial statements of the Plan are prepared on the liquidation basis of accounting. The ongoing basis of accounting was used in presenting the 2021 statement of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

2. Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments were reported at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determined the Plan's valuation policies utilizing information provided by the trustee. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed as incurred. No allowance for credit losses had been recorded as of December 31, 2021. If a participant ceased to make scheduled repayments and the Plan administrator deemed the note receivable to be in default, the note receivable balance was reduced and a benefit payment recorded.

Benefit Payments

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 29, 2024, the date the financials were available to be issued.

3. Certified Information (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held as of May 20, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the period ended May 20, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance.

4. Concentrations

The Plan had two investments representing greater than 20% of net assets available for benefits as of December 31, 2021.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

5. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: Valued at the net asset value (NAV) of shares held by the Plan at year end. Although the collective investment trusts are not available in an active market, the NAV of units is approximated based on the quoted prices of the underlying investments and are traded in an active market.

6. Related Party Transactions and Party-in-Interest Transactions

Notes receivable from participants and participant contributions were considered to be party-in-interest transactions. Employer contributions were considered to be both party-in-interest and related party transactions.

7. Tax Status

The Plan adopted a prototype non-standardized plan which had received an opinion letter dated July 16, 2014, from the IRS which stated the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the advisory letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.
