### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of the Neato Robotics, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise of the statements of net assets available for benefits as of August 31, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to August 31, 2023 (in liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of August 31, 2023 and December 31, 2022 and for the period from January 1, 2023 to August 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section.

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("U.S. GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Substantial Doubt about the Plan's Ability to Continue as a Going Concern**

As discussed in Note 1 to the financial statements, the Board of Directors of Neato Robotics, Inc., the Plan's sponsor, voted on March 29, 2023 to terminate the Plan effective July 31, 2023. The basis of accounting was changed from the going concern basis to the liquidation basis of accounting and participants became 100% vested in their account balance. All account balances were paid to participants and/or beneficiaries and the Plan no longer functions as a retirement plan.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

### 1. Description of Plan

The following description of the Neato Robotics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan was adopted by Neato Robotics, Inc. (the “Company”) on January 1, 2008, and was most recently amended and restated effective April 1, 2023. The Plan is defined as a contribution retirement plan of the profit sharing type arrangement described in the Internal Revenue Code (“IRC”) Section 401(a). All non-excluded employees, as defined by the Plan document, are eligible to participate in the Plan after completion of one month of service, provided that they are at least age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the IRC.

#### **Plan Termination**

On March 29, 2023, the Board of Directors of the Company elected to terminate the Plan effective July 31, 2023; all participants with account balances under the Plan as of the termination date will be fully vested. All account balances were distributed to participants and/or beneficiaries as of August 31, 2023 and the Plan is no longer functioning as a retirement Plan.

#### **Plan Administration**

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Reliance Trust Company (“Reliance”) is the appointed trustee of the Plan. The trustee of the Plan acts at the direction of the Plan’s administrator. ADP Retirement Services (“ADP”) is the recordkeeper for the Plan.

#### **Contributions**

The Plan provides for automatic enrollment at 3% of eligible compensation upon eligibility. Eligible employees may begin deferring a portion of their eligible compensation (1% to 75%) into the Plan on a before-tax and after-tax basis (Roth) pursuant to IRC Section 401(k) up to the limits imposed by Section 402(g) of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct their investments into various investment options offered by the Plan. The Company provides a matching contribution of 100% of the employee elective deferrals up to a maximum contribution of \$6,000. For the period from January 1, 2023 to August 31, 2023, the Plan sponsor made matching contributions of approximately \$381,600.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer contributions, Plan earnings or losses, and rollovers from other qualified plans. Plan earnings or losses are allocated based upon each participant’s account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

#### **Vesting**

Participant contributions, employer contributions and rollovers, as well as all earnings on these contributions, are fully vested when made or earned.

### 1. Description of Plan, continued

#### ***Participant Notes Receivable***

Participants are allowed one loan at any time and may borrow from their fund accounts a minimum of \$500 up to 50% of the value of their account balance, or \$50,000, whichever is less (except for loans under the Coronavirus Aid, Relief, and Economic Security Act). Notes receivable terms range from one to five years, except for notes receivable used to purchase a primary residence, which have a maximum term of thirty years. The notes receivable are secured by no more than 50% (except for loans under the Coronavirus Aid, Relief, and Economic Security Act) of the balance in the participant's account and bear a reasonable rate of interest at the time of loan origination. Principal and interest are paid in equal installments through regular payroll deductions. There were no outstanding participant notes receivable as of August 31, 2023.

#### ***Forfeitures***

Forfeitures that occur during a Plan year will be used to reduce Plan administration fees or to reduce future employer contributions. For the period January 1, 2023 to August 31, 2023, there was no forfeitures or forfeiture activity.

#### ***Payment of Benefits***

When participants leave the employer, upon normal retirement or for any other reason, those participants (or their beneficiaries) may receive the value of their salary deferrals, vested employer contributions, rollovers, and the net earnings thereon in a single lump-sum payment, installments over a period of time, or partial withdrawal.

The Plan allows for in-service withdrawals at age 59½ and hardship withdrawals, as defined by the Plan document.

In order to receive distributions, participants (or their beneficiaries) are required to file the appropriate forms with the Plan's administrator. Account values will be determined as of the day the distribution is made.

The Plan allows for automatic lump sum distributions of participant vested account balances that do not exceed \$5,000.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct his or her contributions in whole percentage increments into a series of registered investment companies and a money market fund offered by the Plan. Participants may change their investment options at any time.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan for the period January 1, 2023 to August 31, 2023 have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

The financial statements of the Plan as of and for the year ended December 31, 2022 have been prepared on the accrual basis of accounting in accordance with U.S. GAAP.

### 2. Summary of Significant Accounting Policies, continued

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, and changes in net assets available for benefits. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of August 31, 2023 and December 31, 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan's administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### ***Payment of Benefits***

Benefit payments are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. The Company paid the majority of all necessary and proper expenses incurred in the administration of the Plan. Such expenses were primarily comprised of fees and expenses related to the maintenance of the Plan's records.

### 4. Fair Value Measurements

Accounting standards for fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these accounting standards are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### 4. Fair Value Measurements, continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022.

*Cash equivalents:* Valued based on redemption values on the last business day of the Plan year.

*Preferred stocks, common stocks, corporate bonds and U.S. government securities:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments in registered investment companies are managed by Reliance. Any purchases and sales of these funds are performed in the open market at fair value. The Plan has a revenue sharing account, the RIA ERISA budget account, which amounted to zero and \$10 as of August 31, 2023 and December 31, 2022, respectively. The RIA ERISA budget account is used to pay advisory fees. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Amounts of approximately \$16,000 were used to pay Plan expenses for the period January 1, 2023 to August 31, 2023 from the RIA ERISA budget account.

### 6. Tax Status

The Plan has adopted the Automatic Data Processing Prototype 401(k) Profit Sharing Plan document that has received an opinion letter from the Internal Revenue Service dated October 6, 2020. The Plan document has been amended since receiving that opinion letter. However, the Plan's administrator and sponsor believe that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and ERISA, and that the trust, which forms a part of the Plan, is exempt from income tax. Accordingly, no provision has been made for federal and state income taxes.

### 7. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan sponsor elected to terminate the Plan in 2023 (see Note 1).

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks will occur in the near term that could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

As of December 31, 2022, approximately 14% of net assets was held in one fund.
