SUMMARY ANNUAL REPORT

For CDC Medical, LLC Employee Health & Welfare Benefit Plan

This is a summary of the annual report of the CDC Medical, LLC Employee Health & Welfare Benefit Plan, EIN 20-3122382, Plan No. 501, for period July 1, 2023 through June 30, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has a contract with Companion Life Insurance Company to pay health, prescription drug and stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2024 were \$160,014.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$64,400 as of June 30, 2024, compared to \$31,664 as of July 1, 2023. During the plan year the plan experienced an increase in its net assets of \$32,736. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$344,233, including employer contributions of \$146,029, and employee contributions of \$198,204 .

Plan expenses were \$311,497. These expenses included \$49,763 in administrative expenses, \$260,942 in benefits paid to participants and beneficiaries, and \$792 in other expenses.
