### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Progressive Technologies, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of November 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended November 30, 2023, and the related notes to the financial statements.

**NOTE 1 – PLAN DESCRIPTION**

The following brief description of Progressive Technologies, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution retirement plan for eligible employees of Progressive Technologies, Inc. Progressive Technologies, Inc. (the “Plan Sponsor”) is the Plan Sponsor. All eligible employees become automatically enrolled in the plan unless they opt out. With the exception of nonresident aliens and residents of Puerto Rico, there are no excluded employees for the purposes of participation in the Plan. Employees are eligible to participate in the Plan upon the completion of 2 months of service. Eligible participants automatically enter the Plan on the first day of the month coinciding with or after eligibility requirements have been met. The automatic enrollment deferral amount is 3% of compensation for each payroll period unless a participant makes an affirmative election; additionally, the initial automatic deferral amount increases by 1% up to a maximum of 6% each January unless a participant makes a different election.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, referred to as ERISA. The trustee is responsible for oversight of the Plan as well as determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. The Plan complied with ERISA’s fidelity bond compliance requirements for the periods ended November 30, 2023 and December 31, 2022.

Reliance Trust Company is the Plan’s custodian and is responsible for investing and managing the Plan assets (subject to the direction of the Plan participants and trustee oversight).

The Plan was terminated effective November 30, 2023. See Note 7.

Contributions

*Participant contributions:* Plan participants may voluntarily contribute, on a pre-tax basis, any amount of their qualified annual compensation, as defined by the Plan, up to the Internal Revenue Code (IRC) maximum limits. Participants who have attained the age 50 before the end of the Plan Year are eligible to make “catch-up” contributions. The maximum allowable pre-tax voluntary contribution, as determined by the Internal Revenue Service (IRS), was \$22,500 with a maximum “catchup” contribution of \$7,500 for 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). All contributions are held in trust and invested by the Plan’s custodian in accordance with the options elected by the participants (i.e., all investments are participant directed).

*Employer contributions:* The Plan Sponsor matches 50% up to 4% of the participant’s qualified compensation, as defined in the Plan document. The Plan Sponsor may also make discretionary matching contributions to eligible participants of the Plan who contribute to the Plan; however, the Plan Sponsor made no such discretionary matching contributions for the period ended November 30, 2023. The Plan permits rollover contributions from other qualified plans; however, rollover contributions are not eligible for the Plan Sponsor matching contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and related employer contributions. Plan earnings are allocated based on participant account balances, as defined in the plan agreement. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested portion of the participant’s account. Participant accounts are valued on a daily basis. Forfeitures are used to reduce the Plan Sponsor’s matching contributions and allocated to participant’s accounts in the same manner as matching contributions.

**NOTE 1 – PLAN DESCRIPTION (CONTINUED)**

Vesting

Participants are immediately 100% vested in participant contributions (including salary deferrals, “catch-up” contributions, and “rollover” contributions).

Employees must work 1,000 hours or more during a calendar year to receive credit for a year of service. The vesting of the Plan Sponsor’s matching and profit-sharing contributions are determined as follows:

Regardless of the vesting schedule, participants will become fully vested upon death or total and permanent disability.

Benefits and Distributions Upon Termination of Employment

Participants may receive a distribution of the vested portion of some or all of the accounts in the Plan for the following reasons: termination of employment for reasons other than death, disability, or retirement; normal retirement; disability; death. Benefits are recorded when paid. Normal retirement age is 65 and the plan currently has no early retirement provision. Distributions under the Plan may be made in lump-sums or partial withdrawals.

Distributions Prior to Termination (“In-Service” Distributions)

Participants are entitled to receive an in-service distribution; however, this distribution is not in addition to other benefits and therefore reduces the value of the benefits received at retirement. This distribution is made at participants’ election. To receive this “in-service” distribution, participants must be of age 59 ½ and the amount can only be made from accounts which are 100% vested.

Forfeited Accounts

Non-vested employer contributions are forfeited by terminating participants. Forfeited accounts are held in an account at Reliance Trust Company until used to reduce employer contributions. Forfeitures were \$7,816 for the period ended November 30, 2023 and were applied against employer contributions.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Other administrative service fees may be charged to participant accounts and are separately disclosed in the accompanying financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments. Additional fees are charged to participants based on their use of certain plan features. For the period ending November 30, 2023, there were \$21,003 in administrative service fees charged to participant accounts.

**NOTE 1 – PLAN DESCRIPTION (CONTINUED)**

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured with at least fifty percent (50%) of the present value of a participant's vested interest in the Plan. The loan interest rate is set at 2% above the prime rate, as defined. Principal and interest are paid weekly through payroll deductions.

Investment Options

Plan investments are participant directed. Upon enrollment in the Plan, a participant may direct contributions in 1% increments or in fractional increments in any of the Plan's investment fund options. Participants may change or transfer their investment options at any time via telephone or a secure internet website.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Presentation of Financial Statements/Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Accordingly, income is recorded in the year earned and expenses are recorded in the year incurred.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, as well as disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of investments which consists of investment income, realized gains and (losses), and the unrealized appreciation (depreciation) on investments.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 30, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in defaults, the participant loan balance is reduced and a benefit payment is recorded.

Date of Management’s Review

The plan sponsor evaluated the November 30, 2023 financial statements for subsequent events through August 23, 2024, the date the financial statements were available to be issued. Management was not aware of any subsequent events that would warrant disclosure in the financial statements.

**NOTE 3 – SUMMARY OF INFORMATION CERTIFIED BY ASSET CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodian has certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments as shown in the statement of net assets available for benefits as of November 30, 2023.
- Investment activity, as shown in the statement of changes in net assets available for benefits for the period ended November 30, 2023.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.

**NOTE 4 – FEDERAL INCOME TAX STATUS**

The Plan has not obtained a separate determination letter from the Internal Revenue Service (IRS) stating that the Plan was compliant the applicable requirements of the Internal Revenue Code (IRC). The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has opined and informed the third-party administrator by a letter dated October 6, 2020 that the prototype plan was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

Generally accepted accounting principles (“GAAP”) requires the Trustee to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan had no uncertain income tax positions as of November 30, 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Reliance Trust Company manages plan investments. Reliance Trust Company is the custodian, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Certain administrative expenses paid directly by the plan sponsor also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction provisions of ERISA and the Internal Revenue Code. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 7 – PLAN TERMINATION**

Effective November 30, 2023, the Plan Sponsor merged all participant accounts (Plan Assets) into the Adams Keegan Retirement Savings Plan and terminated the Progressive Technologies, Inc. 401(k) Plan. The Plan Sponsor decided to join in a single retirement plan with pooled administrative costs, greater investment options, and cost savings for participants. On November 30, 2023, all of the assets of the Plan were transferred to the Adams Keegan Retirement Savings Plan.
