Independent Auditors' Report

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Ameripipe Supply, Inc.'s 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 10 to the financial statements, the 2022 financial statements have been restated to correct a misstatement. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

December 31, 2023 and 2022

1. Description of Plan

The following description of Ameripipe Supply, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan available to all full-time employees of the Company who have three (3) months of service and are age eighteen (18) or older. The Plan was formed on January 1, 1992, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is defined by Section 401(k) of the Internal Revenue Code.

Eligibility

Any employee who is eighteen (18) years of age is eligible to become a participant in the Plan monthly coinciding with or the next following date he or she completes three (3) months of service.

Employee Salary Reduction Election

A participant may elect to defer up to ninety percent (90%) of his or her compensation each year instead of receiving that amount in cash. However, total deferred compensation may not exceed the limits set by Internal Revenue Code (“IRC”) Sections 401(k), 404, and 415. In addition, participants who are age fifty (50) or over before the close of the plan year are eligible to make catch-up contributions subject to the limitation imposed by the IRC.

Contributions

Elective Contributions

The Company must contribute the amount of the total employee salary reduction elections of all participants made during the plan year. The Company must pay elective contributions to the Plan’s trustee as soon as they can be segregated from its general assets, but no later than the fifteenth (15th) business day after the month of receipt of the voluntary contribution.

Employer Matching Contributions

The Company makes a safe harbor matching contribution in an amount equal to one hundred percent (100%) of the participant’s deferred compensation not in excess of three percent (3%) and fifty percent (50%) of the next two percent (2%) of the participant’s deferred compensation. This safe harbor matching contribution is one hundred percent (100%) vested.

Employer Profit Sharing Contributions

The Company may make a discretionary profit-sharing contribution in an amount to be determined by the Company. This profit-sharing contribution is one hundred percent (100%) vested.

Contributions (continued)

Rollover Contributions

The Plan may accept a rollover contribution on behalf of all participants as well as any employee, regardless of whether such employee has met the age and service requirements of the Plan.

Vesting

Participants are one hundred percent (100%) vested in employee elective deferrals, rollover contributions, and employer matching and profit-sharing contributions plus actual earnings.

Forfeited Accounts

At December 31, 2023 and 2022, there were \$81,074 and \$64,680 available, respectively. During 2023, \$14,272 in forfeitures were used to offset employer contributions or reduce Plan expenses.

Distribution of Benefits

Upon Retirement

Distributions may be made to a participant who has not separated from service when he or she attains age fifty-nine and one-half (59 ½). Payment may be in the form of a lump-sum distribution or partial withdraw.

Upon Termination of Employment

A participant may elect to have his or her account balance distributed as soon as administratively feasible following termination of employment. If the value of the vested account balance does not exceed \$1,000, then a distribution will be made in cash. However, if the value of the vested account balance is more than \$1,000 but less than \$5,000, he or she may elect to receive distribution in cash or to roll over to an IRA or a qualified plan of his or her new employer.

Hardship Distributions

A participant may withdraw money for financial hardship if he or she satisfies certain conditions, \$500 minimum. Hardship distributions can only be made from the vested portion of the elective deferral, Roth contribution, matching contribution and profit-sharing contribution accounts.

Upon Disability

A participant's account is distributable upon a participant's disability. Payment may be in the form of a lump-sum distribution or partial withdrawal.

Upon Death

Upon the death of a participant, a distribution of the vested account balance be made to his or her designated beneficiary in a single lump-sum payment.

Administrative Fees

Distribution and loan fees are charged directly to the requesting participant's account. The Company absorbs the majority of all other administrative fees of the Plan. If expenses paid by the Plan are allocated to participants, expenses are either proportionately based on the value of the account balances or as an equal dollar amount based on the number of the participants in the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct all of his or her accounts to a variety of investments. Participant's accounts are segregated for purpose of determining the earnings or losses on their investment options.

Notes Receivable from Participants

Participants may borrow from his or her account with a maximum loan amount not to exceed the lesser of (a) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period or (b) one-half ($\frac{1}{2}$) of a participant's vested account balance. A participant may only have one (1) loan outstanding at any time and will not be granted an amount less than \$1,000. Principal and interest are repaid by payroll deductions from each regular paycheck. Loans are secured by the balance in the participant's account and bear an interest rate currently being charged on similar commercial loans by persons in the business of lending money. Interest income is recorded on an accrual basis.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds

Share Prices/Net Asset Values (NAV's) reported on the financial statements for NAV mutual funds are generally obtained from a file feed from the National Securities Clearing Corporation, and/or directly from the fund house, or a secondary pricing source, such as Interactive Data Corporation (IDC).

Stable Value Funds

Share Prices/NAV's reported on the financial statements for stable value funds are generally obtained directly from the fund house or other investment provider.

4. Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America ("Empower"), a qualified institution, has certified the following investments and notes receivable from participants information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023, and 2022.
- Investment income as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2023.
- Investments and notes receivable from participants information included in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Related-Party Transactions and Party in Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$21,652 of recordkeeping fees to Empower, \$25,033 of advisory fees (net with appreciation in fair value of investments) to Merrill Lynch & Co., Inc. during the year ended December 31, 2023. The Company provides certain administrative services at no cost to the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Company and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Prior Period Adjustments

In 2023, the Plan identified and corrected unrecorded contributions totaling \$15,162. These contributions, made on December 30, 2022, were processed and remitted on January 3, 2023. Consequently, they were received and reflected in the 2023 trust statements. This adjustment resulted in an increase of \$15,162 in the beginning balance of net assets available for benefits.

In 2023, the Plan identified and corrected deemed loans totaling \$16,136. These deemed loans were supposed to be included as plan assets until there is a distributable event, usually termination of employment. This adjustment resulted in an increase of \$16,136 in the beginning balance of net assets available for benefits.
