Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). As discussed in Note 6 to the Financial Statements, the Plan and all assets were merged into a newly formed plan as of July 06, 2023. Our opinion is not modified with respect to that matter.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of 403(b) Thrift Plan for Employees of Family Services' internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan for Employees of Family Services' ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. Description of the Plan

The following description of the 403(b) Thrift Plan for Employees of Family Services, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General – The Plan, which was established on December 1, 1973, is a defined contribution plan covering substantially all employees of Family Services, Inc. (the Company), in accordance with universal availability rules, except for non-resident aliens with no U.S. source income, independent contractors, those who are eligible to participate in a plan of the Company described in Sections 401(k) or 403(b) of the Internal Revenue Code (the Code), or a governmental eligible deferred compensation plan described in Section 457(b) of the Code, as defined by the Plan. There is no age or service requirement to become eligible to make salary deferrals. Employees are required to be 21 years old and have one year of service, defined as 1,000 hours of service, in order to be eligible for Company contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended effective January 1, 2021 to remove the automatic enrollment provisions within the Plan.
- B. Contributions – Under the terms of the Plan, an employee may contribute by making pre-tax contributions of up to 100% of their compensation, as defined by the Plan. Participants are permitted to make Roth elective contributions to the Plan. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants who have attained age 50 before the end of the calendar year and participants with more than 15 years of service may make additional contributions, subject to limitations imposed by the Code. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may roll over funds from other qualified plans into the Plan. For the six days ended July 06, 2023, the Company made no contribution as there were no employee contributions for the period. Contributions are subject to certain statutory limitations.
- C. Participant Accounts – Each participant's account is credited with the participant's contributions, Company contributions, and allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

- D. Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions is based on years of continuous service as presented in the following chart:

Less than 2	0%
2	50%
3	100%

Participants automatically become fully vested upon reaching normal retirement age (age 65) or in the event of death or disability.

- E. Plan Loans – Participants may borrow from Mutual of America using a portion of their Plan account as security for the loan. Loans are limited to a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, subject to certain limitations. The notes are secured by the balance in the participant’s account and bear interest at rates commensurate with the prevailing market rates at the time of loan origination. No more than 2 notes can be outstanding at any time. Principal and interest are paid ratably through payroll deductions. Plan loans are issued directly from the funds owned by Mutual of America and loan proceeds are not removed from a participant’s account balance. However, a portion of a participant’s Mutual of America Interest Accumulation Account equal to 100% of the outstanding loan balance is reserved, or held as collateral, to cover the outstanding loan amount for the period of time the loan is outstanding (Note 5).
- F. Payment of Benefits – Upon termination of service, death, disability, retirement (age 65), or attainment of age 59½, a participant or their beneficiary, in the event of death, is entitled to a distribution of their account balance. Participants may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account or may elect an annuity distribution if certain requirements are met, as defined by the Plan. If the vested account balance is \$1,000 or less, a participant will receive a lump sum payment at termination of employment. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. In all cases, certain income taxes and penalties may apply to withdrawals or distributions prior to age 59½. Distributions are subject to the applicable provisions of the Plan agreement. As of July 06, 2023 and June 30, 2023, there were no net assets available for benefits of the Plan allocated to participants who had elected to withdraw from the Plan who had not received such distributions as of year-end.

G. Forfeited Accounts – Forfeitures of non-vested Company contributions may be applied to reduce future Company contributions. Forfeiture balances available totaled \$-0- and \$34,854 as of July 06, 2023 and June 30, 2023, respectively. For the six days ended July 06, 2023, forfeitures used to reduce Company contributions totaled \$-0-.

2. Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan’s valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the six days ended July 6, 2023.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation in fair value of investments.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used when Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodology used at July 06, 2023 and June 30, 2023.

Level 1 Fair Value Measurements

Interest accumulation account: Valued at amortized cost, which approximates fair value. This account is considered to be a cash equivalent, as there are no front-end or back-end charges (so investments in the account are completely liquid), the interest rate credited is the current rate and is not dependent on the length of time the assets are invested, requests for withdrawals can be made at any time and are processed on the day that they are received, the insurance company does not have to liquidate securities in order to generate a payment, and the value shown is the redeemable value of the fund with no deferred sales charges, load assessments, or interest rate adjustments that would affect the value of a withdrawal request.

Investments Measured at Net Asset Value

Interests in pooled separate accounts: Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Gains and losses included in the changes in net assets available for benefits for the six days ended July 06, 2023 are reported in net depreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 at the end of the reporting period. For the six days ended July 06, 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

5. Plan Loans with Mutual of America

The amount of outstanding loans was \$-0- and \$4,377 at July 06, 2023 and June 30, 2023, respectively. In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the Plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan. As of July 06, 2023 and June 30, 2023, there were no loans in default.

6. Plan Merger

The Plan was merged and restated effective July 6, 2023 into the Sheppard Pratt Health System 403(b) Retirement Plan, in an effort to harmonize the various retirement plans associated with the Sheppard Pratt Health System. All participant account balances will be transferred into the newly formed plan. See Note 10.

7. Tax Status

The Plan adopted a non-standardized prototype plan with Mutual of America, which received a favorable opinion letter from the Internal Revenue Service dated March 31, 2017, stating that the Plan is qualified under Section 403(b) of the Code and therefore, the related trust is exempt from taxation. Subsequent to the issuance of the opinion letter, the Plan has been amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subjected to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Related Party and Party-In-Interest Transactions

Plan investments are managed by Mutual of America, the Trustee and record keeper of the Plan. The Plan allows participants to take out loans with Mutual of America using their vested account balance as collateral according to the applicable provisions of the Plan agreement and therefore considered a party-in-interest. As described in Note 2, the Company pays certain plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA. All of these parties-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

10. Subsequent Events

As part of the merger and formation of the Sheppard Pratt Health System 403(b) Retirement Plan, there was a change in custodians from Mutual of America to Fidelity. The asset transfer from Mutual of America was received by Fidelity on July 7, 2024.

The Plan has evaluated subsequent events through August 26, 2024, the date the financial statements were available to be issued.
