We have performed audits of the financial statements of Elite Surface Infrastructure 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

### **Note 1: Plan Description**

The following description of the Elite Surface Infrastructure 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all qualifying employees of RME Ltd dba Elite Surface Infrastructure (the "Company") who have completed three months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The trustees of the Plan, who are officers of the Company, and the Company as the plan administrator, are responsible for the oversight of the Plan. The plan management committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Empower Annuity Insurance Company of America and Empower Trust Company, LLC, serve as the asset custodian and recordkeeper.

#### **Contributions**

Each year, participants may contribute up to the amount allowed by law of annual compensation, as defined by the Plan, on a pretax or after-tax basis. Deferral contributions and after-tax Roth contributions shall not exceed certain limits set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan includes a Safe Harbor provision that requires the Company to contribute 100% of the participant's elective deferral that does not exceed 3% of the participant's compensation, plus 50% of each participant's elective deferral in excess of 3% but not in excess of 5% of the participant's compensation. In addition, the Company may also make contributions to the participants, subject to prevailing wage laws, which are determined by the governmental agency responsible for the contract. Contributions are subject to certain limitations. The Company made Safe Harbor contributions of \$291,154, during the year ended December 31, 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, Company contributions, and allocations of plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Note 1: Plan Description** (Continued)

#### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company's Safe Harbor contributions, plus actual earnings thereon. Participants are immediately vested in any contributions subject to prevailing wage laws and the related earnings allocated to their accounts.

#### **Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds, a common/collective trust fund, and a guaranteed investment contract as investment options for participants. Additionally, the plan offers a self directed brokerage option, which provides participants the option to self direct investments in a variety of market offerings. Participants may change their investment options at any time.

#### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or annual installments as required by minimum distribution rules. For termination of service due to other reasons, a participant may receive the value of his or her account as a lump-sum distribution.

Under certain circumstances, participants experiencing financial hardship or who have attained the age of 59 1/2 may withdraw a portion of their vested account balance prior to death, disability, retirement, or termination of employment, as defined in the Plan.

#### **Forfeited Accounts**

At December 31, 2023 and 2022, forfeited non-vested funds totaled \$2,369 and \$2,340, respectively. These funds are used to reduce Company contributions or pay plan expenses. During the year ended December 31, 2023, no forfeitures were used to pay plan expenses or reduce Company contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Note 2: Summary of Significant Accounting Policies** (Continued)

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the Plan's fully benefit-responsive investment contract (FBRICs) which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, the custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in benefits paid to participants. Certain investment related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net change in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 20, 2024, which is the date the financial statements were available to be issued.

Subsequent to the year ended December 31, 2023, the Plan elected to change plan custodians from Empower Annuity Insurance Company of America and Empower Trust Company, LLC to Voya Financial.

### Note 3: Investments and Information Prepared and Certified by the Custodians (Unaudited)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodians of the Plan have certified that the following unaudited data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2023 and 2022.
- Interest and dividend income and net change in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits.
- All investment information included in the Supplemental Schedule - Form 5500 Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2023.

This information has not been audited by the Plan's independent auditors.

### Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self Directed Brokerage Accounts:** Accounts primarily consist of money market, mutual funds, and common stocks that are valued on the basis of readily determinable market prices.

**Common/Collective Trust Fund:** Valued at the NAV of the fund as reported to the plan administrator by the custodians of the fund. The NAV is used as a practical expedient to estimate fair value. If the Plan were to experience certain events such as plan termination, the fund may impose a market value adjustment on withdrawals.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5: Fully Benefit-Responsive Investment Contract with Insurance Company

The Plan offers a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America ("Empower"). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contributions to the guaranteed investment contract become part of Empower's general account. The contract is credited with interest in accordance with the interest crediting rate established and periodically adjusted by the issuer. The contract is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is a traditional guaranteed investment contract and is presented in the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate is based on a formula determined by the issuer, but it may not be less than 0.0%. Such interest rates are reviewed on a quarterly basis for resetting.

The average yield of the investment for the year ended December 31, 2023, was 1.23%.

### **Note 5: Fully Benefit-Responsive Investment Contract with Insurance Company**

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) termination of the contract, (2) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (3) plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with participants is not probable.

The insurance company may terminate the contract with thirty days written notice to the contract owner for reasonable cause, which includes failure by the contract owner to meet contract requirements.

### **Note 6: Party-in-Interest Transactions**

Plan investments include a fully benefit-responsive investment contract managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company and Empower Trust Company, LLC are the asset custodian and recordkeepers of the Plan. Additionally, Advised Asset Group, LLC and IMA Wealth, Inc. provides investment advisory services and administrative services to the Plan. Transactions with these companies qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment. For the year ended December 31, 2023, the Plan made direct payments of \$35,184 to some of these companies which were not covered by revenue sharing.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 8: Tax Status**

The Plan utilizes a volume submitter plan which obtained a favorable determination letter from the IRS dated November 14, 2022, stating that the volume submitter plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

### Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
