## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator and Management of  
St. Vincent Hospital Bargaining Employee Long Term Savings Plan  
Santa Fe, New Mexico

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of St. Vincent Hospital Bargaining Employee Long Term Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of July 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 to July 1, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of July 1, 2022 and December 31, 2021, and for the period January 1, 2022 to July 1, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter**

As more fully discussed in Note 10 to the financial statements, the Plan did not allocate forfeitures to participants in accordance with the Plan document. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not

detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Supplemental Schedules Required by ERISA

## St. Vincent Hospital Bargaining Employee Long Term Savings Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF THE PLAN**

The following description of St. Vincent Hospital Bargaining Employee Long Term Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan was a 403(b) defined contribution plan, which was both an annuity contract plan and a custodial account plan, sponsored by Christus St. Vincent Hospital (the Company), covering all permissible full-time employees of Company. Effective July 1, 2022, the Company's Human Resources Department and Board Administration formally authorized the merger of the Plan into the CHRISTUS St. Vincent Retirement Plan. All of the assets of the Plan were transferred to the CHRISTUS St. Vincent Retirement Plan on that date. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The Company's Human Resources Department and Board Administration are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Metropolitan Life Insurance Company (MetLife) and by The Variable Annuity Life Insurance Company (VALIC), the custodians and the qualified institutions for the Plan, whom invests contributions and Plan earnings, makes investment transactions as directed by the Company's Human Resources Department and Board Administration and provides certain recordkeeping services. Pension Planning Consultants, Inc. also acts as the administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

All permissible employees of the Company, as defined in accordance with the Universal Availability Standards, are eligible to enroll upon employment. There are no age or service requirements. Employees not covered by a collective bargaining agreement, leased employees, and non-resident aliens are not eligible under the Plan.

#### ***Contributions***

Each year, participants may contribute up to maximum limits of Section 402(g) of the Internal Revenue Code (IRC), as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also be eligible to make certain "qualified organization catch-up deferrals" by completing at least 15 years of service with the Company as allowed by the IRC and as defined by the Plan.

***Contributions (Continued)***

Employer nonelective contributions are made based on the employees' hourly base rate multiplied by the employees' budgeted full-time equivalent (FTE) for the pay period and subject to rates agreed upon in bargaining union agreements as follows:

Nurses	4.00%
Technical	4.00%
Service and maintenance	4.00%

The Employer also contributes an annual longevity contribution of \$3,250 for each participant who has attained the age of 55, completed 15 years of continuous service, and is employed by the Company on the last day of the Plan year. The employer longevity contribution receivable balance of \$201,500 at December 31, 2021 was received by the Plan in January 2022.

***Participant Accounts***

Each Participant's account is credited with the participant's contribution and the Plan's earnings and losses as well as any Company's non-elective matching contributions. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investment Options***

Upon enrollment in the Plan, participants may direct their investments to several mutual fund options, variable annuity contracts or to a fixed interest account. Participants have the option to choose which service provider (MetLife or VALIC) they would like. Participants may change their investment options daily. If a participant does not make an election as to how their benefits should be invested, the Plan will automatically invest the funds in a Qualified Default Investment Alternative Account.

***Vesting***

Participants are immediately vested in their contributions and longevity contributions from the Company, plus actual earnings thereon. Vesting in the Company's nonelective contributions, plus actual earnings, is based on years of continuous service as follows:

#### ***Plan Loans***

Participants may borrow amounts directly from the Plan custodians. Plan loans may be requested by a participant, using their account as collateral for the Plan loan. A Plan loan is not treated as a distribution from the Plan and is not considered a Plan asset. Therefore, Plan loans are not reported on the statements of net assets available for benefits. A participant may apply for a Plan loan to be made from his or her vested account balance in the Plan not to exceed the lesser of (i) \$50,000 or (ii) 50% of the participant's vested account balance in the Plan. Loans may be further limited by the funding vehicles.

At July 1, 2022 and December 31, 2021, there were \$-0- and \$990,623, respectively, held within participant accounts in the investments at contract value on the statement of net assets available for benefits, which served as collateral against outstanding Plan loan balances. At December 31, 2021, the providers reported \$442,572 of defaulted loans. Defaulted loans have a period of 90 days to cure otherwise they are deemed distributions from the Plan. These loans were carried over to the CHRISTUS St. Vincent Retirement Plan along with the participant accounts.

#### ***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant or beneficiary is entitled to receive the full amount of the participant's account. Upon termination or any other reason, the participant is entitled to the amount of their non-forfeitable interest. The normal benefit form is a qualified joint and 50% survivor annuity; optional forms of payment are available. However, if the value of the benefit does not exceed \$5,000, the benefit may be fully distributed immediately. In-service withdrawals, hardship withdrawals, and withdrawals for participants who have attained 59½ are permitted.

#### ***Forfeitures***

At July 1, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$457,206 and \$462,048, respectively. In 2022, employer contributions were reduced by \$48,733 from forfeited nonvested accounts. See Note 10.

#### ***Hardship Withdrawals***

As permitted by the IRC, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for discussion of fair value measurements, contract value, and NAV. The Company's Human Resources Department and Board Administration determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Due to Related Plan***

As of December 31, 2021, employer and employer contributions of \$159,531 and \$188,271 from another related plan were incorrectly received, resulting in a liability of \$347,802. Such amounts were corrected in 2022 when the plans merged.

#### ***Payment of Benefits***

Distributions to participants are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to plan loans are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### *Subsequent Events*

Management has evaluated subsequent events through the date that the financial statements were available to be issued, August 19, 2024, and determined there were no events that occurred that required disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by MetLife and VALIC, the qualified institutions:

- a) Total investments, at fair value and contract value, included in the statements of net assets available for benefits at July 1, 2022 or December 31, 2021.
- b) Investment income, net depreciation in the value of investments, information included in the statement of changes in net assets available for benefits for the period ended July 1, 2022.
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) All amounts included in Note 5, *Investments Reported at Contract Value*.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 1, 2022 and December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable Annuity Contract:* Prices per unit for variable annuity investment options are calculated daily by the annuity provider based on underlying investments according to the methods described in the annuity contract.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

**Note 5: INVESTMENT REPORTED AT CONTRACT VALUE**

The Plan entered into various traditional fully benefit-responsive guaranteed investment contracts with MetLife and VALIC totaling \$-0- for 2022 and \$29,584,648 for 2021. MetLife and VALIC maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MetLife and VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

### **Note 5: INVESTMENT REPORTED AT CONTRACT VALUE (Continued)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### **Note 6: TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan Administrator and the Plan's tax counsel believe that the terms of the Plan have been prepared to conform with the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service. The Plan is required to operate in conformity with the IRC maintain the tax-exempt status for plan participants under Section 403(b).

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan paid certain expenses related to plan operations and investment activity to various service providers, as described in Note 1 and 2. These transactions qualify as party in interest transactions under ERISA.

### **Note 8: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, the Plan was merged into the CHRISTUS St. Vincent Retirement Plan effective July 1, 2022 and participants follow the continuation of the current vesting schedule in the merged plan.

**Note 9: DELINQUENT PARTICIPANT CONTRIBUTIONS**

DOL Regulation 2580.412-11 requires an employer to segregate participant contributions from its general assets as soon as practicable. During the period January 1, 2022 to July 1, 2022 and the years ended December 31, 2021 and 2020, the Company did not timely segregate participant contributions totaling \$275,693, \$180,126 and \$298,922, respectively. All contributions were made to the Plan prior to their respective Plan period ends. The Company evaluated lost earnings for the year ended December 31, 2020 to be \$574, and contributed the earnings to the Plan in May 2022. The Company is in the process of calculating lost earnings for the Plan year ended December 31, 2021 and for the period January 1, 2022 to July 1, 2022, and will contribute lost earnings to the Plan participant accounts that are now in the CHRISTUS St. Vincent Retirement Plan. The lost earnings related to those plan periods are deemed immaterial to the financial statements and are not recorded in the accompanying statements of net assets available for benefits.

**Note 10: FORFEITURES**

At July 1, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$457,206 and \$462,048, respectively. Per the Plan document, forfeitures are to be allocated in the same Plan year in which the designated forfeitures occur, however these amounts had not been allocated to participant accounts when all of the assets were transferred to CHRISTUS St. Vincent Retirement Plan (See Note 1). Plan management is in the process of allocating the forfeitures to Plan participants and any affected former participants accounts held in in the CHRISTUS St. Vincent Retirement Plan.
