Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was the disclosure of the Plan Sponsor's merger and the Plan termination that was effective July 20, 2023 in Note 2 to the financial statements.

The financial statement disclosures are neutral, consistent and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. The preparation of the Plan's financial statements was based on third-party recordkeeping statements and is deemed adequate for this Plan. There were no misstatements detected as a result of audit procedures that were material, either individually or in the aggregate, to the financial statements taken as a whole.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.


Other Audit Findings or Issues

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Life Storage 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of November 27, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended November 27, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520. 103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520. 103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the period ended November 27, 2023 and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

As discussed in Note 1 to the financial statements, Life Storage LP determined by resolution that the Plan should be terminated effective July 20, 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Notes to Financial Statements

1. Major Plan Provisions

The Life Storage 401(k) Plan (the “Plan”) is a defined contribution plan established effective July 1, 1997, by Sovran Acquisition L.P., which is now known as Life Storage LP (the “Company”, the “Plan Sponsor”, or the “Plan Administrator”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The following description of the Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

Plan Termination – On July 20, 2023, the Plan Sponsor merged with Extra Storage Space Inc. The Plan Sponsor determined by resolution that the Plan should be terminated effective July 20, 2023, and management determined liquidation is imminent. Upon termination of the Plan, all expenses were properly charged to the Plan’s Trust and paid first. An allocation of the remaining Plan assets were then paid out to the individual participants’ accounts as described in the Plan document as a benefit distribution. The account values held in the participant accounts were then available for distribution. Participants had 60 days to elect to rollover their balances into another plan or take a lump sum payment of their account. Termination benefit payments primarily occurred in October and November 2023, and all remaining assets were paid out of the Plan on November 27, 2023.

Liquidation Basis of Accounting – As a result of the Plan termination discussed above, the Plan changed its basis of accounting from the going concern basis used for the year ended December 31, 2022, to the liquidation basis as of and for the period ended November 27, 2023. Under the liquidation basis of accounting, all assets and liabilities are measured at the amounts expected to be settled in liquidation and anticipated expenses incurred for all participants have been accrued as of November 27, 2023.

Eligibility – Effective May 1, 2022, all employees, age 21 or over, regularly employed by the Company, who have completed three months of service are eligible to participate in the Plan. Prior to May 1, 2022, all home office employees, age 21 or over, regularly employed by the Company, who had completed three months of service were eligible to participate in the Plan while all other employees, age 21 or over, regularly employed by the Company, who had completed six months of service were eligible to participate in the Plan.

Contributions – The Plan provides for automatic enrollment of all eligible employees upon reaching the applicable age and service requirements. Employees who are automatically enrolled have 3% of their eligible compensation deferred, increasing by 1% annually to a maximum of 10%. Additionally, unless an election is made by employees to opt out of this provision, an automatic annual increase of 1% up to a maximum deferral of 10% will be applied for employees who have elected to defer less than 10% of their eligible compensation. This annual automatic escalation occurs every March 1. Prior to the automatic enrollment date, participants may elect to defer a different specified percentage of

gross wages, not to exceed 100% of compensation (prior to May 1, 2022, not to exceed 25% of compensation), limited by the amount imposed by law, and they may change their investment elections at their discretion.

The employer matching contribution is 33% of the employees' elective deferrals, up to 5% of gross wages.

Participant and employer contributions are invested, at the option and instruction of the participants, in any combination of the available investment accounts.

Participant Accounts – Each participant's account is credited with the respective participant's contributions, the Company's matching contributions, and an allocation of Plan earnings or losses. Participant accounts are decreased by participant distributions and the respective participant's share of Plan expenses. The allocation of the Plan earnings or losses is credited to or deducted from the account balances of participants based upon each participant's percentage interest in Plan assets. The benefit to which a participant is entitled is the benefit that can be provided from their vested account balance.

Vesting and Forfeitures – Participants are immediately 100% vested in the portion of their account balance representing participant contributions and allocated Plan earnings. Participants become vested in benefits arising from Company contributions plus earnings thereon based on whole years of service according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 but less than 2	30%
2 but less than 3	65%
3 or more	100%

Upon termination of the plan, all participants became 100% vested. Any forfeiture amounts, which occur if an employee terminates prior to being 100% vested, will be used to pay administrative expenses or may be used to offset future employer contributions.

Unallocated forfeited balances totaled \$0 and \$1,374 as of November 27, 2023, and December 31, 2022, respectively. Forfeitures used to pay administrative expenses totaled \$682 and \$610 in November 27, 2023 and December 31, 2022, respectively. Forfeitures used to offset employer contributions in 2023 and 2022 were \$49,804 and \$42,627, respectively.

Plan Expenses – Expenses relating to investment activity are paid by the Plan. Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor.

1. Major Plan Provisions (continued)

Distributions – Generally, distributions from the Plan shall be made only in the event of retirement, death, disability, termination of employment, or termination of the Plan. The participant may elect one or a combination of these methods of distribution:

- a) Conversion of account values to annuities,
- b) Payment of account values in a single sum, in cash.

Withdrawals – Participants may withdraw all or part of the vested portion of their account resulting from elective deferral contributions and matching contributions, if such withdrawal is due solely to an event qualifying as a hardship as defined in the Plan document.

Notes Receivable from Participants – Participants may borrow from their accounts in accordance with the rules prescribed by the Plan. Loans are generally limited to the lesser of \$50,000, or 50% of the value of the participant's vested account balance, with other applicable restrictions. A participant may have only one loan outstanding at a time. Interest is charged based on rates available from commercial lending institutions, as determined by the Plan Administrator. Principal and interest are paid ratably through weekly or biweekly payroll deductions. If a participant terminates employment with the Company, they may continue to make loan payments through a preauthorized check agreement. If the loan is not paid, it will automatically be treated as a distribution to the participant after three months.

Participant loans are reported at their unpaid principal balances plus any accrued and unpaid interest. There is no existing external market for these loans as all transactions are restricted to participants and the Plan Sponsor. These loans cannot be assumed or sold to outside third parties. There is no credit risk involved with these loans as any participant defaults are deemed taxable distributions to the participants.

2. Summary of Significant Accounting Policies

Investments Valuation and Income Recognition – As of December 31, 2022, investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The fair value of the pooled separate accounts is based on the unit value of the accounts, which includes the income gains or losses allocated to the account at any point in time. See Note 4 for further discussion of fair value measurements.

2. Summary of Significant Accounting Policies (continued)

The Plan offers each participant a choice of investment funds, with net gains and losses computed by the Plan's custodian, Principal Trust Company. Investment earnings are automatically reinvested into the fund from which they were derived. All investment programs are fully participant directed.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Investment income consists of interest, dividends, and the Plan's share of gains and losses of the guaranteed interest account, collective investment trust, pooled separate accounts and mutual funds.

Basis of Accounting – The financial statements have been prepared on the accrual basis of accounting and in accordance with the Rules and Regulations of the Department of Labor (“DOL”).

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Accounting Changes – Management periodically assesses the applicability of new accounting pronouncements and technical guidance and the effect, if any, on the Plan's financial statements. There were no new accounting pronouncements or changes to technical guidance that had a material impact on the Plan during the period ended November 27, 2023 and the year ended December 31, 2022.

3. Information Certified by the Custodian (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian has certified that the investments and notes receivable from participants included in the accompanying financial statements is complete and accurate.

The custodian also certified investment income (loss) totaling \$2,803,833 and (\$6,305,875) for the period ended November 27, 2023, and the year ended December 31, 2022, respectively.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- **Level 2** – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in markets that are not active;
 - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- **Level 3** – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used for the Plan’s assets measured at fair value:

Mutual funds – The investments in mutual funds are valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAVs of the mutual funds are quoted prices in an active market.

Pooled separate accounts – The pooled separate accounts are made up of a wide variety of underlying investments such as equities (including mutual funds), commercial paper and asset-backed securities. Pooled separate accounts are valued at the NAV of units held by the respective account. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. There are currently no redemption restrictions or unfunded commitments on this investment.

Collective investment trust – The collective investment trust is a pooled investment vehicle sponsored and maintained by a trust company and is made up of a variety of stable value investment contracts, including conventional guaranteed investment contracts and synthetic investment contracts, as well as cash and cash equivalents. The collective investment trust is valued daily based on the market value of the underlying assets, with fair value determined by dividing the fair value of the collective investment trust’s net assets by the total number of units owned. Withdrawals from the collective investment trust, other than for benefit payments and participant transfers to noncompeting options, require a twelve month advance written notice. There are currently no unfunded commitments on this investment.

Due to the termination of the Plan in 2023, there were no assets held by the Plan as of November 27, 2023. The following table sets forth by level, within the fair value hierarchy, the Plan’s assets carried at fair value as of December 31, 2022:

6. Related Party and Party-in-Interest Transactions

The Plan held units of pooled separate accounts managed by Principal Life Insurance Company and a collective investment account managed by Principal Global Investors Trust Co., both considered custodians of the Plan and members of the Principal Financial Group. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

7. Income Tax Status

Effective January 1, 2017, the Plan was amended and restated to adopt the Actuarial Consulting Services, Inc. Prototype Non-standardized 401(k) Profit Sharing Plan document. The IRS issued an advisory letter dated March 31, 2014 to the sponsoring organization on the acceptability of the form of the Plan under section 401 of the Internal Revenue Code (“the Code”), and the Plan Administrator believes the Plan is compliant with the applicable requirements of the Code.

7. Income Tax Status (continued)

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 27, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

Management has evaluated the impact of all subsequent events for the Plan through August 20, 2024, the date the financial statements were available to be issued, and has determined that no additional recognition or disclosure was necessary.
