#### Note 1 - Description of Plan

The following description of the Arbor Pharmaceuticals LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution retirement plan covering all eligible employees of Arbor Pharmaceuticals, LLC (the "Company"). Employees who are 21 years of age or older may begin to make salary deferral contributions to the Plan immediately following their date of hire. Nonresident aliens, independent contractors who are reclassified as employees, part-time, temporary, or seasonal employees, as defined by the Plan, are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company's Investment Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

In September 2021, the Company was acquired by Azurity Pharmaceuticals, Inc. In November 2022, the Plan was merged into the Azurity Pharmaceuticals, Inc. 401(k) Profit Sharing Plan Trust.

##### **Contributions**

Participants may make salary deferral contributions to the Plan equal to a percentage of their pre-tax annual compensation, as defined by the Plan. Eligible participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an Automatic Contribution Arrangement provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 6% of eligible compensation and their contributions invested in a designated target-date fund based on the participant's current age and expected normal retirement date, until changed by the participant.

Effective January 1, 2022, the Plan was amended to allow the Company to make matching contributions equal to 100% of the participant's elective deferral contributions up to 5% of eligible compensation, as defined by the Plan.

The Company may also make a discretionary qualified nonelective contribution. The discretionary qualified nonelective contribution will be allocated only to non-highly compensated employees who were active at any time during the Plan year. The Company elected not to make a discretionary qualified nonelective contribution for the 2022 Plan year. The participants also direct the investment of Company contributions. All contributions are subject to certain Internal Revenue Code ("IRC") limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary qualified nonelective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific

participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years of service as follows:

Due to a reduction in force on January 23, 2019, a partial Plan termination occurred. All employees affected by the partial termination of the Plan were 100% vested in their account as of that date. Any employee who left employment for any reason during the 2019 Plan year was treated as an affected employee.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate is based on the rates available for similar loans from commercial lending institutions. Principal and interest are paid ratably through payroll deductions.

#### **Payment of benefits**

On termination of service for any reason, participants will receive benefits equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance less than \$1,000 will receive a mandatory distribution. For terminated participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an Individual Retirement Account designated by the Plan administrator. Participants with a vested account balance greater than \$5,000 may elect to receive their benefit as a lump sum, a specified amount each year, a series of substantially equal payments over a fixed period or may defer payment of benefits until a later date.

Withdrawals may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants who are at least 59½ years of age or disabled may withdraw all or a portion of their salary deferral and vested employer account balances prior to termination. Withdrawals from a participant's rollover account may be made at any time, in accordance with the provisions specified in the Plan.

#### **Forfeited accounts**

As of November 18, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$144,560, respectively. Forfeited nonvested matching contributions are used to reduce future matching contributions in accordance with terms of the Plan. Forfeited nonvested accounts may also be utilized to pay Plan administrative expenses. Company matching contributions were reduced by \$68,394 from forfeited nonvested accounts and \$331 was utilized to pay Plan expenses for the period from January 1, 2022 to November 18, 2022.

#### Note 2 - Summary of accounting policies

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors and the trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 18, 2022 and December 31, 2021.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the processing of distributions are charged directly to the participant's account and are included in administrative expenses. Indirect investment-related expenses are included in the net depreciation in fair value of investments.

##### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Subsequent events**

The Plan has evaluated subsequent events through August 27, 2024, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial

Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 18, 2022 and December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Pooled separate accounts:* Valued using the accumulated unit value, which is based on the fair value of the underlying assets of the account. The accumulation unit value is deemed equivalent to NAV, which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

#### **Note 4 - Tax status**

The Plan has been designed using a nonstandardized defined contribution plan document designed by Principal Life Insurance Company. Principal Life Insurance Company received an advisory letter dated June 30, 2020 in which the Internal Revenue Service ("IRS") stated that the nonstandardized defined contribution plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 6 - Related party transactions and party-in-interest transactions**

Certain Plan investments are shares of mutual funds, common collective trusts and pooled separate accounts managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust Company"). Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net depreciation in fair value of investments. Fees paid directly by the Plan to the trustee for investment management and the processing of loan and distribution transactions were \$109,372 for the period from January 1, 2022 to November 18, 2022. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

#### **Note 7 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at November 18, 2022 and December 31, 2021, and investment income (loss) and interest income on notes receivable from participants for the period from January 1, 2022 to November 18, 2022, that are disclosed in the accompanying financial statements were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

#### **Note 8 - Department of Labor**

In June 2024, the Company received two notices from the U.S. Department of Labor ("DOL"), Employee Benefits Security Administration of their intent to assess financial penalties against the Company for its failure to file a complete Form 5500 for the Plan years ended December 31, 2021 and November 18, 2022. The 2021 and 2022 Form 5500's for the Arbor Pharmaceuticals LLC 401(k) Plan were both rejected as they did not include a copy of the Plan's audited financial statements. The Company submitted two "Statement of Reasonable Cause" letters on June 28, 2024, requesting the penalties associated with the rejected filings be abated. On July 15, 2024, the Company was notified by the DOL that their requests to waive the assessed penalties for 2021 of \$100,000 and 2022 of \$132,210 were denied. The Company was given 30 days from the receipt of the July 15, 2024, DOL letter to file a "Request for a Hearing and Answer" with the Office of Administrative Law Judges ("OALJ") to oppose the penalty determination. The Company decided not to file a letter with the OALJ for a "Request for a Hearing and Answer" and paid the 2021 and 2022 penalties in August 2024. The

Company filed an amended Form 5500 for 2021, including a copy of the Plan's audited financial statements for the year ended December 31, 2021, on July 31, 2024.

#### **Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain salary deferral contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the period from January 1, 2022 to November 18, 2022. These delinquent participant contributions pertain to payroll periods during the period from January 1, 2022 to November 18, 2022. The Company is currently working with its third-party administrator to correct the delinquent participant contributions relating to payrolls for the period from January 1, 2022 to November 18, 2022. The Company believes that these transactions should not affect the tax-qualified status of the Plan.
