### **Opinion**

We have audited the financial statements of the L&L Enterprises Employee Welfare Benefit Plan Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2023 and 2022, the related statements of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2023, and the related notes to financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan on a modified cash basis as of December 31, 2023 and 2022, and the changes in its net assets available for benefits on a modified cash basis for the year ended December 31, 2023, in accordance with modified cash basis of accounting as described in Note 2.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter-Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented

and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**1. DESCRIPTION OF THE PLAN**

The following description of the L&L Enterprises Employee Welfare Benefit Plan Trust (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Master Plan Document or Summary Plan Description for a more complete description of the Plan provisions. The Plan Administrator is responsible for oversight of the Plan and monitors investment performance.

General - The Plan provides health and other benefits to eligible employees and their covered dependents of Dodge City Motors, Inc.; Lewis Automotive Group, Inc.; Lewis Motors, Inc.; Lewis Chrysler, Inc.; JTL Leasing, FLP; Garden City Motors, LLC; Ralph Motors LLC; LAG Rentals LLC; Lewis Chevrolet of Dodge City LLC; Lewis Ford of Dodge City Inc.; and Lewis Chevrolet of Liberal LLC (collectively, Company) which constitute a controlled group under Internal Revenue Code 414(b) and 414(c). Employees who work at least 32 hours a week and are at least age 18 become eligible to participate in the Plan on the first day of the calendar month following completion of 60 days of service.

Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The benefits are funded by the Company and participating employees. All funds contributed are to be held for the exclusive benefit of the participants.

Benefits - The Plan provides health benefits (medical, vision, dental and prescription drugs), group life insurance, short and long-term disability benefits and accidental death and dismemberment (AD&D) benefits to covered participating employees and designated dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-Insured Benefits - The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan maintains a contract with Meritain Health (Meritain) to administer the payment of medical, vision, dental and prescription drug benefit claims.

Stop-Loss Coverage - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for benefits liability (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Contributions - In addition to deductibles and copayments, participants contribute via payroll deductions specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

**1. DESCRIPTION OF THE PLAN (CONTINUED)**

Administrative Expenses - Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan and no such costs are therefore included in these financial statements. Administrative fees for claims and reinsurance contracts are paid by the Plan.

Concentration of Credit Risk - The participating entities in the Plan own and operate car dealerships located throughout Kansas. Participant premiums are billed and collected on a monthly basis.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The financial statements are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this basis, participant contributions are recognized when collected rather than when earned; benefits, premiums and expenses are recognized when paid rather than when incurred; amounts due to claim processors that have not been reimbursed by the Plan are recorded as accounts payable to claims administrators; investments are reported at fair value with net change in fair value including gains and losses of investments bought and sold as well as held during the year; and interest and dividend income on investments is recognized when earned. Consequently, participant contributions receivable, claims incurred but not reported or paid, amounts due insurance companies, deferred premiums and accrued expenses are not included in the accompanying financial statements.

Cash, Non-Interest Bearing - The Plan considers cash and cash equivalents to include deposits on demand and short-term investments with original maturities of three months or less. Interest bearing accounts are classified as investments. The Plan's cash and cash equivalents are held in high credit quality financial institutions. The Plan maintains its cash in bank deposit accounts that, at times, may exceed the federally insured limits. The Plan has not experienced losses in such accounts.

Investments - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors.

The purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Insurance Premiums - Premiums paid by the Plan are recorded as claims administration and other expenses in the accompanying statement of changes in net assets available for benefits. Premiums for expected claims as annualized by Meritain are paid by employees and are included as participant contributions in these financial statements.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Claims Payable - Claims and benefits are processed and paid by insurance companies and reimbursed by the Plan on a periodic basis up to the individual and aggregate limits. Current health claims of active participants and their dependents are provided under a minimum premium group-term policy with Meritain. Life and AD&D benefits are covered under group-term policies with Meritain.

Claims and benefits are recorded when paid in accordance with the modified cash basis of accounting. The estimate for unrecorded estimated medical claims payable and unrecorded claims incurred but not reported (IBNR) is calculated based on actual claims incurred during the year for which payment was made subsequent to year-end and historical data as provided by insurance consultants to the Plan. The estimated IBNR for the Plan was approximately \$233,000 and \$547,000 as of December 31, 2023 and 2022, respectively. These obligations will be funded through subsequent contributions or from existing assets in the Plan.

Stop Loss - Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits (modified cash basis). Stop loss refunds totaling approximately \$333,000 have been netted with claims paid in the accompanying statement of changes in net assets (modified cash basis).

Reinsurance - The Plan limits its risk through reinsurance of medical and dental benefits. The Plan has a contract with Meritain which includes reinsurance coverage for claim losses as specified by a formula and pays specific losses per individual and aggregate losses in excess of the Expected Incurred Claims Expense and the Administrative Fee.

Estimates - The preparation of financial statements requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Subsequent Events - These financial statements considered subsequent events through August 12, 2024, the date these financial statements were available to be issued.

**3. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The following describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds*

These investments (which include mutual funds and money market funds) are valued using a quoted price in an active market.

**4. CLAIMS ADMINISTRATION AND OTHER EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators (Meritain). These expenses are reported on the statement of changes in net assets available for benefits (modified cash basis) as claims administration and other expenses.

**5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets were invested and managed by Principal, as well as certain Plan deductions are payments to Meritain who performs administrative services for the Plan, and therefore, these transactions qualify as party-in-interest transactions. As described in Notes 1 and 4, the Plan has several arrangements with service providers. Total fees incurred and paid directly by the Plan for these services were \$861,541.

**6. TAX STATUS**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated November 17, 2004, stating that the trust is tax exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan, and any amendments to the Plan since receiving the determination letter, is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements related to all open periods. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PLAN TERMINATION**

Although it has not expressed an intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants; to discontinue its contributions at any time; and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for the purposes other than for the exclusive benefit of the Plan's participants.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

IBNR is determined based on certain assumptions pertaining to historical claim rates, lag times, and individual large claims, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material.
