NOTE 1 - Description of Plan

The following description of the Blue Prism Software, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Blue Prism Software, Inc. (the "Company") who meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Advisory Committee is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and the monitoring of investment performance.

Merger - On November 14, 2023, the Board of Directors of SS&C Technologies, Inc., a controlling party of the Company, approved the merger of the Plan into the SS&C Technologies, Inc. 401(k) Retirement Savings Plan ("Savings Plan"), effective November 17, 2023. As a result, all investments were transferred from the Plan into the Savings Plan on November 24, 2023.

Plan Amendment - Effective December 31, 2022, the Plan was amended and restated to freeze eligibility and benefit accruals. Therefore, no new employees could become eligible to participate in the Plan and no contributions could be made to the Plan as of December 31, 2022.

Contributions - There are two types of salary deferrals: Pre-Tax 401(k) deferrals and Roth 401(k) deferrals. Prior to December 31, 2022, participants could contribute up to 100 percent of their pretax annual compensation, as defined in the Plan. Participants could elect to make Roth 401(k) deferrals, these deferrals were subject to federal income taxes in the year of deferral. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offered fifty three (53) mutual funds, three (3) pooled separate accounts, and a common/collective trust fund as investment options for participants. Participants could change their investment options at any time. The Plan was a Safe-Harbor Plan where the Company's Safe-Harbor matching contributions were equal to 100 percent of the first four percent of eligible compensation contributed by the participant. The Company could elect to make discretionary profit sharing contributions to the Plan. The Company's Safe-Harbor matching contributions and profit sharing contributions were participant directed as stated above. Contributions are subject to certain IRS limitations.

NOTE 1 - Description of Plan (continued)

Participant Accounts - Each participant's account is credited with the participant's contributions, the Company Safe-Harbor matching contributions, and the Company's discretionary profit sharing contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that were paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions, including their rollovers and employer Safe-Harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six (6) years of credited service. A participant is 100 percent vested upon death, disability, or normal retirement.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent at the time the note is issued. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits - On termination of service due to death, disability, or retirement, or upon termination of employment, a participant or their beneficiary (ies) may elect to receive a lump-sum payment equal to the value of the participant's vested account balance. An account balance less than \$1,000 will receive an automatic lump-sum payment regardless of whether the participant or their beneficiary (ies) elects to receive payment.

Forfeited Accounts - At November 24, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$667, respectively. Forfeitures may first be used to pay plan expenses, then used to offset employer contributions. Any forfeitures remaining are then allocated to the Plan participants. During the period ended November 24, 2023, employer contributions were reduced by \$80,606 from the forfeited non-vested accounts and \$5,587 were used to pay administrative expenses.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Advisory Committee determines the Plan’s valuation policies utilizing information provided by the investment advisor, trustee, and custodian. All Plan assets were transferred to the Savings Plan before close of business on November 24, 2023. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of November 24, 2023 and December 31, 2022.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through August 30, 2024, the date the financial statements were available to be issued. No material events or transactions have occurred during this period which would render these financial statements to be misleading.

NOTE 3 – Certification of Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-supplemental schedules, including investments and notes receivable from participants held at November 24, 2023 and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the period ended November 24, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal Trust”), the trustee of the Plan and Principal Life Insurance Company (“Principal”), the custodian of the Plan.

NOTE 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">· Quoted prices for similar assets or liabilities in active markets;· Quoted prices for identical or similar assets or liabilities in inactive markets;· Inputs and other than quoted prices that are observable for the asset or liability;· Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 24, 2023 and December 31, 2022.

Mutual Funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the net asset value (NAV) of units held by the Plan at year end based on the market value of its underlying investments. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market. There are no unfunded commitments related to any of these investments and there are no Plan initiated redemption restrictions on these investments. There are no redemption restrictions on participant's holdings in the investments and the Plan can redeem these investments daily.

Common/Collective Trust Fund: Valued at the net asset value (NAV) of units of a common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probably that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

NOTE 5 - Related Party Transactions and Party in Interest Transactions

Plan investments are shares of mutual funds, pooled separate accounts, and a common/collective trust fund managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal Trust”) and Principal Life Insurance Company (“Principal”). Principal Trust and Principal are the trustee and custodian, respectively, as defined by the Plan and, therefore, these transactions qualify as related party and party-in-interest transactions. The pooled separate accounts and common/collective trust are exempt from prohibited transaction rules under ERISA 3(17).

Certain fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan for administrative expenses amounted to \$50,016 for the period ended November 24, 2023, which were not covered by revenue sharing.

NOTE 6 - Prohibited Transactions

During 2022, the Plan sponsor had delinquent participant deferrals and notes receivable from participants repayments to the Plan aggregating \$874,138, which were remitted in the 2022 Plan year. The Plan sponsor computed and deposited the lost earnings on the delinquent contributions and applied under the Voluntary Fiduciary Correction Program (VFCP) in the 2023 Plan year.

NOTE 7 - Tax Status

The standardized pre-approved profit-sharing plan has received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the form of the Plan is accepted under Section 401 of the Internal Revenue Code (the "Code") for use by employers for the benefit of their employees. The Company has adopted this Plan and may rely on the current qualifications of the IRS standardized pre-approved profit-sharing plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.
